THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, read with section 3 (2) of the Act, I, Simpson Wijeratne, Assistant Controller of Prices (Food), Kalutara District, do by this order—

- (i) fix with immediate effect the price which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as the wholesale dealer's maximum wholesale price for the Colombo Municipality, increased by the amount specified in Column 2 of the Schedule hereto, to be the maximum wholesale price per hundredweight gross above which Maldive fish or Bonito fish specified in the corresponding entry in Column 1 of the Schedule shall not be sold within the Administrative District of Kalutara;
- (ii) fix with immediate effect the price which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as the retail dealer's maximum retail price for the Colombo Municipality, increased by the amount specified in Column 3 of the Schedule hereto, to be the maximum retail price per pound nett above which Maldive fish or Bonito fish specified in corresponding entry in Column 1 of the Schedule shall not be sold within the Administrative District of Kalutara;
- (iii) direct that for the purpose of this order—
 - (a) any sale of any quantity of Maldive fish or Bonito fish specified in Column 1 of the Schedule for the purpose of resale or any sale of Maldive fish or Bonito fish specified in Column 1 of the Schedule in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of any quantity of Maldive Fish or Bonito fish specified in Column 1 of the Schedule, less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
- (iv) direct that in every area where the maximum prices are fixed by this order, no person shall sell any Maldive fish or Bonito fish specified in Column 1 of the Schedule which is adulterated with any other article;
- (v) direct that in every area where the maximum prices are fixed by this order, every trader, who has any Maldive fish or Bonito fish specified in Column 1 of the Schedule in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a quantity of such Maldive fish or Bonito fish in a suitable container, with maximum prices for such Maldive fish or Bonito fish fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the Maldive fish or Bonito fish and the maximum prices could be clearly seen by any customer;
- (vi) direct that for the purpose of this Order "pound" or "lb" shall be deemed to be the standard pound avoirdupois weight;
- (vii) direct that in every area where the maximum prices are fixed by this Order, every person who sells any Maldive fish or Bonito fish specified in Column 1 of the Schedule by wholesale shall and every person who sells any Maldive fish or Bonito fish specified in Column 1 of the Schedule by retail shall on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale;
 - (b) the quantity of Maldive fish or Bonito fish sold (by weight);
 - (c) the price paid for the quantity sold; and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
- (viii) direct that when any Maldive fish or Bonito fish specified in Column 1 of the Schedule is sold, the maximum prices referred to in Columns 2 and 3 of that Schedule shall include the price of wrapper or container, if any, in which Maldive fish or Bonito fish is sold.

DRIED FISH AND DRIED PRAWNS

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in the Deputy Controller of Prices (Food), by section 4, read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Donald Martensz Anthonisz Speldewinde, Deputy Controller of Prices (Food), Trincomalee District, do by this Order—

- (i) revoke with immediate effect Food Price Order No. T/6/61 dated June 3, 1961, and published in *Ceylon Government Gazette* No. 12,460 of June 9, 1961;
- (ii) fix the prices which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as the wholesale dealer's maximum wholesale price for Colombo Municipality increased by the amounts specified in columns 2 and 3 of the First Schedule hereto to be the wholesale dealers maximum wholesale price per hundredweight nett, above which dried fish and dried prawns of the description given in the corresponding entry in column 1 of the same Schedule shall not be sold within the areas mentioned at the head of columns 2 and 3 of the first schedule hereto;
- (iii) fix the prices which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as the retail dealers maximum retail price for Colombo Municipality, increased by the amounts specified in columns 2, 3, 4 and 5 of the Second Schedule hereto to be the maximum retail prices per pound nett, above which dried fish and dried prawns of the description specified in the corresponding entry in column 1 of the same schedule shall not be sold within the areas mentioned at the head of columns 2, 3, 4 and 5 of the Second Schedule, hereto;
- (iv) direct that for the purpose of this Order—
 - (a) any sale of any quantity of dried fish or dried prawns for the purpose of re-sale or any sale of any dried fish or dried prawns in a quantity of one hundredweight or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of dried fish or dried prawns in a quantity less than one hundredweight nett for any purpose other than re-sale shall be deemed to be a sale by retail;
 - (c) a "wholesale dealer" shall mean any person who is in the habit of selling dried fish or dried prawns by wholesale;
 - (d) the "wholesale dealers' maximum wholesale price" fixed by this Order shall apply to all sales by wholesale except sales by an importer to a wholesale dealer;
 - (e) the "maximum retail price" shall apply to all sales by retail;
 - (f) "Dried Fish" shall be deemed to be the same as "Dry Fish";
- (v) direct that in every area where maximum prices are fixed by this Order, no person shall sell dried fish or dried prawns of the description specified in column 1 of the First Schedule hereto and in column 1 of the Second Schedule hereto which is adulterated with any other article;
- (vi) direct that in every area where maximum prices are fixed by this Order, every trader who has in his possession or under his control at any place or in any vehicle, any dried fish or dried prawns of the description specified in column 1 of the First Schedule hereto and in column 1 of the Second Schedule hereto shall exhibit conspicuously at that place or on that vehicle a quantity of such article in a suitable container with the maximum prices for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the article and the maximum prices could be clearly seen by any consumer;
- (vii) direct that for the purpose of this Order 'pound' or 'lb.' shall be deemed to be the standard pound avoirdupois weight;
- (viii) direct that in every area where maximum prices are fixed by this Order, every person who sells by wholesale any dried fish or dried prawns specified in column 1 of the First Schedule hereto shall, and every person who sells by retail any dried fish or dried prawns specified in column 1 of the Second Schedule hereto shall, on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of sale;
 - (b) the description of the article sold;
 - (c) the gross and the nett weight of the quantity sold;
 - (d) the price paid for the quantity sold; and
 - (e) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
- (ix) direct that when any dried fish or dried prawns specified in column 1 of the First Schedule hereto and in column 1 of the Second Schedule hereto is sold, the maximum price referred to in columns 2 and 3 of the First Schedule and in columns 2, 3, 4 and 5 of the Second Schedule shall include the price of the wrapper or the container, if any, in which such article is sold;
- (x) direct that in any sale of any dried fish specified in column 1 of the Schedules hereto other than kumbalawa, bombili, sprats, thondaya, kooney and dried prawns in containers, the sale price shall be calculated on gross weight less a minimum tare of ten pounds per container;
- (xi) direct that in any sale of kumbalawa specified in column 1 of the Schedules hereto in containers, the sale price shall be calculated on gross weight less a minimum tare of twenty-five pounds per container;
- (xii) direct that in any sale of bombili specified in column 1 of the Schedules hereto in containers the sale price shall be calculated on gross weight less a minimum tare of eight pounds per container;
- (xiii) direct that in any sale of sprats and kooney specified in column 1 of the Schedules hereto in containers, the sale price shall be calculated on gross weight less a minimum tare of twenty pounds per container;
- (xiv) direct that in any sale of dried prawns without shell or dried prawns with shell and thondaya, specified in column 1 of the Schedules hereto, in containers, the sale price shall be calculated on gross weight less a minimum tare of fifteen pounds;
- (xv) direct that for the purpose of this Order "nett" shall mean gross weight less tare or naked weight of dried fish or dried prawns.
