##### The Revenue Protection Ordinance

THE following Order made by the Minister of Finance in pursuance of the powers vested in him by section 2 of the Revenue Protection Ordinance (Chapter 191) is hereby published for general information.

#### ORDER

Whereas the Cabinet has during the present session of Parliament approved of the introduction into the House of Representatives of a resolution whereby, if such resolution is carried, export duties on rubber will be altered :

Now, therefore, in pursuance of the powers vested in me by section 2 of the Revenue Protection Ordinance (Chapter 191), read with the Proclamation under section 88 of the Ceylon (Constitution) Order in Council, 1946, and with section 9A (15) of the Customs Ordinance (Chapter 185), I, Felix Reginald Dias Bandaranaike, Minister of Finance, do hereby—

- (a) order the Principal Collector of Customs from midnight of November 26/27, 1961, to demand and levy (in lieu of the export duties payable on rubber of any description under the Customs Ordinance) export duty on such rubber at such one of the rates specified in the Schedule hereto as is, according to that Schedule, appropriate having regard to the estimated f. o. b. value of R. S. S. Grade 1 rubber at the time of exportation ;
- (b) direct that the duties to be so demanded and levied shall be in addition to the export duties leviable or payable on rubber of any description under any written law other than the Customs Ordinance ; and
- (c) direct that, for the purposes of the application of this Order, an amount computed by the Principal Collector of Customs shall be deemed to be the estimated f. o. b. value per pound of R. S. S. Grade 1 rubber during any week commencing on Monday.
