BY virtue of the powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, read with section 3 (2) of that Act, I, Gardiye Punchihewage Buddhadasa de Silva, Assistant Controller of Prices (Food), for the Administrative District of Matale, do by this Order

(i) fix with immediate effect the prices which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as the wholesale dealer's maximum wholesale price for Colombo Municipality. increased by the amounts specified in column 3 in Schedule II hereto, to be a wholesale dealer's maximum wholesale price per cwt. gross, and the retail dealer's maximum retail price for the Colombo Municipality fixed under the Control of Prices Act, No. 29 of 1950, increased by the amounts specified in column 4 in Schedule II hereto, to be a retail dealer's maximum retail price per pound nett to a consumer respectively, above which Maldive Fish or Bonito Fish specified in the corresponding entry in column 1 of Schedule II shall not be sold within the Administrative District of Matale, appearing under column 2 of Schedule II, full particulars of which appear in Schedule I ;

(ii) direct that for the purpose of this Order-

- (a) any sale of any quantity of Maldive Fish or Bonito Fish specified in column 1 of Schedule II for the purpose of resale or any sale of Maldive Fish or Bonito Fish specified in column 1 of Schedule II, in a quantity of one hundredweight gross or more at a time, shall be deemed to be a sale by wholesale;
 (b) any sale of any quantity of Maldive Fish or Bonito Fish specified in column 1 of Schedule II, less than one hundredweight gross for the purpose of consumption or use, shall be deemed to be a sale by retail;
- (iii) direct that in every area where maximum prices are fixed by this Order, no person shall sell Maldive Fish or Bonito Fish specified in column 1 of Schedule II which is adulterated with any other article ;
- (iv) direct that in every area where maximum prices are fixed by this Order, every trader who has any Maldive Fish or Bonito Fish specified in column 1 of Schedule II, in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle, a quantity of Maldive Fish or Bonito Fish in a suitable container with the maximum prices for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached in such a manner that the Maldive Fish or Bonito Fish and the maximum price could be clearly seen by any customer;

(v) direct that for the purpose of this Order " pound " or " lb." shall be deemed to be the standard pound avoirdupois weight ;

(vi) direct that in every area where maximum prices are fixed by this Order, every person who sells any Maldive Fish or Bonito Fish specified in column 1 of Schedule II by wholesale, and every person who sells any Maldive Fish or Bonito Fish specified in column 1 of Schedule II by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out

(a) the date of sale ;

- (b) the quantity of Maldive Fish or Bonito Fish sold (by weight);
 (c) the price paid for the quantity sold; and
 (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
