3. Any person whose name appears in any of the register of electors or in list "B" for any of the above electoral districts, may object to the inclusion in such register of his own name or the name of any other

person appearing in such in register or List "B", or to the insertion or retention in such register of the name of any claimant, in writing in duplicate to the Registering Officer, the Kachcheri, Ratnapura, substantially in Form "D" or Form "E", as the case may be, specified in the First Schedule to the said Order in Council. Every objection to the inclusion of a name in the register must reach the Registering Officer, the Kachcheri, Ratnapura, within 4 weeks from the date of publication of this notice in the *Government Gazette*, and every objection to the insertion or retention in the register of the name of any claimant must reach the Registering Officer within 10 days from the date on which a notice containing the names of claimants is exhibited at the office of the Registering Officer.

4. Forms for the purpose of making any claim, application by a person to have the name of another person inserted or retained in a register, or objection

may be obtained at the office of the Registering Officer, the office of each Divisional Revenue Officer, the office of each Local Authority, each Village Headman's office and each Post Office in the Administrative District of Ratnapura.
