ASSISTED SCHOOLS AND TRAINING COLLEGES (SUPPLEMENTARY PROVISIONS) ACT, No. 8 OF 1961 Vesting Order No. 163

C/ANANDA COLLEGE, COLOMBO

BY virtue of the powers vested in me by section 4 of the Assisted Schools and Training Colleges (Supplementary Provisions) Act, No.8 of 1961, I, Badi-ud-din Mahmud, Minister of Education and Broadcasting, do hereby declare that, with effect from the 20th day of December, 1961, all property specified in the Schedule appended hereto, being property liable to vesting, shall vest in the Crown.

SCHEDULE

- 1. The premises in which C/Ananda College, Colombo, was conducted and maintained on July 21, 1960, viz., all that land bearing Assessment No. 691, situated at Second Division Maradana in the Municipality and the District of Colombo, Western Province and bounded on the North by Ananda Mawatha (formerly known as Paranawadiya Road), on the East by Maradana Mills of Messrs. Mackwoods Ltd., Colombo, on the South by Temple Road Mosque premises, Temple Road, private properties abutting Temple Road and Wesleyan Methodist Church premises and on the West by the Maradana-Borella public road and containing in extent Five Acres, Two Roads and Eighteen Perches (5A. 2R. 18P.).

MT/PAKKIA VIDYALAYAM, MATALE

BY virtue of the powers vested in me by section 4 of the Assisted Schools and Training Colleges (Supplementary Provisions) Act, No. 8 of 1961, I, Badi-ud-din Mahmud, Minister of Education and Broadcasting, do hereby declare that, with effect from the 20th day of December, 1961, all property specified in the Schedule appended hereto, being property liable to vesting, shall vest in the Crown.

1. The premises in which Mt/Pakkia Vidyalayam, Matale, was conducted and maintained on July 21, 1960, viz., all that land called and known as Pakkia Vidyalayam premises, situated at Matale in the District of Matale, Central Province, and bounded on the North by premises bearing Assessment Nos. 93 and 91 said to belong to Mrs. P. Kandasamy, premises bearing Assessment No. 89 said to belong to Mrs. M.
