BY virtue of the powers vested in me by section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Shanmugam Paramanathan, Assistant Controller of Prices (Food), Mannar District, do by this Order-

- (1) fix with immediate effect the price which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as the wholesale dealer's maximum wholesale price for Colombo Municipality, increased by the amounts specified in columns 2, 4 and 6 of the Second Schedule hereto, to be the maximum wholesale prices per hundred-weight gross above which the article specified in the corresponding entry in column 1 of the same Schedule, shall not be sold within areas No. 1, No. 2 and No. 3 (as described in the First Schedule hereto) respectively;
- (2) fix with immediate effect the price for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as retail dealer's maximum retail price for the Colombo Municipality, increased by the amounts specified in columns 3, 5 and 7 of the Second Schedule hereto, to be the maximum retail price per pound nett above which the article specified in the corresponding entry in column 1 of the same Schedule shall not be sold within the areas No.1, No. 2, and No. 3 (as described in the First Schedule hereto) respectively;
- (3) direct that for the purpose of this Order-
 - (a) any sale of any quantity of an article specified in column 1 of the Second Schedule in a quantity for the purpose of resale or any sale of an article specified in column 1 of the Second Schedule in a quantity of one hundred-weight gross or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of any quantity of an article specified in column 1 of the Second Schedule less than one hundred-weight nett for the purpose of consumption or use shall be deemed to be a sale by retail;
 - (c) a wholesale dealer shall mean any person who is in the habit of selling any article specified in column 1 of the Second Schedule;
 - (d) the maximum retail price shall apply to all sales by retail;
 - "Nett" shall mean gross weight less tare for naked weight of the article specified in column 1 of the Second Schedule;
- (4) direct that in every area where maximum prices are fixed by this Order no person shall sell any article specified in column 1 of the Second Schedule hereto, which is adulterated with any other article;
- (5) direct that in every area where maximum prices are fixed by this Order, every trader who has in his possession or under his control at any place or in any vehicle any article specified in column I of the Second Schedule hereto, shall exhibit conspicuously at that place or on that vehicle, a quantity of such article in a suitable container with the maximum prices for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the article and the maximum prices could be clearly seen by any customer;
- (6) direct that for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound "avoirdupois" weight;
- (7) direct that in every area where maximum prices are fixed by this Order, every person who sells by wholesale any article specified in column 1 of the Second Schedule attached hereto shall, and every person who sells by retail any article specified in column 1 of the Second Schedule hereto shall, on demand, give the purchaser thereof a receipt in which there shall be set out—

 - (a) the date of sale;
 (b) the quantity of such article sold (by weight);
 (c) the prices paid for the quantity sold; and
 (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
- (8) direct that the maximum wholesale and the maximum retail prices referred to in columns 2, 3, 4, 5, 6, and 7 of the Second Schedule hereto shall include the price of the wrapper or container, if any, in which the article is sold.

SUGAR (RAW BROWN AND WHITE REFINED)

THE CONTROL OF PRICES ACT, No. 29 OF 1950

BY virtue of the powers vested in the Controller of Prices (Food), by section 4 of the Control of Prices Act, No. 29 of 1950, I, Reginald Lawrence Arnolda, Controller of Prices (Food), do by this Order—

- (i) revoke with effect from this date my Food Price Order No. C 322 dated July 28, 1961, published in Ceylon Government Gazette Extraordinary No. 12,563 of July 28, 1961;
- (ii) fix with immediate effect the prices specified in Columns 2 and 3 of the Schedule hereto to be the maximum wholesale price per cwt. gross and the maximum retail price per pound nett, respectively, above which sugar specified in the corresponding entry in column 1 of that Schedule shall not be sold within the Municipal limits of the town of Colombo;
- (iii) direct that for the purpose of this Order-
 - (a) any sale of any quantity of sugar specified in column 1 of the Schedule for the purpose of resale or any sale of sugar specified in column 1 of the Schedule in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale;
 (b) any sale of any quantity of sugar specified in column 1 of the Schedule less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;

- (vi) direct that for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight;
- (vii) direct that in every area where maximum prices are fixed by this Order, every person who sells any sugar specified in column 1 of the Schedule by wholesale shall, and every person who sells any sugar specified in column 1 of the Schedule by retail shall, on demand, give the purchaser thereof, a receipt in which there shall be set out—
 - (a) the date of sale :

- (a) the quantity and variety of sugar sold (by weight);
 (c) the price paid for the quantity of sugar sold;
 (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
- (viii) direct that when any sugar specified in column 1 of the Schedule is sold, the maximum prices referred to in columns 2 and 3 of the Schedule hereto shall include the price of wrapper or container, if any, in which sugar is sold.
