PART I: SECTION (I)—GENERAL

Price Orders

Food Price Order No. KD—96

RAW BROWN SUGAR AND WHITE REFINED SUGAR

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Cyril Joseph Serasinghe, Deputy Controller of Prices (Food), Kandy District and Uda Hewaheta Divisional Revenue Officer's Division of Nuwara Eliya District, do by this Order—

- (i) revoke with immediate effect, my Food Price Order No. KD-93 dated July 28, 1961, published in the *Ceylon Government Gazette Extraordinary* No. 12,569 of August 3, 1961;
- (ii) fix with immediate effect, the prices specified in column 2 of the First Schedule hereto to be the maximum wholesale prices per hundredweight gross above which Raw Brown Sugar shall not be sold by wholesale within the respective areas mentioned in the corresponding entries in Column 1 of the First Schedule hereto;
- (iii) fix with immediate effect, the prices specified in column 3 of the First Schedule hereto to be the maximum wholesale prices per hundredweight gross above which White Refined Sugar shall not be sold by wholesale within the areas mentioned in the corresponding entries in Column 1 of the First Schedule hereto;
- (iv) fix with immediate effect, the prices specified in column 2 of the Second Schedule hereto to be the maximum retail prices per pound nett above which Raw Brown Sugar shall not be sold by retail within the respective areas mentioned in the corresponding entries in Column 1 of the Second Schedule hereto;
- (v) fix with immediate effect, the prices specified in Column 3 of the Second Schedule hereto to be the maximum retail prices per pound nett above which White Refined Sugar shall not be sold within the respective areas mentioned in the corresponding entries in Column 1 of the Second Schedule hereto;
- (vi) direct that for the purpose of this Order—
 - (a) any sale of any quantity of Raw Brown Sugar or White Refined Sugar for the purpose of resale or any quantity of Raw Brown Sugar or White Refined Sugar in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of any quantity of Raw Brown Sugar or White Refined Sugar less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
 - (c) "Sugar" shall exclude all forms of jaggery;
- (vii) direct in every area where maximum prices are fixed by this Order, no person shall sell Raw Brown Sugar or White Refined Sugar which is adulterated with any other article;
- (viii) direct that in every area where maximum prices are fixed by this Order, every trader, who has any Raw Brown Sugar or White Refined Sugar in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a quantity of the Sugar in a suitable container with the maximum price of the sugar fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the Sugar and the maximum prices could be clearly seen by any customer;
- (ix) direct that for the purpose of this Order "pound" or "lb" shall be deemed to be the standard pound avoirdupois weight;
- (x) direct that in every area where maximum prices are fixed by this Order every person who sells any Raw Brown Sugar or White Refined Sugar by wholesale shall, and every person who sells Raw Brown Sugar or White Refined Sugar by retail shall on demand, give the purchaser thereof a receipt in which there shall be set out:—
 - (a) the date of the sale;
 - (b) quantity of the Raw Brown Sugar or White Refined Sugar sold (by weight);
 - (c) the price paid for the quantity sold; and
 - (d) the nature of the transaction, that is to say whether the sale was by wholesale or by retail;
- (xi) direct that when Raw Brown Sugar or White Refined Sugar is sold the maximum prices fixed by this Order shall include the price of the wrapper or container, if any, which the Sugar is sold.

WHITE REFINED SUGAR

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Kandiah Sivappirakasam, Assistant Controller of Prices (Food), Jaffna District, do by this Order —

- (i) revoke with immediate effect my Food Price Order No. J/29/61 dated July 28, 1961 published in *Ceylon Government Gazette Extraordinary* No. 12,568 of August 2, 1961;
- (ii) fix with immediate effect the prices specified in columns 2 and 3 of the Schedule hereto to be the maximum wholesale price per hundredweight gross and the maximum retail price per pound nett, respectively, above which white refined sugar shall not be sold within the areas specified in the corresponding entry in column 1 of that Schedule;
- (iii) direct that for the purpose of this Order—
 - (a) any sale of any quantity of white refined sugar for the purpose of resale or any sale of white refined sugar in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of any quantity of white refined sugar less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
 - (c) "White Refined Sugar" shall exclude all forms of jaggery.
- (iv) direct that in every area where maximum prices are fixed by this Order, no person shall sell white refined sugar which is adulterated with any other article;
- (v) direct that in every area where maximum prices are fixed by this Order, every person who has any White Refined Sugar in his possession or under his Control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a quantity of White Refined Sugar in a suitable container with the maximum prices for the White Refined Sugar fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the White Refined Sugar and the maximum prices could be clearly seen by any customer;
- (vi) direct that for the purpose of this Order "pound" or "lb" shall be deemed to be the standard pound avoirdupois weight;
- (vii) direct that in every area where maximum prices are fixed by this Order, every person who sells any White Refined Sugar by wholesale shall and every person who sells any White Refined Sugar by retail shall, on demand, give the purchaser thereof, a receipt in which there shall be set out—
 - (a) the date of sale;
 - (b) the quantity and variety of White Refined Sugar sold (by weight);
 - (c) the price paid for the quantity of White Refined Sugar sold;
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
- (viii) direct that when any White Refined Sugar is sold, the maximum prices referred to in columns 2 and 3 of the Schedule hereto shall include the price of wrapper or container, if any, in which White Refined Sugar is sold.
