Foreign Secretary Admiral Prof. Jayanath Colombage told a media briefing at the Government Information Depart-

ment yesterday (25) that Sri Lanka was closely monitoring the Russia-Ukraine crisis and was pursuing a non-partisan policy.

Speaking further Colombage said there were very few Sri Lankans in Ukraine but they had been told to leave the country.

He said that several people had left Ukraine and that he was in constant contact with Sri Lankans in Ukraine through the Sri Lankan Embassy in Turkey.



#### Dollar crisis not cause of power cuts... From page 01

Governor Cabraal went onto point to a combination of reasons - increased import demand, world oil price increases, and the adverse weather conditions that are all causing the currency and the power crisis that go together, saying he doesn't want to enter into a debate with the Power and Energy Minister on that aspect. Cabraal was emphatic that the current power crunch is not traceable to the Dollar shortage only.

"The people need to realise that we need at this juncture to be a little more austere and voluntarily reduce power consumption. Many steps are being taken by the government to ensure that power is provided on a continued basis", he said.

Asked by the programme's host whether the government's policy to peg the dollar at an artificially determined rate meant that there are no inward remittances because people wouldn't remit at those rates - causing the dollar shortage that impedes fuel purchases for power generation - the Governor

said that this aspect contributes negligibly to the overall situation.

He said the remittances are low mainly due to the repercussions of the COVID economy, with people being unable to work in the Middle East etc. due to the Covid restrictions, and tourism dropping, or decreasing drastically. "It's only now that we are beginning to recover from these downward trends,"

"Power generation and distribution is not an overnight business and therefore in light of the fact that there have been no sources added to the national grid

in the last seven years, this situation is to be expected", he added. If we do not plan to add to the power grid, the energy options we have now are far too expensive and untenable, he emphasized at the discussion. He said that such augmentation of the national grid is being carried out now, but that it would take around five years for the these new projects to have the effect of to the national grid.

One of the key reasons for the current power crisis was that there were no new power generation projects from 2015 to 2019, he stressed.

The other key reason is that there is additional demand on the grid because there is an additional thirst for power due to the imports and exports picking up after the pandemic, and economic activity in general being on the rise, post-pandemic.

"There is a confluence of factors that contribute to the current power crisis, and one of them is that the cost of a barrel of crude oil has gone up in the world market. The current power crisis is not entirely due to the lack of foreign exchange", Governor Cabraal said. The people need to understand that there is a necessity to curtail power consumption as well, he opined, and observed that all the neon light were on, along the Galle Road stretch when he was headed home recently a sign, he said, of an inability to adjust.

Moscow's Defence Ministry said yesterday its Forces had "successfully completed" their objectives for the day, earlier claiming to have destroyed over 70 Ukrainian military targets, including 11 airfields.

Western intelligence confirmed that Moscow had established "complete air superiority" over Ukraine.

Ukrainian Forces said they had killed "around 50 Russian occupiers" while repulsing an attack on a town on the frontline with Moscow-backed rebels, which could not immediately be confirmed by news Agencies.

Ukraine also said a military plane with 14 people on board crashed south of Kyiv with officials still determining how many people died, while another transport plane crashed in Russia killing the crew.

Meanwhile, Ukraine President Volodymyr Zelenskyy has already appealed to the citizens that whoever is ready to defend the country will be provided with weapons. Now the Ministry of Defence has

taken to social media urging the civilians to make Molotov cocktails to neutralise the occupiers.

In a post from the verified Twitter page of the Ministry of Defence of Ukraine, it said: 'In Obolon... We ask citizens to inform us about the movement of equipment! 'Make Molotov cocktails, neutralise the occupier! Peaceful residents - be careful! Do not leave the house!

The highway heading west out of Kyiv, home to more than three million people, was choked with traffic across five lanes as residents sought to escape to far-off cities, fearful of bombardments while stuck in their cars.

The UN Refugee Agency said an estimated 100,000 Ukrainians had fled their homes. Thousands were also crossing into neighbouring countries, including Romania, Moldova, Poland and Hungary.

Meanwhile, Moscow is ready for talks with Kyiv if its Army surrenders, Russian Foreign Minister Sergei Lavrov said on Friday as the Russian military advanced into the Ukrainian capital.

On the second day of battle, social media showed Russian armoured vehicles rolling into Kyiv. In its northern district Obolonsky, pedestrians ran for safety amid gunfire and explosions.

Meanwhile, British airlines have been banned from landing at Russia's airports and from crossing its airspace, the Russian civil aviation regulator has said.

Russia said the move was a response to "unfriendly decisions by the UK aviation authorities"

On Thursday, the UK banned Russia's national airline Aeroflot from landing in Britain. The measure was part of sanctions introduced following Moscow's invasion of Ukraine. UK Defence Secretary Ben Wallace told ITV: "I think that is their retaliation for us yesterday banning Aeroflot from using and landing in the United Kingdom. That is their tit for tat response."

The President said that the entire process should be fully monitored to prevent irregularities by intermediaries when bringing milk purchased from the dairy farmer to the institution and that the dairy farmers should be paid the proper price.

The President took these decisions with the objective of empowering the dairy farmer and promoting the consumption of liquid milk. The President also stated that there should be no change in the prevailing prices and that the consumer should not be burdened.

President Rajapaksa who visited the factory premises inspected the process of collecting liquid milk as well as the process of making dairy products.

The National Dairy Development Board was established in 1956 and it was transformed into Milco Pvt.Ltd in 1986. In the first phase, the company limited itself to producing pasteurized milk but it has now expanded its manufacturing process to include milk and dairy products

The Danish Government is investing 600 million euros in the construction of a dairy factory in Badalgama, which is expected to commence operations in September.

8.5 liters of liquid milk is required to produce 1 kilogram of powdered milk. It can only make 45 cups of milk. But officials said that 2.5 liters of liquid milk could meet that requirement. 

Bandula Padmakumara, who later in his career served as the Editorial Director and Chairman of Lake House (ANCL) took Sri Lankan journalism to a whole new level," the Prime Minister in a message said.

## Ukranian crisis and its impact

hat Russia would overrun Ukraine was pretty obvious when President Vladimir Putin started massing Russian troops on the Eastern borders of its former ally. The ferocity of the onslaught saw Ukraine's major cities fall like ninepins to the combined air and ground attacks targeting Ukrainian military installations, airports and cities including the Capital, in the first invasion of a European country since the World War II. The full scale invasion has so far killed over 300 Ukrainians including military personnel. According to reports, there are also fears of radiation leaks from the Chernobyl nuclear facility which is now under Russian control.

The reaction from the US and West was final and decisive. US President Joe Biden has already imposed severe sanctions against Russia with EU countries following suit that includes freezing of Russian international banking activity virtually cutting off Russia from the Western financial system and suspension of foreign assets of Russia's top oligarchies. While a direct US military response has been dismissed, at least for the time being, President Biden had dispatched troops to Germany while NATO Forces have been massed in the surrounding Baltic States such as Estonia, Lithuania and Latvia in a clear preemptive measure of designs by Russia visa-vis Ukraine. Ostensibly it was the possibility of Ukraine joining NATO that was central to Putin's invasion of Ukraine, but the former KGB strongman's dream of recreating the glory of the former Soviet Union was never in doubt. Towards this end he continued to foment unrest in those parts of Ukraine with a firm leaning towards Moscow. In fact one day prior to the invasion when he declared two Ukrainian Provinces independent, it was for the stated purpose of liberating 'his people'. As one analyst put it, it was a scenario similar that which was seen in Sri Lanka in the mid 80's when Premier Rajiv Gandhi ordered a parippu airdrop in the North for the ostensible purpose of feeding the 'starved' Northern population before subsequently deploying the IPKF.

It is hard to visualize, though, that Putin would annex Ukraine as he did Crimea, for this will be a costly exercise given that he would have to feed a 40 million population which will be a daunting prospect in the face of Western economic sanctions. He can also expect fierce resistance from a possible Ukranian underground with weapons pouring in from the West in a scenario similar to what happened in Afghanistan, following the Soviet invasion of that country in 1991. Putin is already facing protests in Russia itself over the invasion and some 1,700 protesters have been arrested. Of course, the sanctions will take time to bite and when it does there is bound to unrest among the Russian population.

But will this matter to Putin whose sole dream is to recreate the disintegrated Soviet Union and break up the present unipolar world order - a tall order given the heavy presence of NATO troops in former Soviet satellite states some of which are now NATO members. Amidst the unprecedented crisis the focus will be shifted alternately between Putin and Biden who will be expected to play a dominant role to ensure the aggression of Russia does not proceed beyond this limit. Russia has a few friends including China, which is doing a tightrope walk at the moment without calling the Russian foray an invasion.

It will very much depend on how deep the sanctions will bite. Russia had been subject to periodic sanctions by the West but showed no signs of being affected due to the strength of its oil reserves and the economy. There had been proposals among US decision makers to freeze all of Putin's personal assets in the West on the basis that this may force him to step back. He will also be under pressure from Russian Oligarchs whose foreign assets have already been frozen.

But it appears that Putin's resolve is unshakable. He has declared that Ukraine as a country should not have been formed in the first place. According to reports Putin ordered Russain troops to attack Ukraine to demilitarize, and, as he put it, "de-Nazify' it when ironically the Ukranian President Volodymyr Zelensky is himself a Jew.

The economic fallout on the world economy particularly that of Third World countries is going to be dire. The crisis has already shot world oil prices to US\$ 105 per barrel for the first time since 2014 with concerns also raised about disruptions to global energy supplies. Russia is the third largest oil producer and second-largest oil exporter. How will this affect countries such as Sri Lanka which is in the midst of its worst energy crisis? Russia is also the world's number one producer of wheat-flour and sanctions will mean countries such as Sri Lanka will have a problem in procuring its wheat requirements to meet the

## ENDING TERRORISM: A COMPLEX EQUATION

illing terrorist organisations' leaders is no effective way of fighting terrorism — as it is political and economic crises on which terrorism feeds.

At the start of February 2022, the US

At the start of February 2022, the US celebrated the killing of Islamic State (IS) leader Abu Ibrahim al-Qurashi in Syria. The ensuing euphoria, however, failed to disguise the fact that this operation was merely a modest setback for Jihadist groups.

It was probably more important for US President Joe Biden, who may hope – in anticipation of the midterm elections in November – that such actions will boost his popularity. After all, didn't his predecessor Donald Trump celebrate the killing of the then IS Leader Abu Bakr al-Baghdadi two years ago, and Barack Obama before him that of Osama bin Laden?

A brief look at the career of al-Qurashi shows clearly what is happening in the ongoing field of terrorism and counter-terrorism. The emir, on whose head the US administration had placed a bounty of millions of dollars, was once an ordinary unknown officer in the Iraqi Army.

He comes from a village in the Tal Afar district, which lies in north-western Iraq in the border region with Syria. His father was a muezzin at the local mosque. Al-Qurashi's life – like that of most IS leadership figures – only started to derail when the Americans invaded Iraq.

Al-Qurashi joined al-Qaida and was then arrested. After his release, he rose up the ranks of the IS and eventually became a 'hidden caliph'.

Let us imagine that the invasion of Iraq never happened, and all the ensuing sectarian violence, with thousands dead and millions displaced, never took place. Instead, a political solution was found for Iraq. Would this officer's life have been so profoundly transformed then? And even if he had become radicalised, would this not have remained at worst an internal Iraqi issue?

#### Decapitating IS doesn't work

The example of al-Qurashi is hardly different from the career of dozens of other Islamist leaders. They all have a turning point in common that arrived with the devastating crises in the Arab and Islamic world.

Their rise as terrorist leaders was the result of state.

Their rise as terrorist leaders was the result of state failure, misguided security policies, conflicts between opposing ethnic, religious and sectarian groups, as well as failed development policies and adverse socioeconomic conditions.

The ensuing violence became a global threat as the international political community responded with military interventions, drones, and bounty campaigns – a game that seems to be far from over.

The spiritual father of the IS in Iraq, Abu Musab al-Zarqawi, was killed by an American air strike in 2006. A whole series of other leaders followed, all more or less equally dangerous. In 2011, Osama bin Laden was killed in a US military operation at his hideout in Pakistan.

Numerous other terrorist leaders were killed in similar fashion both before and after that. But has the danger from extremism and terrorism diminished as a result?

In Iraq and Syria, the IS may be less dangerous today than it was in its heyday. It is certainly no longer able to attract tens of thousands of fighters from all over the world. That time of magic, and the associated opportunities for propaganda, recruitment, and terrorist attacks, are in the past.

But the IS has not disappeared from Iraq and Syria either and still feeds on the crises there – notwith-standing the US's declaration that the militia has been defeated. Nothing could illustrate this better than the complex and daring operation against a prison in Kurdish-controlled Hassakeh in Syria carried out by the IS just a few days before its leader was eliminated.

It ended with the deaths of hundreds of IS fighters

#### How the IS has globalized

The IS may be under pressure in Iraq and Syria, but it is not in the process of disappearing. Rather, it has become a global brand, maintaining dozens of bases around the world. In Africa in particular, it has been able to spread like a bushfire in recent years.

Africa is rife with religious and ethnic conflicts. Many states are fragile. Their land areas are often so large that IS offshoots have safe areas where they can retreat and spread out. Their conduct there is sometimes even worse than in the original caliphate in Iraq and Syria. Since 2019, there have been dozens of terrorist attacks in about 15 African countries, with thousands of deaths. IS jihadists are active in Central, Western, and Eastern Africa, from the Sahara to Congo, Uganda, and Mozambique. There are also cells in North Africa.

So far, the African terrorism problem is confined to the continent and is linked to regional crises. But the more joint international action is taken against it, and the more the local crises become entrenched, the greater is the concern that the African variant of IS terrorism could be exported around the world.

#### A foothold in Asia

Just as the IS has succeeded in spreading its ideology in Africa, this has also happened in East Asia, especially against the backdrop of splits within the Taliban in Pakistan and Afghanistan. Since the withdrawal of NATO troops from Afghanistan, there have already been large-scale attacks carried out by the IS offshoot 'Khorasan'.

Among other recruitment sources, this organisation has received an influx of jihadists who have had to flee Iraq and Syria with their families and whose countries of origin no longer want to take them back. But fighters from Central Asia are also flocking to it.

For now, the 'Khorasan' is still fighting against the Taliban, who want to rule Afghanistan and to prove to the world that they are capable of doing so. To that end, they are also trying to avoid the scenario from their first rule, when they offered shelter to al-Qaida and suffered a huge backlash following the attacks of September 11, 2001.

To be successful, then, the fight against terrorism must first and foremost address the root causes of the respective crises. The billions of dollars spent on military operations and bounties should be used for projects to strengthen state institutions, political integration, and economic development. Governments should be supported through projects that aim to build up their societies, integrate citizens into public life, and strengthen democracy and civil culture.

Russia's immediate concerns involve the Ukrainian acquisition and use of Turkish drones along its border regions, along with a general increase in Ukrainian military power, he explained, adding: "Moscow's long-range problem is its inability to reverse the Western orientation that Kyiv has adopted since 2014."

In '5 Places Where World War III Could Erupt In 2022', Farley continues: Russia has publicly argued that it wants to resolve the issues of Ukraine and of Russia's relationship with NATO on a permanent basis. The United States and NATO have not responded positively to these overtures but have notably failed to guarantee Ukraine's security. If Russia launches an invasion of Ukraine things could get ugly quickly. Despite improvements in Ukrainian forces, most analysts expect that Russia would win quick victories along the border, potentially gaining access to the Ukrainian heartland.

Direct Russian military action would put immense pressure on the United States to respond in some fashion. However, the US can support Kyiv in several ways without direct intervention. This includes economic sanctions against Russia, cyberattacks against Russian infrastructure, the transfer of weapons to Ukraine, and the sharing of realtime intelligence with Ukrainian forces. The use of any of these tools, especially if they show some success on the ground, could lead to a confrontation between Moscow and Washing-

#### WHAT UKRAINE CRISIS PROVES ABOUT UN

Trita Parsi, MSNBC Opinion Columnist, on February 22, 2022, highlights that US President Joe Biden is trying to enforce rules on Russia that the US has consistently broken.

The impending Ukraine crisis is not just about Ukraine. That has been the Biden administration's message from the outset: Any Russian aggression against its southern neighbour is not only an unacceptable violation of Ukraine's sovereignty but also an attempt by Russian President Vladimir Putin to challenge the international rulesbased order. "The stakes go far beyond Ukraine," Secretary of State Anthony Blinken told the U.N. Security Council last week. "This is a moment of peril for ... the foundation of the United Nations Charter and the rulesbased international order."

The Biden administration's argument received an air of vindication Monday when Putin all but signalled his intent to invade Ukraine, prompting the White House on Tuesday to call Russia's actions an "invasion." Yet, despite its stated concern for the U.N. Charter and the rules-based international order, there is a conspicuous hole at the centre of President Joe Biden's Russia strategy.

Rather than upholding the current international order based on international law and the principles enshrined in the United Nations Charter, the United States has itself systematically undermined the most central institutions of the current international system, all the while promoting its global primacy in the name of that very same rules-based order. Blinken admitted as much in an address to the U.N. last May: "I know that some of our actions in recent years have undermined the rules-based order and led others to question whether we are still committed to it."

Blinken was, of course, referring to the actions of Donald Trump. But the United States was systematically sidelining the U.N. long before Trump took the White House. Neoconservatives and other hawks in the U.S. foreign policy establishment have long held that "American power, not the United Nations Security Council, provides peace and security for the rest of the world." According to this logic, the United States should not allow the U.N., international treaties or norms to constrain American power. In fact, the thinking goes, America should actively break norms upheld by the United Nations to demonstrate to the world the hollowness of multilateral institutions and the near-omnipo-

#### tence of American power. THE DEFEAT OF **PROGRESSIVE MOVEMENTS**

Byrnes offers a different perspective in an analysis in the Jacobine on February 20, 2022: Following the Vietnam War, global progressive movements sought to refashion the world in the interests of the majority. The failure of this project, and the subsequent triumph of liberal interventionism, explains the arrogance of the US foreign policy elite.

One of the more fascinating things to emerge from the Ukraine crisis — which, appears terrifyingly on the precipice of war — is the miraculous restoration of the Biden administration's confidence in American democracy. Gone is the gnawing fear of "a dagger at the throat" of the republic, as the president had put it on January 6. Instead, we are treated to praise of "the power, resilience, and universal appeal of our shared democratic values.' These, President Biden confidently suggested on February 15, can be counted on to "pre-

Such confidence—in both the durability of the American system and its universal appeal is, of course, essential. Without it, how can the United States courageously defend what secretary of state Antony Blinken has called "the basic principles that sustain [global] peace and security"?

Undoubtedly, the prospect of Russian military forces in Kyiv was once unthinkable. But now it has happened. However, one need not believe that the world should simply acquiesce to Russian demands to be startled by the hubris of American diplomats running to the ramparts of "freedom" and "national sovereignty" so swiftly and with such self-assurance.

## WAR IN UKRAINE AND NON-PROLIFERATION REGIME

resident Vladimir Putin has chosen the path of destruction instead of diplomacy. His monthslong build-up of a massive Russian invasion force encircling Ukraine and his decision on February 21 to order Russian soldiers into the Eastern Ukrainian provinces of Luhansk and Donetsk have set in motion a catastrophic

Putin's indefensible, premeditated assault on Ukraine will heighten tensions between NATO and Russia, increase the risk of conflict elsewhere in Europe, and undermine prospects for nuclear non-proliferation and disarmament—for years to

There are many grievances fuelling Putin's latest and most brazen attempt to reset the post-Cold War European security order through military force. Some are real, such as the effect of NATO's expansion on the military balance in Europe, and some are imagined. No rationale, however, justifies a violent attack by Russia on one of its neighbours.

In an angry speech announcing his decision to move Russian Forces into Ukraine, Putin espoused wild, ethno-racialist, and historically inaccurate claims that Ukraine is not a legitimate state and belongs within a greater Russia. He voiced hyperbolic claims that an independent, westward-leaning Ukraine, which he

falsely charged might even build nuclear weapons, is a grave threat to

#### **Budapest Memorandum**

Putin's aggression against Ukraine violates the 1994 Budapest Memorandum in which Russia, the United Kingdom, and the United States extended security assurances against the threat or use of force against Ukraine's territory or political independence.

In response, Ukraine acceded to the nuclear Nonproliferation Treaty (NPT) as a non-nuclear-weapon state and gave up the 1,900 nuclear warheads it inherited from the Soviet Union. Ukraine, Russia, and the world were safer as a result. But Putin's behaviour undermines the NPT and reinforces the impression that nuclear-

conflict elsewhere in Europe, and undermine prospects for nuclear non-proliferation and disarmament—for years to come.

armed states can bully non-nuclear states, thus reducing the incentives for disarmament and making it more difficult to prevent nuclear proliferation.

The vicious cycle of mistrust between Russia and the West in recent years has been exacerbated by the loss-through negligence, noncompli-

ance, or outright withdrawal—of important conventional and nuclear arms control agreements that helped end the Cold War.

These guardrails included the Conventional Forces in Europe Treaty, which was designed to prevent major force buildups on the continent; the Open Skies Treaty, which provided transparency about military capabilities and movements; the Anti-Ballistic Missile Treaty, which was designed to prevent an unconstrained offensedefense arms race; and the Intermediate-Range Nuclear Forces Treaty, which reduced the danger of nuclear war in Europe.

#### **Sanctions against Russia**

As a result, cooperation between the parties has eroded, concerns about military capabilities have grown, and the risk of miscalculation is higher.

With Putin's deadly war against Ukraine now underway, the United



States, Europe, and the international community must maintain a strong and unified response, including more powerful sanctions against key Russian institutions and leaders. The besieged people of Ukraine require urgent assistance from the international community. As it should, the Kyiv Government will get defensive military assistance to deter Putin from seizing more, if not all, of its ter-

In the days and weeks ahead, leaders in Moscow, Washington, and Europe must be careful to avoid new and destabilizing military deployments, close encounters between Russian and NATO Forces, and the introduction of offensive weapons that undermine common security. For example, the offer from Russia's client state, Belarus, to host Russian tactical nuclear weapons, if pursued by Putin, would further undermine Russian and European security, and increase the risk of nuclear war.

Although Putin's regime must suffer international isolation now, U.S. and Russian leaders must eventually seek to resume talks through their stalled strategic security dialogue to defuse broader NATO-Russia tensions and maintain common sense arms control measures to prevent an all-out arms

Russia's December 2021 proposals on security and the Biden administration responses show there is room for negotiations to resolve mutual concerns, including agreements to scale back large military exercises and prevent the deployment of intermediaterange missiles in Europe or Western

Washington must test whether Russia is serious about such options.

In the long run, U.S., Russian, and European leaders, and their people, cannot lose sight of the fact that war and the threat of nuclear war are the common enemies.

Russia and the West have an interest in striking agreements that further slash bloated strategic nuclear forces, regulate shorter-range "battlefield" nuclear arsenals, and set limits on long-range missile defenses before the last remaining nuclear arms control agreement, New START, expires in early 2026. Otherwise, the next showdown will be even riskier.

The Indian Navy Diving School is located in Kochi. The motto of the diving school is "Service Most Silent" which aptly describes the role and task of a clearance diver. A navy clearance diver works in a manner to garner tactical advan-

tage to his fleet. The school carries out military diver training for both officers and sailors of the Indian Navy. In addition, the

school also trains divers for the Indian Army, Indian Air Force and other paramilitary branches. The school has extended its training to friendly navies from Sri Lanka, Maldives, Vietnam, Malaysia, Mauritius, Thailand, Sey-

chelles and Myanmar. The diving school has successfully trained its students as ship divers and clearance divers. A ship diver follows an eight-week basic diving course. The clearance diver follows a longer duration of training learning to use pure oxygen, mixed air and compressed sets. The clearance diver augments his skills by mastering the art of handling the chambers, underwater demolitions and various methods of underwater salvage.

> A clearance diver was originally a specialist naval diver who used explosives underwater to remove obstructions to make harbours and shipping channels safe to navigate, but later the term "clearance diver" was used to include other naval underwater work. In a first for the Indian Navy, divers slithered down from a helicopter with two explosive sniffing dogs as a part of a simulated bomb threat exercise. In a video shared by the official Twitter handle of PRO Defence, Mumbai, the dogs named Minki and Mukti are seen being lowered down from the naval chopper to an offshore platform 'Neelam'." Clearance divers of the Western Naval Command slithered down from a naval helicopter to an offshore platform with two explosive sniffing dogs Minki and Mukti as part of simulated bomb threat during recently concluded Exercise Prasthan," read the caption of the tweet, which has now gone viral on social media.

Diving at sea is laden with risk. A diving bell is a rigid chamber used to transport divers from the surface to depth and back in open water, usually for the purpose of performing underwater work. The most common types are the open-bottomed wet bell and the closed bell, which can maintain an internal pressure greater than the external ambient. Diving bells are usually suspended by a cable, and lifted and lowered by a winch from a surface support platform. The bell with divers on board is deployed from the working platform (usually a vessel) by a crane. The bell is lowered into the water and to the working depth at a rate recommended by the decompression schedule, which allows the divers to equalise comfortably. Wet bells with an air space will have

the air space topped up as the bell

descends and the air is compressed by increasing hydrostatic pressure. The air will also be refreshed as required to keep the carbon dioxide level acceptable to the naval divers. The oxygen content is also replenished.

The Sri Lanka Navy Diving School in Trincomalee is the only one of its kind in our country and I was privileged to visit this school. Its history dates back to July 1991. These officers explained to me that all prospective sailors who want to undergo diver training must appear for an aptitude test, swimming test and PT test. Priority is placed on swimming. The stages of training are classified as Clearance Diver (CD) 1, 2 and 3. The initial course is carried out for 12 weeks. Just across the school is the vast blue ocean where practical diving classes take place. Divers are taught about salvage operations, underwater clearance, life saving, recovery of bodies, ship hull inspection (during the period of war, the enemy could place limpet mines that stick to the bottom of the ship by magnet), assist in underwater ship repairs and combat diving which includes reconnaissance and demolition. Alpha-521 is the diving vessel of the Sri Lanka Navy. It has a displacement of 592 tonnes with a sailing speed of 10 knots. Its sea endurance is almost 12 days. The Navy has a crew of 81 men including nine officers on this vessel. The Indian Navy and Sri Lankan Navy have enjoyed defence cooperation for decades. INS Nireekshak is due to visit Sri Lanka in the

In January 2013, a team of saturation divers from Nireekshak set a new national diving record, operating at 257 metres (843 ft) in the Arabian Sea, about 35 Nautical miles off Kochi. ## Back on the Tourism Map

he Sacred City of Kandy is teeming with life. Monkeys tightrope along telephone cables, the trees around Kandy Lake are feathered with hordes of egrets, and the Sacred Temple of the Tooth Relic (Sri Dalada Maligawa)— said to house the Buddha's left canine — thrums with the sound of drums pounded every evening for *pooja* (worship).

A few streets over, our group and a handful of independent travellers enter a village hall for a performance of regional dances. Such things can feel contrived, but not this time. One dancer drops his spinning plates, another forgets his tambourine, and the drummers bump into each other as they exit backwards into the wings. After an uncertain couple of years, they are a little out of practice — just like us, as we get into the swing of tourism again.

At the start of 2019, the "Teardrop of India" was riding high. Lonely Planet had named the country its No. 1 travel destination of the year, tourism had brought in £ 3.3 billion and visitor arrivals were at nearly two million. Then a double disaster hit. On Easter Sunday, a Sri Lankan Islamist group targeted three churches and three luxury hotels in Colombo, killing 267 people. And, on January 27, 2020, Sri Lanka's first case of Covid was confirmed. By the end of 2021, visitor numbers were below 200,000. Tourism ground to a complete halt, depriving thousands of their livelihoods.

Happily, travellers are now returning because among our favourite long-haul destinations. Sri Lanka is one of the easiest to visit, with no quarantine required on arrival. It is an ideal time to see the sights without the crowds and give the country's economy a much-needed boost at the same time.

I had come to sample a classic tour of the country, looping up from Colombo via the ancient capitals of Anuradhapura and Polonnaruwa, before dipping south to the holy town of Kandy, into the tea-terraced hills around Nuwara Eliya and Ella, then down into the Southern Province to visit the Yala National Park for leopards and

finishing in the seaside Fort City of Galle. Perhaps the most classic sight of all is UNESCO-listed Sigiriya, a 180 m high column of magma rising abruptly from the forest and crowned with a fifthcentury palace.

Dubbed the Lion Rock, it was one of Asia's earliest royal cities and the subject of many legends, including rumours of treasurefilled rooms dug deep below the rock, an army of wasp "soldiers" to guard it, and a crocodileinfested moat at its base. Its architect, King Kashyapa, adorned the side of the rock with frescoes of his bejewelled harem and their gravity-defying breasts. In places, it seems the distractions were all a bit much for the artists, who painted three nipples on one siren and a hand protruding from the bosom of another.

To reach the top, visitors must pass between the Lion's Feet all that remains of an enormous stone sculpture that once guarded the entrance to the citadel — and ascend steep iron stairs. "Usually, there are queues to go up, but it is still very quiet," says

our guide Richard Pieres. Pre-pandemic, Sigiriya received about 1,500 visitors a day, but when we visit there are

In the water gardens, at the base of the rock, I meet Adikari. He has worked as a freelance guide at the site for 22 years, offering historical background and a helping hand to travellers who struggle with the stairs. "Life has been hard. The price of rice jumped. For nine months altogether, no factories were open for other work. Sometimes we ate; sometimes not. December was better — there were more tourists," he

Reaching the flat top, I wander across terraced brick foundations the last vestiges of this citadel in the sky — and past a bathing pool, still filled with water, to the rock's edge. From here, the whole world opens up. Rocks give way to trees, then rice paddies, then a shimmering lake and, in the far distance, layer upon layer of hills silhouetted in the hazy, lazy heat.

A short drive south of Sigiriya, we reach the UNESCO-listed Dambulla Cave Temple. Eight years before the birth of Jesus Christ, the island's King mine. Valagamba hid here after being overthrown by invading kings from Southern India. When he later reclaimed power, he had the interior of five caves embellished with rock-hewn statues and intricate frescoes in honour of the Buddha. Today, they are among the best-preserved cave paintings in South

I slip off my sandals, the stones cool on my soles, and squeeze into the narrow first cave. A 14m-long Buddha reclines on his side, face resting on a rolled-up pillow. Every inch of wall is

painted with Bodhisattvas (previous incarnations of the Buddha), their heads all turned toward the statue, palms pressed together in prayer. The Buddha's enormous feet are painted with lotus flowers and still bear shimmers of ancient gold; round about lie offerings of fresh frangipani and jas-

ceiling is emblazoned with 1,500 images of the Buddha, their pigments made from lime leaves and honey, still vibrant. More magic is afoot. An underground spring appears to flow up the roof of the cave and drip from its pinnacle into a pot placed beneath. No one has been able to explain why.

Outside, a handful of men are hawking moonstone necklaces, wooden fans, postcards and sarongs. One, with a thick crop of black hair greying at the temples, is called Anura. He has worked

as a tout here for 35 years. "Normally, we see 700 people or more a day; during the pandemic, it was 30 maximum," he says sadly, pointing to the now 40 or so travellers milling in and out of the

But the lockdowns were not without their upsides, as I found in the Yala National Park, in the Southeast of the island. Outside Africa, it is one of the best places in the world to see leopards. We trundle through the gates at 6 am as sunrise paints the sky a pastel pink. Storks stand in the shallows of lakes; still surfaces studded with the crinkled heads and tails of crocodiles. The damp sandy road is pockmarked with tantalising paw prints.

Our guide here, Chanika, has been visiting the park since he was a child, and says he saw the behaviour of the wildlife change during the three months the park was closed. "Normally, we would only see Sri Lankan black bears in the evenings, but since the end of lockdown we have had regular sightings in the mornings too," he says with a smile. The animals seem more relaxed and the closure has broken the pattern of elephants approaching visitors for food too.

In another lake, water buffaloes wallow up to their necks, their guardian white egrets ever near. Suddenly, the bark of a sambar deer breaks through the birdsong and a flash of feline spots and swinging tail appears from around a gorse bush across the water. Word goes out via mobile phones to other guides and within minutes a roar of 4x4s crush together to get a glimpse of the leopard. It feels chaotic and jarring, despite the fact that, as Chanika tells me, there are only half as many Jeeps here as there would have been pre-pandemic. And it is hard to resent the number of leopard-watchers. Guides can only work

during the February-June season, says Chanika. "During lockdown expenses were high and income was low; we had little support from the Government. We need as many visitors as

It hits home again and again as we travel around the country. In the central highlands, our bus snakes around the lush, steep terraces en route to a tea factory. A young man in jeans and my group, about being among the

the undergrowth to meet the bus at the next bend. The third time, we stop. He leans in the door, heaving for breath. Once we have bought a few flowers, he tells us that while he did find work during the pandemic, as a road-roller earning Rs. 3,000 (£11) per day, selling his flowers to just three tourist buses will earn him double At our final stop in Galle, the glass-

flip-flops stands by the road holding a

bouquet of red roses aloft. Each time

we turn a corner, he scrambles through

clear waves gently lap against the old Dutch-built bastion walls. There are no signs of the 2004 tsunami that swept Galle off its feet. Men in crisp whites are practicing on the new cricket ground and the colonial-era streets are lined with shops open as usual. It is a good reminder that all things pass.

"We have been the lucky ones," ys Jane Collins, a fellow tourist in first to return to Sri Lanka. "To enjoy the stillness of places without the crowds has been great, and also to feel we can contribute in some small way to people's livelihoods. To other travellers I say, 'Come!"

Travel at the moment is a neverending dance — tricky to get every step right, but the rewards are there for the taking. (*The Times UK*)

**UKRAINE:** Multiple explosions were heard in Kyiv in the early hours of Friday, according to news agencies. These set off day two of shelling and fighting after Russian President Vladimir Putin announced the 'military operations' in Ukraine. Earlier, Ukrainian President Volodymyr Zelenskyy said 137 people, including 10 military officers, have been killed and 316 people injured

In the wee hours of Friday, Ukraine said it lost control of the Chernobyl nuclear site, the site of the 1986 disaster, and the staff at the Chernobyl plant had been "taken hostage". World leaders have decried the invasion and announced sanctions on Russia. China, meanwhile, continues its support of the Kremlin with its customs agency approving imports of wheat from all regions of Russia. Although Ukrainians had been warned for weeks that war with Russia was imminent, when the attacks finally came Thursday many seemed not to know how to react.

Civil defence sirens wailed in the air of the capital, Kyiv, in the gray and drizzly morning, but the city's main street Khreshchatyk was a mixture of anxiety and normalcy.

The hotel where many Associated Press journalists stayed ordered an evacuation within 30 minutes. Upon checkout, the friendly desk clerk asked: "Did you have anything from the mini-bar?"

Outside, guests hurriedly loaded their hastily packed luggage into cars, while passersby walked dogs and occasionally waved at acquaintances.

Some had been awakened by the sound of explosions on the city's fringes, but others heard nothing. The mayor of Boryspil, the suburb where the capital's main airport lies, said some of the explosions were due to the shooting down of drones of unidentified origin. "I'm not scared at the moment, maybe I'll be scared later," said Maxim Prudskoi, a resident standing on Khreshchatyk. In Mari-

upol, the Azov Sea port city that many fear will be the first major target because of its strategic importance and valuable heavy industry, AP journalists saw similar scenes of aplomb and fear.

People waited at bus stops, seemingly on their way to work, while others hastened to their cars to leave the city that is only about 15 km (less than 10 miles) from the front line with the Donetsk People's Republic, one of two separatist-held areas recognised by Russian President Vladimir Putin as independent this week in a prelude to the invasion. As the morning progressed in Kyiv, alarm rose, with long lines of cars at gas stations and others heading away from the city. The city's extensive subway system was declared free for all riders and scores of people huddled with luggage in corridors, appearing uncertain where to ride to but comforted by the protection of being underground.

Kyiv Mayor Vitaly Klitschko called on the city's 3 million people to stay indoors unless they were workers in critical sectors and said everyone should prepare go-bags with necessities such as medicine and documents.

Ukrainian President Volodymyr Zelenskiy vowed on Friday to stay in Kyiv as his troops battled Russian invaders who are advancing toward the capital in the biggest attack on a European state since World War Two.

U.S. and Ukrainian officials say Russia aims to capture Kyiv and topple the Government. "(The) enemy has marked me down as the number one target," Zelenskiy warned in a video message. "My family is the number two

target. They want to destroy Ukraine politically by destroying the head of state." "I will stay in the capital. My family is also in Ukraine." A democratic nation of 44 million people, Ukraine is Europe's biggest country by area after Russia itself. Russia said on Thursday that its military had destroyed more than 70 military targets, including 11 airfields in Ukraine.

"As a result of strikes carried out by the Russian armed forces, 74 Ukrainian military ground facilities were destroyed," said Igor Konashenkov, a Defence Ministry spokesman.

Destroyed facilities included 11 airfields, three command posts and 18 radar stations of the S-300 and Buk-M1 anti-aircraft missile systems, he said. He added that a Ukrainian military helicopter and four drones had also been shot down.

## **US** will 'defend every inch' of NATO nations but no troops to Ukraine: Biden

#### Biden hits Russia with new sanctions, says Putin 'chose' war

**US:** US President Joe Biden vowed Thursday to defend "every inch" of NATO territory after Russia sent forces into Ukraine -- but reaffirmed that no American troops would be deployed to Washington's ally.

"As I made crystal clear, the United States will defend every inch of NATO territory with a full force of American power,'

Biden said in an address to the nation from the White House. The President added, however: "Our forces will not be engaged in a conflict with Russia in Ukraine." President Joe Biden on Thursday announced a new round of sanctions targeting Russia after its invasion of Ukraine, charging that Russian leader Vladimir Putin "chose this war" and that his country will bear the consequences of his action. The sanctions target Russian banks, oligarchs and high-tech sectors, Biden said. The United States and its allies will block assets of four large Russian banks, impose export controls and sanction oli-

**UKRAINE:** The missile fragment pierced the ceiling of Mikhail Shcherbakov's apartment in Kharkiv, Ukraine's second-largest city. A Russian attack, after weeks of rhetoric and warning signs, had hit home.

"I heard noise and woke up. I realized it sounded like artillery,' Shcherbakov said. He jumped from the couch and ran to wake his mother, and something exploded behind him.

The missile left a nearby computer and teacup shrouded with dust, instant artifacts of Europe's latest crisis.

At dawn on Thursday, Ukrainians' uneasy efforts at normality were shattered. Smoke rose from cities, even ones well away from a long-running separatist conflict in the country's east. By the end of the day, many of the capital's residents had taken shelter deep underground, in Kyiv's metro system.

"Today I had the worst sunrise in my life," said another Kharkiv resident, who gave her name only as Sasha. She rushed to her balcony and realized the sounds that had woken her weren't fireworks. Farther from

the border, a morning commute transformed into chaos, with lines of cars waiting at fuel stations or fleeing from the gray and drizzly capital, Kviv. People carrying luggage took shelter in the subway, unsure of where to go.

Some panicked. Others clung to routine, with irritation.

"I'm not afraid. I'm going to work. The only unusual thing is that you can't find a taxi in Kyiv," one resident complained, as air raid sirens wailed. Many seemed unsure how to react. Kyiv's main street, Khreshchatyk, rip-

pled with anxiety as people checked their phones. Some walked their dogs or waved at friends.

"I'm not scared at the moment. Maybe I'll be scared later," resident Maxim Prudskoi said.

But elsewhere in the capital, Anna Dovnya watched soldiers and police remove shrapnel from an exploded shell and was terrified. "We have lost all faith," she said. "Until the very last moment, I didn't believe it would happen. I just pushed away these thoughts." - THE BANGKOK POST

## Baltic States worry they could be Russia's next target

**LITHUANIA:** Viewed from Paris, London and Washington, the events unfolding in Ukraine may seem like a

new Cold War taking shape in Europe. From the Baltic countries, it looks much worse. To Estonians, Latvians and Lithuanians — particularly those old enough to have lived under Soviet control — Russia's belligerence toward Ukraine has some worried that they could be the next target. The tensions have brought back memories of mass deportations and oppression.

"My grandparents were sent away to Siberia. My father was persecuted by the KGB. Now I live in a free democratic country, but it seems that nothing can be taken for granted," said Jaunius Kazlauskas, a 50-year-old teacher in Vilnius, Lithuania's capital.

All three Baltic countries were seized and annexed by Stalin during World War II before gaining independence again with the breakup of the Soviet Union in 1991. They joined NATO in 2004, putting themselves under the military protection of the U.S. and its Western allies. Ukraine is not part of NATO.

The Baltic countries and Poland, also a NATO member, have been among the loudest advocates for powerful sanctions against Moscow and NATO reinforcements on the alliance's eastern flank. Baltic government leaders in recent weeks have shuttled to European capitals, warning that the West must make Russian President Vladimir Putin pay for attacking Ukraine, or else his

tanks will keep rolling toward other parts of the former Soviet empire.

"The battle for Ukraine is a battle for Europe. If Putin is not stopped there, he will go further," Lithuanian Foreign Minister Gabrielius Landsbergis warned last week in a joint news conference with U.S. Secretary of Defense Lloyd Austin.

Two days before Russia launched its anticipated attack on Ukraine, President Joe Biden announced that some American forces deployed in Europe, including 800 infantry soldiers, F-35 fighters and Apache helicopters, would be moved to the three Baltic states, describing the step as purely defensive.

The news was met with enthusiasm in the Baltic capitals. While the NATO treaty commits all allies to defend any member that comes under attack, the Baltic countries say it is imperative that NATO show resolve not just in words but with boots on the ground.

"Russia always measures the military might but also the will of countries to fight," said Janis Garisons, state secretary at Latvia's Defense Ministry. "Once they see a weakness, they will exploit that weakness.'

While Putin hasn't publicly expressed any ambition to reassert Russian control over the Baltic countries, many Estonians, Latvians and Lithuanians worry he wants to regain influence across all former republics of the Soviet Union, the collapse of which he once described as a tragedy for the Russian people.



In his speech earlier this week setting the stage for Russia's military intervention, Putin said Ukraine is "not just a neighbouring country for us. It is an inalienable part of our own history, culture and spiritual space."

The Baltic countries, culturally and linguistically different, don't have the

same connection to Russian history and identity. However, they were ruled by Moscow for most of the past 200 years, first by the Russian Empire, then for the half-century following World War II by the Soviet Union. All three countries have ethnic Russian minorities; in Latvia and Estonia, they make up about one-quarter of the population.

Though many of them are well integrated, tensions flared in 2007 when hundreds of ethnic Russians rioted against government plans to relocate a Soviet war memorial in Tallinn, Estonia's capital. Estonia suspected Russia of stoking the unrest and orchestrating cyberattacks that paralyzed government computer networks.

When we hear Putin humiliating Ukraine, calling it an artificial state with no history, it reminds us of the same things that they have been repeating about all former Soviet republics for many years," said Nerijus Maliukevicius, a political analyst at Vilnius University. The Russian "state propaganda machine is now working on unprecedented levels of intensity, and the message is not just about Ukraine," he

Lithuania borders both Kaliningrad, a Russian region where the country's Baltic Sea fleet is based, and Belarus, the former Soviet republic where tens of thousands of Russian troops have been deployed for joint exercises. Belarus recently announced that the drills would continue because of the tensions in eastern Ukraine.

"It seems they are not going to leave," Lithuanian Defense Minister Arvydas Anusauskas said before Russia launched its attack on Ukraine. "But we must understand that numbers do not mean everything. There are technically very advanced troops on our side of the border. Their main task is deterrence — and defense, if necessary."

The Baltic countries have expressed strong support for Ukraine. Baltic leaders have traveled to Kyiv to show their solidarity and have sent both weapons and humanitarian aid to Ukraine. Estonia, which has maintained close political and economic relations with Ukraine, also has offered to help Ukraine bolster its cybersecuri-

Estonia, which will celebrate its independence day on Thursday, is taking a strong stance in the conflict, but not because it fears for its security, said former President Kersti Kaljulaid, the first woman to hold that office.

"We are doing it because we find it is our moral obligation," she said. "We very strongly feel that ... every nation should have the right to decide their future."

While the Baltics are direct neighbours of Russia, she said other European countries should be equally worried about the crisis in Ukraine.

"Frankly speaking, I don't think it concerns the Baltics more," she said. "If you look from Kyiv, it's the same distance to Berlin as Tallinn.'

**AFGHANISTAN:** Eight members of polio vaccination teams working to eradicate the crippling virus in Afghanistan were killed on Thursday in four separate attacks,

the United Nations said. Polio teams were frequently targeted by insurgent groups in Afghanistan until the Taliban's takeover of the country last year, when the hardline Islamist group said it wanted to work with the U.N. to stamp out the disease.

In the past polio campaigns in Afghanistan -- and neighboring Pakistan -- were accused of being fronts for spying, while some clerics said the vaccine was a conspiracy to sterilize Muslims.

"We are appalled by the brutality of these killings, across four separate locations," the U.N. said in a

"This senseless violence must stop immediately, and those responsible must be investigated and

brought to justice. These attacks are a violation of international humanitarian law.'

The Taliban said they had "received the news" of the incidents and were trying to get more information.

"Our policy is clear, we want to vaccinate and protect all the children in Afghanistan under the age of five," Javid Hajir, a spokesman for the Ministry of Health, told AFP.

The U.N. said one person was killed in Takhar province in the far north, and seven in neighboring Kunduz province - including four in the provincial capital Kunduz city.

They were engaged in house-tohouse visits or on their way to begin campaigns, the U.N. said.

Afghanistan and Pakistan are the only two countries in the world where polio has not been eradicated, although Pakistan last month reported a year without a case for the first time in history. - JAPAN TODAY


