The Ceylon Chamber of Commerce Ordinance, 1935, as amended by the Ceylon Chamber of Commerce Amendment Ordinance, 1932

#### APPENDICES

##### APPENDIX B.—BYE-LAWS AND CONDITIONS OF SALE OF TEA BY AUCTION

##### Bye-laws

(a) The following new Bye-law was substituted for Bye-law No. 3 :—

“3 (i) No teas shall be catalogued until the full quantity comprising each lot has arrived in Colombo at the stores of the owners or agents of the owners.

If, prior to the Sale, it is found that any lot of tea had been printed in a catalogue before the full quantity of tea had arrived in Colombo, the whole invoice in which that lot of tea appears shall be withdrawn and shall not be reprinted for the next four auctions.

If it is found after the Sale that any lot of tea had been printed in a catalogue before the full quantity had arrived in Colombo, the buyer shall have the option of cancelling the Sale in which event that lot of tea shall not be reprinted for the next four auctions.

(ii) No packeted teas shall be catalogued.

(iii) Catalogues shall be closed and samples and catalogues delivered to Buyers at such time and dates as the Committee of the Association shall from time to time decide.”

(b) The following new Bye-law was substituted for Bye-law No. 5 :—

“5. 18 packages comprising full or half chests of tea and upwards shall constitute a large break, any smaller number being regarded as a small break but no break of less than 12 packages of any grade other than Orange Pekoe or Pekoe shall be catalogued. The minimum number of packages for a break of Orange Pekoe or Pekoe shall be 9.”

##### Conditions of Sale

(a) *Condition of Sale No. 4*—“20 per cent” was substituted for “10 per cent”.

(b) *Condition of Sale No. 5 (a)*—The following :—

(i) The following words appearing in brackets were omitted :—  
(less 8 lb. or 6 lb. sample allowance, as the case may be).

(ii) The words—“Payment shall be made by the selling broker” were substituted for “Payment shall be made to the selling agent or to the selling broker”.

(c) *Condition of Sale No. 8*—The following words were added at the end of this Condition :—

“Second-hand packages of any description shall be declared as such and previous markings, if any, shall be completely removed.”

##### APPENDIX B (i)—BYE-LAWS AND CONDITIONS OF SALE BY AUCTION OF TEA EX-ESTATE, EX-GALLE AND EX-TRINCOMALEE

##### Bye-laws

The following new Bye-law was substituted for Bye-law No. 5 :—

“5. No lot of less than 18 packages shall be offered.  
No unbulked tea or packeted tea shall be offered.”

##### Conditions of Sale

(a) *Condition of Sale No. 4*—The following new Condition of Sale was substituted for Condition No. 4 :—

“4. If required by the Selling Broker a deposit of 20 per cent. shall be made at the moment a lot is knocked down, or at such later time as the Broker may state. Should the Buyer fail to make a deposit as required the Sale shall be considered as cancelled and the Broker shall re-sell the lot as early as possible either by auction or privately, but not to the same Buyer. The Broker shall report the Buyer to the Association and the Buyer shall be precluded from bidding in auctions for a period of one month therefrom. No deposit shall be required in the case of a genuinely mistaken bid provided the bidder notifies the Auctioneer of the mistake within 25 lots of the mistaken bid or before the Auctioneer leaves the rostrum when there are less than 25 lots remaining to be sold in his catalogue.”

(b) *Condition of Sale No. 5 (a)* } The following words appearing in brackets were omitted :—  
*Condition of Sale No. 5 (b)* }

“(less 4 lb. sampling allowance)”

(c) *Condition of Sale No. 7*—The following words were added at the end of this Condition :—

“Second-hand packages of any description shall be declared as such and previous markings, if any, shall be completely removed.”

APPENDIX F.—ARBITRATION AWARDS AND SURVEY AND ASSESSMENT REPORTS

“(c) The Secretary shall not register any survey report in respect of the quality and/or weight of Ceylon Produce for export, unless the exporter is a member of the Chamber or of any Trade Association approved by the Chamber under Rule 8 (ii) (a) of the Chamber Rules.”

(b) Rule 9—The following new Rule was substituted for Rule 9 :—

“9 (a) Every surveyor or assessor shall, if he agrees to carry out a survey or assessment required, commence the survey or assessment within four working days of receiving the request for making the survey or assessment.

(b) Every survey or assessment report shall specify the date on which the request for the survey or assessment was received and the date or dates on which the survey or assessment was made, and the place at which the survey or assessment was made.

(c) Every survey report of Ceylon Produce for export shall be on a printed form supplied by the Chamber, substantially in the Form C set out in the Schedule hereto.”
