CONSTRUCTION OF BALCOMBE PLACE, BORELLA

Provisional Apportionment under Section 26 of Chapter 199 of the Legislative Enactments of Ceylon

THE following is the provisional apportionment made by the Municipal Commissioner, Colombo Municipal Council, under section 26 of the Housing and Town Improvement Ordinance (Chapter 199 of the Legislative Enactments of Ceylon) of the cost of providing in the private street known as Balcombe Place—

- (a) A 4 inch thick penetration macadam carriageway, 20' 0" and 18' 0" wide with kerbs and channels on either side, gravelled and bitumen dressed footways and electric street lights;
- (b) A rainwater sewer; and
- (c) Soil sewers.

This apportionment is based on estimates prepared on current rates for labour and materials, but is liable to alteration due to fluctuation of price of material and rates of labour at actual time of construction. The apportionments of cost published in Government Gazettes No. 10,945 of June 29, 1956 and No. 11,041 of January 4, 1957, are hereby cancelled.
