## PART I: SECTION (I) — GENERAL

ORDER made by the Minister of Industries and Fisheries, after consultation with the Industrial Products Regulation Board under section 5 of the Industrial Products Act, No. 18 of 1949.

#### ORDER

Frames and/or Forks of Bicycles (Pedal) 20" and over whether imported separately or assembled on Bicycles, shall each be an industrial product for the purposes of the Industrial Products Act, No. 18 of 1949.

#### ORDER

1. The Order relating to "Bicycles (Pedal) with or without accessories whether imported whole or in parts, including bicycle frames and forks" under section 8 of the Industrial Products Act, No. 18 of 1949, published in *Gazette Extraordinary* No. 11,802 of July 9, 1959, is hereby revoked.

2. The provisions of the Industrial Products Act, No. 18 of 1949, shall with effect from 11th March, 1960, apply to the industrial products specified in column I of the Schedule hereto.

3. Every importer of an industrial product specified in column I of the Schedule shall in order to obtain a licence to import such industrial product, with effect from the date specified in paragraph 2 of this Order, purchase the local product specified in the corresponding entry in column II of that Schedule.

**THE INDUSTRIAL PRODUCTS ACT, No. 18 OF 1949**

(Pursuant to Section 9)

**NOTIFICATION**

BY virtue of powers vested in me by sub-section 1 of section 9 of the Industrial Products Act, No. 18 of 1949, read with section 15 of the Interpretation Ordinance, Cap. 2, I, Jinadasa Don Weerasekera, Minister of Industries and Fisheries, after consultation with the Industrial Products Regulation Board, do by this Notification—

- (1) revoke the Notification relating to Bicycles under section 9 of the Industrial Products Act, No. 18 of 1949, published in *Gazette Extraordinary* No. 11,802 of 9th July, 1959, and
- (2) prescribe—
- (a) that, in order to obtain a licence to import the regulated product specified in column I of the Schedule hereto, an importer shall purchase the local product specified in the corresponding entry in column II of that Schedule in the ratio specified in the corresponding entry in column III thereof; and
- (b) that the price at which the local product specified in column IV of the Schedule hereto will be sold to any applicant for a licence to import the regulated product shall be the price prescribed in the corresponding entry in column V of that Schedule.

**THE INDUSTRIAL PRODUCTS ACT, No. 18 OF 1949**

(Pursuant to Section 6)

**NOTIFICATION**

BY virtue of the powers vested in me by section 6 of the Industrial Products Act, No. 18 of 1949, I, Egerton Christison Selvarayan Paul, Controller of Industrial Products, do by this Notification require every person who manufactures or has in his possession or under his control the industrial products

"Frames and Forks of bicycles (pedal) 20" and over fabricated in Ceylon,"

to furnish me on or before 31st March, 1960, with a return containing full details as to quantities, descriptions and grades of the said industrial products manufactured and sold by him from 1st August, 1959, to 31st January, 1960, and a similar return in respect of the same industrial products from 1st February, 1960, in respect of each month thereafter.
