GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE PUBLIC SERVICE ADVERTISED IN THE “CEYLON GOVERNMENT GAZETTE”

1. **Allowances**—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

2. **Conditions of Service**—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

3. **Terms of Engagement**—(i) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay) appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute, at their option, a further 5 per cent. The Government contribution in either case will be equal to 7½ per cent. of the salary paid in at the close of each financial year.

(ii) Appointees may be required to furnish security in terms of the Public Officers (Security) Ordinance, if so required by the Head of their Department.

(iii) Appointees other than those already in the Public Service will be required to pass a medical examination by a Government Medical Officer as to their physical fitness to serve in any part of the Island.

4. New Entrant Officers—

(i) The period of probation/trial of “New Entrant Officers” appointed to pensionable posts/non-pensionable posts, as the case may be, shall be 3 years unless a longer period is prescribed in respect of any posts.

(ii) “New Entrant Officers” will be required to comply with any rules already made or that may hereafter be made for giving effect to the Language Policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

(iii) (a) These officers will be required to acquire proficiency in Sinhala during their period of probation/trial.

(b) Their confirmation, at the expiry of the period of probation/trial, will depend, *inter alia*, on the passing of a proficiency test in Sinhala.

Those who fail to reach the prescribed standard of proficiency in Sinhala during their period of probation/trial are liable to be discontinued, but discontinuance may be deferred if the appointing authority is satisfied that a genuine attempt had been made to acquire proficiency in the Official Language. Loss of seniority may be waived at the discretion of the appropriate authority if the officer passes the test within a reasonable time after the due date.

(iv) New Entrant Officers who qualify for entry into the Public Service through the Sinhala medium will be exempted from the Proficiency Test in Sinhala.

Note—The term “New Entrant Officers” in this context means officers appointed to posts in the Public Service on or after September 24, 1956, who are not deemed to be old entrant officers in terms of sub-paragraphs 2 (ii) (b) and 2 (ii) (c) of Treasury Circular No. 379 of 23rd May, 1957.

5. **Qualifications required**—Every applicant must furnish satisfactory proof that he is a Ceylonese. A “Ceylonese” is a citizen of Ceylon by descent or by registration.

6. **War Service Concession**—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty’s Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service commencing from September 3, 1939, at the earliest, and up to December 31, 1949, at the latest, from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

7. **Other Requirements**—(i) Applications from officers of the Public Service who are qualified must be forwarded through the Heads of their respective Departments. In the case of applications from officers holding permanent posts in the Public Service, the Heads of the Departments concerned should, in forwarding the applications, state whether or not they are prepared to release the applicants (if selected) in accordance with Administrative Regulation 109 of the Manual of Procedure.

(ii) Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.

(iii) Anyone desiring to recommend a candidate should do so by giving a testimonial. Any form of canvassing or attempt to influence the selection of a candidate will disqualify such candidate.

(iv) Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection, and to dismissal if discovered after the selection.

(v) Applications not conforming in every respect with the requirements of this advertisement will be rejected.

VACANCIES FOR OFFICERS IN THE CEYLON ARMY

APPLICATIONS are invited for officer vacancies in the Ceylon Army.

2. The selected candidates will be granted regular commissions in the Ceylon Army in the rank of Second Lieutenant.

3. On appointment the selected candidates will draw the pay and, if married, the marriage allowances appropriate to their rank. Ration and other allowances will also be payable as prescribed in the Army Pay Code. The basic rates of pay for commissioned officers up to the rank of Lieutenant-Colonel are as follows:—

4. Applicants must fulfil the following conditions:—

- (a) **Nationality.**—Candidates must be citizens of Ceylon.
- (b) **Age.**—Candidates must not be more than 30 years of age on 8 July, 1960.
- (c) **Educational and Professional.**—Candidates must—

- (i) be officers on the active list of the Ceylon Volunteer Force with not less than 3 years' efficient service in the rank of Lieutenant or above and possessing at least the Ceylon Senior School Certificate or equivalent;

OR

- (ii) have passed the First Examination (General or Special, Arts or Science) qualifying in any of the Faculties of the University of Ceylon;

OR

- (iii) have passed the intermediate Examination in any Faculty or the Preliminary in Economics of the University of London (exemption from the Preliminary is NOT acceptable);

OR

- (iv) possess the Ceylon Higher School Certificate or equivalent;

OR

- (v) have passed in three subjects at Advanced Level on one and the same occasion at the G. C. E. Examination, of the London University with either—

- (a) passes in two other subjects at Ordinary Level, not necessarily on the same occasion, at the G.C.E., London Examination; or

- (b) credit passes in two other subjects entered on a Ceylon Senior School Certificate,

provided that the five subjects required at both Levels include English, Sinhalese or Tamil, Arithmetic or Mathematics or a Science subject.

Note.—A candidate who holds a Ceylon Senior School Certificate without the required credit passes will be permitted to count such credit passes obtained at any Ceylon G.C.E. (Ordinary Level) Examination.

- (vi) (a) All candidates will be commissioned as Second Lieutenants. Candidates falling under category (i) above may be given promotion to the rank of Lieutenant, with effect from the date of first commission or from such subsequent date as may be determined by the Commander of the Army, provided they are suitable and complete a basic course of training to the satisfaction of the Commander of the Army, or on satisfactory completion of 18 months' service in the rank of Second Lieutenant.

- (b) Candidates falling under categories (ii), (iii), (iv) and (v) above will be commissioned as Second Lieutenants and will be eligible for promotion as Lieutenants on the satisfactory completion of 18 months' service in that rank.

- (c) Any candidate who during his period of basic training is found unsuited for a military career and/or is found incapable of making the minimum grade required on the basic training course will be liable to be called upon to resign his commission.

- (d) **Medical Standard.**—Candidates must conform to the required Army Medical Standards.

5. Applications should be submitted in writing in the terms of the form specified below and should be forwarded to Army Headquarters, P. O. Box 553, Colombo, so as to reach there not later than 8 July, 1960. The envelope enclosing the application should be marked "APPLICATION FOR OFFICER VACANCIES, CEYLON ARMY".

6. Applications from persons already in Government Service must be forwarded through the Heads of the Departments concerned and should bear a certificate to the effect that the officer can be released if selected.

7. Applications should be accompanied by copies of—

- (a) certificate of registration of birth;
- (b) certificates in support of the educational and professional qualifications claimed;
- (c) at least two recent certificates of character from responsible persons who are personally acquainted with the applicant; and
- (d) a recommendation from the Commanding Officer of the Volunteer Force Unit in which the applicant is serving in the case of candidates falling under category 4 (c) (i) above.

8. If the number of applications warrants it, a preliminary selection will be made from amongst the candidates who fulfil the above conditions. Candidates will be required to attend such preliminary selection at their own expense at a given place, date and time. The final selection will then be made after interview of these selected candidates by a Selection Board appointed by the Minister of Defence. Candidates selected for interview will be informed in writing of the place, date and time of such interview. The final interview will take place in Colombo. No travelling or other expenses will be paid by the Ceylon Government in this respect. Candidates not selected for interview by the Selection Board will be so informed.

9. Selected candidates will be required to comply with any rules already made or that may hereafter be made for giving effect to the language policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

MINISTRY OF EDUCATION AND CULTURAL AFFAIRS

UNESCO Fellowship in the Teaching of Journalism

APPLICATIONS are invited from Journalists who possess the qualifications mentioned in paragraph 4 below for the award of a UNESCO Fellowship in the Teaching of Journalism. Applicants may be of either sex. The country or countries of study will depend on a study of the qualifications of the candidate by experts of the UNESCO Secretariat who will work out the details of a suitable study programme and make an assignment. The Fellowship is intended to contribute towards UNESCO's effort to promote international understanding through raising standards in Journalism and in the professional education of Journalists. It is expected that, on return to their own countries, recipients of Fellowships will make full and effective use of the experience and knowledge acquired during their study tour.

2. *Tenure.*—The duration of the Fellowship will be two months. The study programme will consist of two parts; an initial programme of intensive work at the Strasbourg Centre, in October, 1960, to be followed by a one-month programme of individual study in one or two European countries.

3. *Terms of Award.*—The following benefits are covered by the award:—

- (a) *Stipends.*—UNESCO applies the scale of monthly stipends agreed by the United Nations in consultation with its specialized agencies. The organization reserves the right, however, to apply lower ad hoc rates whenever living accommodation is available at no cost or at a cost considerably below the average on which the stipend rate has been based. Monthly allowances are fixed and paid in the currency of the country of study.
- (b) *Travel.*—UNESCO accepts responsibility of the payment of Fellow's Round Trip Travel Expenses.
- (c) *Other allowances.*—The Fellow is entitled to receive \$ 50 for the purchase of books necessary for his/her studies. Additional funds are set aside to meet incidental expenses such as tuition fees, travel within the country (or countries) of study. No clothing allowance is, however, provided.

4. *Eligibility.*—Every applicant should—

- (i) be a citizen of Ceylon;
- (ii) be of good moral character;
- (iii) be less than 45 years of age on the date of closing applications;
- (iv) possess a high proficiency in English;
- (v) (a) have a degree of a recognized University or equivalent qualification;
- (b) have about 10 years of professional experience in Journalism;
- (c) have a particular interest in the teaching of Journalism.

Note.—Preference will be given to applicants who can produce a letter of guarantee from their employers that the following obligations towards the applicants will be fulfilled:—

- (a) Ensuring the continuation of salary or such other arrangements as may be appropriate to maintain the Fellow's dependants, or other obligations while he is abroad.
- (b) Assurance that the Fellow will be employed upon his return from study abroad in work related to the studies for which the Fellowship was awarded.

5. *Agreement and Security.*—The selected officer will have to enter into agreements with the Government of Ceylon—

- (a) undertaking among other things to pursue faithfully and diligently the prescribed course of studies and complete it satisfactorily; and
- (b) undertaking to repay to the Government of Ceylon the full cost of the course of training, i.e., all expenses incurred by the Government of Ceylon and the Awarding Agency in connection with the entire scholarship in the event of his/her failure to comply with the terms and conditions of his/her agreement.

6. *Medical Examination.*—The selected officer will be required to submit, on a special form obtainable from this office, a medical certificate from a qualified medical practitioner, together with an X-ray photograph of the thorax.

7. *Interview.*—Candidates will be required to present themselves for an interview in Colombo at an appointed time and place. No travelling or other expenses connected therewith will be paid.

8. Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before selection, and to withdrawal of the award if discovered after selection.

9. MINISTRY OF EDUCATION AND CULTURAL AFFAIRS

Commonwealth Scholarships in New Zealand, 1961

APPLICATIONS are invited for the award of scholarships offered under the Commonwealth Scholarship and Fellowship Plan and tenable in institutions of higher learning in New Zealand, from March, 1961.

The scholarships aim at providing opportunities for Ceylonese students to pursue advanced courses or undertake research in New Zealand. They are intended for men and women of high intellectual promise who may be expected to make a significant contribution to life in their own country on their return from study abroad. The scholarships will usually be awarded for advanced study or research. In exceptional cases an award may be made to a graduate who wishes to study for another under-graduate degree, if the programme of studies he wishes to follow is not available in Ceylon. Applications are invited for the following courses:—

Geology
Civil Engineering
Electrical Engineering
Mechanical Engineering
Chemical Engineering
Agriculture
Horticulture
Architecture
Fine Arts
Public Administration
Industrial Chemistry.

2. *Tenure.*—Awards will normally be made for a programme of study or research extending over a period of two academic years and the intervening summer; but when a programme of studies so requires, awards may be made for a shorter or longer period. Each award will be continued for the period of study or research for which it is granted, provided the student's progress and conduct are satisfactory.

Scholarships are, however, liable to be terminated at any time during the currency of the course at the discretion of the New Zealand authorities, for misconduct, irregularity in attendance, absence without permission of the authorities concerned from College or Hostel, or unsatisfactory progress in studies or failure to pass examinations. In such an eventuality the scholar might be required to return to Ceylon at his/her own expense.

3. *Eligibility.*—Candidates should—

- (i) be citizens of Ceylon;
- (ii) not have reached their 35th birthday on 1st March, 1961. (But preference will be given to those between 24 and 28 years of age. In special circumstances this age limit may be raised);
- (iii) be graduates of a recognized University or holder of an equivalent qualification;
- (iv) be able to produce satisfactory evidence that they have a sufficient competence in English to profit by a course of study in Australia; and
- (v) possess a good knowledge of Sinhala or Tamil.

4. *Terms of Award.*—Each award is intended to cover the expenses of travel, living and study during its tenure, as follows:—

- (a) Travel to and from New Zealand by tourist class sea or air as arranged by New Zealand authorities.
- (b) Approved tuition, laboratory, and examination fees.
- (c) A personal maintenance allowance at the rate of £58-6-8 per month for post-graduate scholars and £41-13-4 per month for under-graduate scholars from date of arrival in New Zealand.
- (d) A grant for books and apparatus of £25 per year.
- (e) A grant for internal travel of £25.
- (f) Where appropriate, a clothing allowance of up to £40.
