BY virtue of the powers vested in me by section 82 of the Local Authorities Elections Ordinance, No. 53 of 1946, as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Junius Richard Jayewardene, Minister of Local Government and Housing, do by this Order declare—

- (a) that the notice dated May 3, 1960, published by the Elections Officer, Nuwara Eliya District, under section 27 (2) (a) of the Local Authorities Elections Ordinance, No. 53 of 1946, specifying May 21, 1960, as the date on which candidates shall be nominated for the purpose of electing a member to represent Ward No. 2 of the Nuwara Eliya Municipal Council, shall be, and shall at all times be deemed to have been void and of no effect whatsoever, and

Whereas by virtue of an Order made under the Town Councils Ordinance, No. 3 of 1946, and published in *Gazette* No. 12,119 of April 29, 1960, a Town Council has been constituted for the town of Hendala:

And whereas in terms of the said Order the term of office of the said Town Council is due to commence on the first day of February, 1961:

And whereas it is necessary that special provision should be made for the purpose of holding the first general election of the members of the said Town Council before the thirty-first day of January, 1961:

Now, therefore, it is hereby ordered and declared that, notwithstanding anything to the contrary in the Local Authorities Elections Ordinance, No. 53 of 1946-

- the Elections Officer for the District in which the town of Hendala is situated shall commence the preparation of the electoral lists for the purpose of the said general election on such date as may be determined by him; and
- (2) the said Elections Officer shall take the steps required to be taken under sections 23, 27 and 39 of that Ordinance for the purpose of the said general election on such dates as may be declared by him in the exercise of his discretion, having regard to the date on which the term of office of the said Town Council is due to commence.
