THE LOCAL AUTHORITIES ELECTIONS ORDINANCE, No. 53 OF 1946

Order under Section 82

BY virtue of the powers vested in me by section 82 of the Local Authorities Elections Ordinance, No. 53 of 1946, as modified by the Proclamation published in Gazette Extraordinary No. 9,773 of September 24, 1947, I, Junius Richard Jayewardene, Minister of Local Government and Housing, do by this Order declare—

- (a) that the notice dated April 25, 1960, published by the Elections Officer, Colombo District, under section 27 (2) (a) of the Local Authorities Elections Ordinance, No. 53 of 1946, specifying May 13, 1960, as the date on which candidates shall be nominated for the purpose of electing a member to represent Ward No. 36 of the Colombo Municipal Council, shall be, and shall at all times be deemed to have been, void and of no effect whatsoever; and
- (b) that the said Elections Officer shall publish a fresh notice under the said section 27 (2) (a) specifying another date on which candidates for election for the said ward of the Colombo Municipal Council shall be

Whereas by virtue of an Order made under the Town Councils Ordinance, No. 3 of 1946, and published in Gazette No. 11,752 of May 29, 1959, a Town Council has been constituted for the town of Battaramulla-Talangama:

And whereas in terms of the Order made under the Town-Councils Ordinance, No. 3 of 1946, and published in Gazette No. 12,055 of February 5, 1960, the term of office of the said Town Council is due to commence on the first day of February, 1961:

And whereas it is necessary that special provision should be made for the purpose of holding the first general election of the members of the said Town Council before the thirty-first day of January, 1961:

Now, therefore, it is hereby ordered and declared that, notwithstanding anything to the contrary in the Local Authorities Elections Ordinance, No. 53 of 1946—

- (1) the Elections Officer for the District in which the town of Battaramulla-Talangama is situated shall commence the preparation of the electoral lists for the purpose of the said general election on such date as may be determined by him; and
- (2) the said Elections Officer shall take the steps required to be taken under sections 23, 27 and 39 of that Ordinance for the purpose of the said general election on such dates as may be declared by him in the exercise of his discretion, having regard to the date on which the term of office of the said Town Council is due to commence.

BY virtue of the powers vested in me by sections 14 and 82 of the Local Authorities Elections Ordinance, No. 53 of 1946, as modified by the Proclamation published in Gazette Extraordinary No. 9,773 of September 24, 1947, I, Junius Richard Jayewardene, Minister of Local Government and Housing do by the Order direct by this Order direct-

(1) that, as respects the general election of the members of each local authority specified in column I of the Schedule hereto, which is due to be held before the thirty-first day of December, 1960, no electoral lists shall be prepared;

- (2) that the electoral lists to be used for the purpose of such general election of the members of each such local authority shall be the appropriate electoral lists certified by the respective Elections Officers under section 28 (1) of the aforesaid Ordinance on the dates specified in the entry corresponding to each such local authority in column II of the Schedule hereto; and
- (3) that the said electoral lists shall be operative for all matters connected with such general election of the members of each such local authority.
