THE AWARD

This is an award under section 17 of the Industrial Disputes Act, No. 43 of 1950, as amended by Acts Nos. 25 of 1956, 14 of 1957, and 62 of 1957.

It relates to an industrial dispute between the Lanka Estate Workers' Union, 47, Driberg's Avenue, Colombo 10 (hereinafter referred to as the "Union"), and the management of No. 2 Block, Ferriby Estate, Puwakpitiya (hereinafter referred to as the "Management").

2. The Honourable the Minister of Labour by virtue of the powers vested in him by section 4 (1) of the Industrial Disputes Act, No. 43 of 1950, referred the above dispute to me for settlement by arbitration by his Order of 16.1.60. The statement of matters in dispute as set out by the Deputy Commissioner of Labour bearing the date 11.1.60, which accompanied the Minister's Order, is as follows:—

- (1) whether the non-employment of the following workers of Ferriby Estate, No. 2 Block, is justified, and to what relief each of them is entitled:—

- (a) Arumugam,
- (b) Suppiah,
- (c) Perumal,
- (d) Warthiaraju, and

- (2) the demand of the Lanka Estate Workers' Union for the payment of a month's wages in lieu of notice in respect of the following:—

- (a) Muththammah (wife of Arumugam),
- (b) Karupai (wife of Perumal),

- (f) Japin (wife of Burampy).

3. Mr. Advocate A. Shanmugalingam, instructed by Mr. S. Kanagaratnam, appeared for the Union; and Mr. Advocate D. Jayasinghe, instructed by Mr. D. S. de Silva, appeared for the Management. Mr. Shanmugalingam, in opening the case for the Union, stated that Ferriby Estate at Puwakpitiya consisted of 350 acres of rubber round about 1953. 100 acres of this Estate were bought by four people as co-owners; they were Jinasamy, M. A. Amaris, A. D. Peter Singho and W. N. Nandiris Hamy. In 1956 or so the land was partitioned into four lots; lot No. 1 was given to Nandiris Hamy; lot No. 2 to Jinasamy, who was dead by that time, and the lot was said to have been managed by A. B. Siriwardena, son of Jinasamy; lot No. 3 was given to M. A. Amaris; and lot No. 4 to Peter Singho.

4. The four workers mentioned in demand No. 1 were permanent workers on the Estate who worked in lot No. 2.

5. As a result of the dismissal of one Somapala from the Estate, there was a strike which was investigated by an Assistant Commissioner of Labour. As the management refused to reinstate the workers who were on strike, the matter was referred to me for settlement by arbitration. With regard to the second demand the Union was not pressing for reinstatement of the five labourers (b) to (f). (Labourer (a), wife of Arumugam was dead). The Union was satisfied if the labourers were given a month's wages in lieu of notice. The Management agreed to this proposal, and the dispute as far as the second demand was concerned was settled at that stage.

6. In connection with the first demand there was a doubt raised with regard to the ownership of lot No. 2, after the death of Jinasamy, the original owner. It was contended by both parties that it was A. B. Siriwardena, son of the late Mr. Jinasamy, and not his wife, who became the owner of the property after the death of Jinasamy, and that Siriwardena would be in a position to give evidence in this Court on all matters connected with the lot concerned. The Court accordingly summoned Siriwardena to appear in Court on 11.6.60. He was represented by Advocate Miss Maureen Seneviratne, instructed by Mr. Eardley Seneviratne. There was no evidence to show that Mr. A. B. Siriwardena became the owner of lot No. 2 and that he managed the Estate by himself after the death of his father. At this stage both parties agreed to come to a full settlement of the matters in dispute. The terms of the settlement are as follows:—

I consider the terms of settlement fair and reasonable, and I make my award accordingly.

THE FOOD CONTROL ACT, No. 28 OF 1950

Order No. 152

BY virtue of the powers vested in me by section 4 (1) (i) of the Food Control Act, No. 25 of 1950, I, Tikiri Bandara Ilangaratne, Minister of Commerce, Trade, Food and Shipping, do by this Order—

- (d) in the Village Headman Divisions of Maravanpulaivu and Tanankilapu in the D. R. O's Division of Tenmaradchy,

"Jaffna Peninsula" for the purpose of this Order means the Revenue District of Jaffna, exclusive of the Divisional Revenue Officer's Division of Punakari and the Divisional Revenue Officer's Division of Karachchi-Thunukkai.

Regulation

1. (1) Every person employed by the Commissioner of Tea Exports for the purpose of collecting the tax payable under the Tea (Tax and Control of Export) Act, No. 16 of 1959, on tea sold at a Colombo Tea auction shall be entitled to payment of an amount calculated at the rate of seventy-five cents for each lot of tea sold by him at such auction.

(2) For the purposes of this regulation, "lot of tea" means a lot consisting of a number of packages of tea—
