The Award

THIS is an award under section 17 of the Industrial Disputes Act, No. 43 of 1950, as amended by Industrial Disputes (Amendment) Act, No. 25 of 1956, No. 14 of 1957, and No. 62 of 1957.

- It re'ates to an industrial dispute between the Hotel, Bakery and Beverages Workers' Union (hereinafter referred to as the "Union"), and the New City Bakery, 163/165 of Jampettah Street, Colombo (hereinafter referred to as the "management"),
- 2. The above dispute was referred to me by the Acting Commissioner of Labour by his letter dated 17th August, 1959, under section 3 (1) (d) of the aforesaid Industrial Disputes Acts for settlement by arbitration. The matters in dispute between the Union and the management as contained in the statement of the Deputy Commissioner of Labour of 17th August, 1959, which accompanied the Acting Commissioner's letter of even date to me, are the following demands made by the aforesaid Union:
 - one month's wages plus the cost of meals to be paid to each worker as an annual bonus;
 - (2) a meal costing not less than 60 cents per day per worker to be provided.
- 3. The hearing of the case was taken up on 4.1.60 and Mr. P. E. Perera, proprietor of New City Bakery, applied for a posponement as his Counsel was unable to be present in Court on that day owing to personal reasons. Mr. Sanmugathasan, who appeared for the Union, had no objection to a postponement. The case was fixed for the 15th of February. On this date the Union was represented by Mr. Kulaveerasingham, and the management by Mr. Advocate S. P. Amerasingham, instructed by Mr. V. H. M. Arunanayagam. In opening the case for the Union Mr. Kulaveerasingham stated that he wished to drop demand No. 2, which required the management to provide a meal costing not less than 60 cents per day per worker. He also wished to amend demand No. 1 to read: "One month's basic wages to be paid to each worker as an annual bonus." The management agreed to the new proposals of the Union, and the matter in dispute between the parties was confined to demand No. 1 as amended.

- 4. The Union based its claim for an annual bonus on the following submissions:—
 - (a) "The wages paid by the Company are low, and to bridge the gap, we are asking for a bonus."
 - (b) "These men have put in a long period of service, and the Company does not pay them any form of incremental scale or seniority allowance. They have not been paid the Rs. 17.50 allowance."
 - (c) "The workers and the management have jointly earned these profits which the Company has made, and the Company should consider payment of a bonus to bridge the gap."
 - (d) These bonuses were paid by the management in 1956 and 1957, and there was no necessity to drop the bonus in 1958.
- 5. With regard to (a) it has been definitely established that these workers are being paid according to wages as laid down by the Wages Board for this category of workers. These wages and conditions of service have been standardised to suit the particular trade. The wage is a minimum in the sense that no employer can pay less, but it does not mean that it is less than that required to maintain a minimum living standard. The wages fixed according to the Wages Board approximate more closely to a fair wage. There is, therefore, no gap applicable only for these workers. If there is a gap it is a gap applicable to all workers throughout the whole industry. Any unlateral adjustment of the standard rates by artificial means, by the addition of any yearly bonus payment, is tantamount to circumventing the broad, general decision of the Wages Board. Moreover in a highly competitive trade, it is a risk that no management will take.
- 6. With regard to (b), as there is a consolidated rate paid to this category of workers according to the Wages board, this question does not arise. It would appear, however, that those with long experience and possessing efficiency and good conduct deserve some recognition at the hands of the management.
- 7. With regard to (c), the principle is accepted that where huge profits are made by the joint effort of workers and the management, the workers should participate in the profits. In this case, unfortunately no appreciable profits have been made for the year 1958.
- 8. With regard to (d), a bonus was paid in the years, 1956 and 1957 respectively, as the Company was in a position to do so on the profits made during those two years. But in 1958 the management made no profits to pay a bonus. D. P. Kalansooria, accounts clerk, who gave evidence for the Union, stated that bonuses were paid to workers in 1956 and 1957, but no bonuses were paid to them in 1958. Mr. Kulaveerasingnam stated that the profits made by the management in 1958 worked out to Rs. 79,000 a year, and the bonus claimed by the Union was only Rs. 5,000. On a question by the Court as to how he arrived at the figure of Rs. 79,000 as annual profits made, Mr. Kulaveerasingham stated that he must have calculated it without considering the expenditure items. Mr. Amerasingham, for the management, did not wish to call in any witnesses, but submitted documents marked R. 1, R. 2 and R. 3, giving the audited Balance Sheets of the Company for the years 1958, 1957 and 1956, respectively. He stated that the management was in a position to pay a bonus in 1956 and 1957, but that when the Wages Board came into operation in 1958, the wage bill went up by 25 per cent, and the financial capacity to pay a bonus disappeared altogether.
- 9. I have exmained carefully the Balance Sheets, R. 1, R. 2 and R. 3, of the Company for the years 1958, 1957 and 1956, respectively. The net profit shown in these audited decoments are as follows:—Rs. 764.13 in R. 1 for 1958; Rs. 17,568.50 in R. 2 for 1957; Rs. 20,769.02 in R. 3 for 1956. It is to be noted that the profits in 1957 and 1956 have been realised after the payment of Rs. 7,500 as bonus for each of the two years. It is quite clear that in 1958 the management was not in position to pay a bonus.
- 10. In this connection it might be stated that certain principles have been laid down in the Industrial Cours of Ceylon with regard to the payment of bonuses. The guiding principles applicable in this case are as follows. Bonus, as the word implies, is generally an ex gratia payment paid out of the bounty and goodwill at the pleasure of an employer, and an employee has no claim to it as a matter of right. This general rule is subject to certain exceptions. One would be the case where wages fall short of the living standards, and the employer makes a profit. A second would be, whereby with the joint contribution of capital and labour the employer makes huge profis. A third would be, where there is an agreement express or implied to pay a bonus.
- 11. In these circumstances, I hold that demand No. 1 of the Union is unjustified, and the workers are not entitled to the bonus demanded.

BY virtue of the powers vested in the Deputy Controller of Prices (Food), by section 4, read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Anton Rothwell Mc Heyzer, Deputy Controller of Prices (Food), Trincomalee District do by this Order—

- (ii) fix with immediate effect the prices specified in column (2) of the First Schedule hereto to be a wholesale dealer's maximum wholesale price to a retail dealer per hundredweight nett of rice to be sold to a consumer as the first half and the second half of the legal rations above which rice shall not be sold within the areas specified in the corresponding entries in column (1) of the First Schedule hereto;
- (iii) fix with immediate effect the prices specified in column (3) of the First Schedule hereto to be the Wholesale dealer's maximum wholesale price to a retail dealer per hundredweight nett of paddy to be sold to a consumer as the first half and the second half of the legal rations above which paddy shall not be sold within the areas specified in the corresponding entres in column (1) of the First Schedule hereto;
- (iv) fix with immediate effect the prices specified in column, (2) and (3) of the Second Schedule hereto to be a retailer's maximum retail price to a consumer for the first half of the legal ration of rice (i.e., two pounds nett) and the retail dealer's maximum retail price to a consumer of the second half of the legal rations of rice (i.e. 2 lb. nett) respectively above which rice shall not be sold within the areas specified in corresponding entries in column (1) of the second Schedule hereto;

- (vii) direct that in every area where maximum prices are fixed by this Order, no person shall sell rice or paddy which is adulterated with any other article;
- (viii) direct that in every area where maximum prices are fixed by this Order every trader who has rice or paddy in his possession or under his control at any place shall exhibit conspicuously at that place a notice in which there shall be set out the maximum prices for rice or paddy fixed by this Order in that area;
- (ix) direct that in every area where maximum prices are fixed by this Order every person who sells rice or paddy by wholesale shall, and every person who sells rice or paddy by retail shall, on demand, issue the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of sale;
 - (b) the quantity of such article sold (by weight);
 - (c) the price paid for the quantity;
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or retail;
 - (e) the variety of the paddy or rice sold.
- (x) direct that when rice or paddy is sold, the maximum prices fixed by this Order shall include the price of wrapper or container, if any, in such rice or paddy is sold;
- (xi) direct that in any sale of rice or paddy in eighty measures or one hundred and sixty pounds size gunnies the sale price shall be calculated on gross weight less a tare of two and a quarter pounds (2½ lb.);
- (xii) direct that in any sale of rice or paddy in 112 measures or 224 pounds size gunnies the sale price shall be calculated on gross weight less a tare of three pounds;
- (xiii) direct that in any sale of Chinese Rice in 80 measures or 160 pounds size gunnies the sale price shall be calculated on a gross weight less a tare of $2\frac{1}{2}$ pounds;
- (xiv) direct that in any sale of American Rice in 100 lb. bags the sale price shall be calculated on gross weight, less a tare of $\frac{\pi}{4}$ lbs.;
- (xv) direct that for the purposes of this Order " nett " shall mean gross weight less tare, or naked weight of rice.
