Hours of Inspection

The office shall be open to the public every week day, except Saturday, between the hours of ten to four, and on Saturdays between the hours of ten to one, except on public holidays. Applications for inspections will, however, be accepted up to 3 p.m. on week days and 12 noon on Saturdays.

Trade Marks limited to colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to certain colours, the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

Association

Where it is stated that an advertised mark is to be associated (under Section 22 of the Trade Marks Ordinance (Cap. 121)) with another mark, it is indicated by its official number.

OPPOSITION

NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge notice of Opposition on form T. M. No. 7 bearing an uncancelled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and upon such terms as he may direct.

Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant for registration so as to afford him an opportunity of withdrawing his application before the expense of preparing the Notice of Opposition is incurred. Failure to give such notice will be taken into account in considering any application by an Opponent for an Order of Costs if the opposition is uncontested by the Applicant.

WILSON-JONES COMPANY.

"Loose leaf binder".

Abstract.—The nature of the invention can be ascertained from claims 1 and 2 which read as follows:—

- 1. A loose leaf binder comprising top and bottom post retaining members each having a plurality of apertures each aligned vertically with an aperture in the other member, flexible sheet retaining posts each extending through a pair of vertically aligned apertures and having an enlarged head lying adjacent a concave lower surface of the bottom post retaining member between edge portions thereof depending below the post heads, and top cover plates holding the upper ends of the posts below the upper edge of the top post retaining member.
- 2. A loose leaf binder as claimed in claim I in which the top cover plates are slidable in a longitudinal recess in the top post retaining member which receives the upper ends of the sheet retaining posts and in which stops are provided to prevent removal of the top cover plates from the recess.

1. A compound of the formula

wherein $\mathbf{R_1}$ is an alkyl radical having from one to five carbon atoms or an alkenyl radical having from two to five carbon atoms, and $\mathbf{R_2}$ and $\mathbf{R_3}$ are alkyl radicals having at least three carbon atoms.

"Improvements in and relating to the wilting of green tealeaves".

Abstract.—The nature of the invention can be ascertained from claims 1, 2 and 3 which read as follows:—

- 1. Apparatus for effecting wilting of green tea leaves wherein the leaves are transported by an endless conveyor through a tunnel-like enclosure through which is maintained a continuous flow of dry air.
- 2. Apparatus as claimed in claim 1, wherein the leaves are transported successively through a plurality of tunnel-like enclosures through each of which is maintained a flow of dry air.
- 3. Apparatus as claimed in claim 1 or 2 wherein air flow through the, or each enclosure, is counter to the direction of movement of the leaves.

ROGER PAUL CHARLES CARCASSONNE-LEDUC.

"Flavoured cereals".

Abstract. —The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. A method of preparation of raw or pre-cooked cereals in dry grains, impregnated substantially throughout with dry aromatic flavouring substances, said method consisting essentially in that the cereal grains are immersed in an aqueous liquid containing the aromatic flavouring substances, and are then removed from said liquid and left to rest for a period of sufficient length for the said liquid, accompanied by all or part of the aromatic flavouring substances which it contains, to penetrate and diffuse substantially throughout the grains, following which the cereals thus impregnated are brought to the required degree of dryness for marketing.

"Improvements in tea rolling apparatus".

Abstract.—According to the invention the apparatus comprises two plates each having a roughened surface, the two plates being arranged with their roughened surfaces facing one another and with a small gap between them, at least one of said plates being so shaped that the gap between the plates is smaller at the edges of the plates than in the central area thereof, means for imparting an eccentric motion to one of the plates about an axis lying substantially at right angles to the plate, and means for feeding tea leaves positively and continuously into the space between said plates in the region of said axis.

2. Tea rolling apparatus as claimed above, comprising means for rotating one of the plates relative to the other about said axis or an axis parallel thereto.

" Self hair-cutter ".

Abstract. —The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. A hair-cutter made of metal having two razor blades, mounted on blade carriers and held rigidly on the cutter-head by means of a cover plate and a clamping nut screwed on to a bolt

passing through the cutter head and cover-plate, one cutting edge of each blade being exposed through a comb like arrangement of teeth machined on two opposite edges so that hair may be cut by drawing the teeth of the cutter through the hair, allowance being made for adjusting the length of hair left uncut by shifting the blade carrier assembly across the cutter head exactly as described and illustrated in my specification and drawings.

Abstract.—This invention relates to new isonicotinic thioamides of the pyridine series, viz., α substituted isonicotine thiomides having the general formula shown below in which $\hat{\mathbf{R}}$ is an alkyl, aryl or aralkyl radical.

$$R = \frac{c - NH_2}{s}$$
