Trade Marks limited to colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colours, the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

Association

OPPOSITIO N

NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge notice of Opposition on form T. M. No. 7 bearing an uncancelled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and upon such terms as he may direct.

Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant for registration so as to afford him an opportunity of withdrawing his application before the expense of preparing the Notice of Opposition is incurred. Failure to give such notice will be taken into account in considering any application by an Opponent for an Order of Costs if the opposition is uncontested by the Applicant.

Abstract.—The nature of the invention can be ascertained from claim 1 which reads as follows:-

1. A metal-flooring or like surfacing element comprising an elongated panel with downturned flanges at the side edges and with transverse openings which extend across a substantial proportion of the width of the panel and are bounded in part at least by a downward flange.

"Process for making alpha, alpha-dihalopropionic acids".

Abstract. —The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. In a process for halogenating propionic acid, the steps which consist in (1) reacting propionic acid with an approximately equimolecular proportion of chlorine or bromine at a temperature between 50° and 140°C. in the presence of a phosphorus containing catalyst consisting of phosphorus, or a halide, oxyhalide, oxygen acid or oxide of phosphorus, whereby an alpha-halopropionic acid is obtained as substantially the sole halogenated derivative and (2) reacting the alpha-halopropionic acid with an approximately equimolecular proportion of chlorine or bromine by heating said alpha-halopropionic acid at a reaction temperature between 150° and 225°C. in the presence of said catalyst while introducing the halogen into admixture with the liquid alpha-halopropionic acid.

Abstract.-The nature of the invention can be ascertained from claim 1 which reads as follows:-

1. Method of producing wood pulp, particularly for paper making, characterised in that the wood of the rubber tree (Hevea brasiliensis) is used as raw material, the wood being reduced to chips under 1 mm in thickness, preferably between 0.1 and 0.4 mm thick, and digested by cooking.

"Improvements in or relating to compositions containing materials derived from vegetable substances".

Abstract.—The nature of the invention can be ascertained from claims 1, 2 and 3 which read as follows:—

- 1. A composition comprising a major proportion of vegetable substance having aromatic and/or narcotic constituents, for example leaves, berries or beans, together with minor proportions of (a) an edible gum and (b) oxidised tea leaf.
- 2. A composition as claimed in claim 1, wherein the edible gum is present in the composition in an amount of from 5 to 17 per cent by weight on the weight of the composition.
- 3. A composition as claimed in claim 2, wherein the edible gum is present in the composition in an amount of from 3 to 10 per cent by weight on the weight of the composition.

"Process for the preparation of a colourless or substantially colourless light hydro carbon oil freed or substantially freed from mercaptons".

Abstract.—The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. A process for the preparation of a colourless or substantially colourless light hydrocarbon oil freed or substantially freed from mercaptons by treating a light hydrocarbon oil containing mercaptons in the presence of oxygen, with an aqueous alkali metal hydroxide solution, characterised by the use of an aqueous alkali metal hydroxide solution containing a combina-

tion of an acetic acid salt as solutizer to increase the extractive power for the mercaptons and an auxiliary substance for promoting the solvent power for oxygen.

Abstract.—The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. A process of preparing leaves of plants and shrubs having aromatic and/or narcotic properties which process comprises spraying the leaves with an alcoholic liquor containing at least 80 per cent of alcohol before the fermentation stage in their manufacturing process.

Machine and process for shrinking and finishing woven textile fabrics.".

Abstract.—The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. A method for shrinking and finishing a web of woven textile fabric by means comprising a compressive shrinking device which confines the fabric between a smooth heated surface and an elastic rubber surface, the fabric being overshrunk in said device and being subsequently stretched, characterised by positively feeding the fabric in a dry condition continuously in a lengthwise direction at a uniform predetermined linear speed by means distinct from the compressive shrinking device, moisture conditioning the fabric so fed to render plastic the fibres of its yarns, stretching the moisture conditioned fabric sidewise to a selected width, then overshrinking the fabric lengthwise in the compressive shrinking device flashing off considerable moisture in the form of steam from the overshrunk fabric, and then drying the fabric whilst it is caused to move at a predetermined linear speed greater than its linear speed immediately after the compressive shrinking, and less than the linear speed of said positive feed, whereby the over-shrunk fabric is stretched lengthwise and, as a result, the amount of shrinkage left in the fabric is predetermined by the difference between the linear speed of said positive feed and the linear speed of the fabric during drying. during drying.

"Improvements in and relating to trays and like receptacles, such as are used for conditioning or storing commodities".

Abstract.—The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. The combination of a tray as hereinbefore defined, guide means therefor in or on which the sides of the tray are adopted to bear and along which the tray is adopted to be moved, means secured to or formed integrally with the tray and adopted so to engage the underside of said guide means relatively to the tray-supporting surface thereof as to impart to the tray rigid and firm support in any position into which it is moved in or on said guide means, and further means secured to, integral with, or otherwise so positioned in relation to said guide means that when the fray has been moved to one end of said guide means, said means secured to or formed integrally with the tray co-operate with said further means to prevent the tray becoming completely detached from said guide means.
