Hours of Inspection

The office shall be open to the public every week day, except Saturday, between the hours of ten to four, and on Saturdays between the hours of ten to one, except on public holidays. Applications for inspections will, however, be accepted up to 3 p.m. on week days and 12 noon on Saturdays.

Trade Marks limited to colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to certain colours, the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

Association

Where it is stated that an advertised mark is to be associated (under Section 22 of the Trade Marks Ordinance (Cap. 121)) with another mark, it is indicated by its official number.

Applications for registration in Part A of the Register are shown with the official number unaccompanied by any letter. Applications for Part B of the Register are distinguished by the letter B prefixed to the official number.

NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge notice of Opposition on form T. M. No. 7 bearing an uncancelled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and upon such terms as he may direct.

Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant for registration so as to afford him an opportunity of withdrawing his application before the expense of preparing the Notice of Opposition is incurred. Failure to give such notice will be taken into account in considering any application by an Opponent for an Order of Costs if the opposition is uncontested by the Applicant.





STAUFFER CHEMICAL COMPANY

"Improvements in and relating to thiolcarbamates".

Abstract. - The nature of the invention can be ascertained from claim 1 which reads as follows:

1. Compounds of the general formula.



where X is selected from the radical R₁SR₂, the radical R₁OR₃, a cyanoalkyl radical, a bromoalkyl radical or a cycloalkyl radical, wherein R₁ is a lower alkyl radical and R₂ a lower alkylene radical, at least one of R₁ and R₂ having at least two carbon atoms, and R₃ and R₄ are alkyl radicals, cycloaliphatic radicals, alkylene radicals, substituted alkyl radicals or together comprise a linear hydrocarbon radical, the terminal carbon atoms of which are bonded to the nitrogen atom so as to form a heterocyclic ring. atom so as to form a heterocyclic ring.

HENRIC THEODORE PERERA (Communicates of AMERICAN CYANAMID COMPANY).

"Nitrogen-containing compounds and process for preparation".

Abstract.—The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. A process for preparing 4-quinazolinones of the following general formula

wherein

- (1) R, R_1 , R_2 and R_3 are hydrogen or an alkyl radical of up to 6 carbon atoms
- (2) R_1 and/or R_2 can also be an aralkyl or substituted aralkyl radical
- (3)- R_2 can also be an OH group, in which case R and R_1 are absent with the bonds involved forming an unsaturation linkage between ring atoms 1 and 2
- (4) R and R_1 (or R_2) may be absent with the bonds involved forming an unsaturation linkage between ring atoms 1 and 2; or R_3 and R_1 (or R_2) may be absent with the bonds involved forming an unsaturation linkage between ring atoms 2 and 3
- (5) and wherein X is a halogen, an alkyl or a trihalomethyl substituent and Y is a sulfamyl substituent of the formula H₂NO₂S—; or X and/or Y are substituents other than hydrogen capable of transformation into said substituents, and including tautomers of the above compounds, said process being characterized by:
 - (a) forming an anthranilic acid derivative, having the following radical in the structural formula

$$X - \bigcap_{N-1}^{R} C \leq \dots II$$

and during or subsequent to formation, effecting intra-molecular reaction, or inter-molecular reaction with an appropriate agent, to form the 4-quinazolinone ring structure; wherein X, Y, and R are as defined above

- (b) and, if desired, reducing the compound produced in step (a) which has an unsaturation center between atoms 1 and 2 or between atoms 2 and 3
- (c) and, further, if desired, alkylating the compounds produced in steps (a) and/or (b) to convert R from a hydrogen atom to an alkyl radical,
- (d) and, at any desired time in the above sequence, if desired, converting X to a halo, an alkyl or a trihalomethyl group and/or Y to a sulfamyl group.

There are 56 claims and 51 examples.
