#### COURTS ORDINANCE

WHEREAS it is provided by section 26 of the Courts Ordinance (Chapter 6) that a Criminal Sessions of the Supreme Court for the Eastern Circuit shall be holden by one of the Judges thereof or by a Commissioner of Assize at Batticaloa and such other place or places in such Circuit as the Chief Justice, after previous consultation with the Judges, shall appoint, such Sessions commencing at Batticaloa in the months of February and July in every year;

AND WHEREAS an order has been made fixing Monday, 25th July 1960, as the date of commencement of such Sessions at Batticaloa.

AND WHEREAS it is further provided that it shall be competent for the Chief Justice, for sufficient reasons to him appearing, to alter the dates above mentioned, after previous consultation with the Judges, and to fix any other dates for the commencement of the above Sessions:

I, HEMA HENRY BASNAYAKE, Chief Justice, do hereby, after previous consultation with the Judges, fix Monday, 5th September 1960 as the date of commencement of the Criminal Sessions at Batticaloa for the Second Eastern Circuit, 1960.
