#### Notifications of Criminal Sessions of the Supreme Court

##### COURTS ORDINANCE

WHEREAS it is provided by section 26 of the Courts Ordinance (Chapter 6), that a Criminal Sessions of the Supreme Court for the Eastern Circuit shall be holden by one of the Judges thereof or by a Commissioner of Assize at Batticaloa and such other place or places in such circuit as the Chief Justice, after previous consultation with the Judges, shall appoint, such Sessions commencing at Batticaloa in the months of February and July in every year;

AND WHEREAS it is further provided that it shall be competent for the Chief Justice for sufficient reasons to him appearing to alter the dates above mentioned, after previous consultation with the Judges, and to fix any other dates for the commencement of the above Sessions;

AND WHEREAS an order made by me in consultation with the Judges was published in *Gazette* No. 12,162 of July 22, 1960, fixing Monday, 5th September, 1960, as the date of commencement of the Criminal Sessions at Batticaloa for the 2nd Eastern Circuit, 1960;

AND WHEREAS it has become necessary to alter the date for the commencement of the said Sessions:

I, HEMA HENRY BASNAYAKE, Chief Justice, for sufficient reasons to me appearing, do hereby after previous consultation with the Judges, revoke the order published in *Gazette* No. 12,162 of July 22, 1960, and fix Monday, 10th October, 1960, as the date for the commencement of the Criminal Sessions at Batticaloa for the 2nd Eastern Circuit, 1960.
