THE VILLAGE COMMUNITIES ORDINANCE

BY virtue of the powers vested in me by section 6 of the Village Cimmunities Ordinance (Chapter 198), as modified by the Proclamation published in Gazette

Extraordinary No. 9,773 of September 24, 1947, I, Mahanama Samaraweera, Minister of Local Government and Housing do, by this Order, with effect from February 1,

- constitute the village area of Pamunugama comprising the Village Headman's Divisions of Pamunugama (164), Bopitiya (165/166), and Epamulla (167), situated in Alutkuru Korale South, Colombo District, Western Province; and
- (2) dissolve the Village Committee of the Wattala village area situated in Alutkuru Korale South, Colombo District, Western Province.
