##### IMPORT CONTROL NOTICE No. 33/60

###### Import of Black Cloth Umbrellas

IMPORTERS are informed that a licence is not required now for the importation of black cloth umbrellas if manufactured in any territory other than the Ceylonised areas.

Black cloth umbrellas manufactured in the Ceylonised areas could now be imported by Registered Ceylonese Traders who are authorised to import black cloth umbrellas on their General Import Licences.
