The Award

This is an award under section 17 (1) of the Industrial Disputes Act, No. 43 of 1950 (as amended).

It relates to an industrial dispute between the All-Ceylon Commercial and Industrial Workers' Union (hereinafter referred to as "the Union") and Messrs. Tyrecraft Limited, Colombo (hereinafter referred to as "the Company").

2. By his Order dated 22nd December, 1959, the Hon. the Minister of Labour referred this dispute to me for settlement by arbitration under section 4 (1) of the Industrial Dispute Act.

3. According to the statement of the Deputy Commissioner of Labour dated 18th December, 1959, the matter in dispute between the Union and the Company is whether the non-employment of the following nine workers is justified and to what relief they are entitled to:—

1. K. T. Karunaratne.
2. N. P. G. Gunadasa.
3. T. G. Alwis.
4. N. W. G. Premadasa.
5. T. G. Ariyadasa.
6. W. M. D. Karunadasa.
7. W. Sardiel.
8. W. A. Siripala.
9. W. D. Fernando.

4. At the inquiry before me Mr. Advocate S. Suntheralingam instructed by Mr. S. Kanagaratnam appeared for the Union, and Mr. Advocate R. A. Kannangara instructed by Mr. K. Pethiyagoda appeared for the Company.

5. Mr. Suntheralingam mentioned that most of the discontinued employees had obtained employment elsewhere and that the Union was interested only in the cases of K. T. Karunaratne, N. P. G. Gunadasa, W. M. D. Karunadasa and W. D. Fernando.

During the course of the inquiry, W. M. D. Karunadasa and W. D. Fernando also secured employment and the present inquiry was confined to the cases of Karunaratne and Gunadasa.

6. The Company is engaged in the business of re-treading motor car tyres. It has been in existence for several years and its business appeared to have been successful. But in the year 1959 the Company found that there was a reduction in the business as a result of the organisation of the Ceylon Transport Board. Prior to the establishment of the Ceylon Transport Board a number of bus operators had sent their tyres for re-treading to this Company, but the Ceylon Transport Board decided to call for tenders for this purpose, and as several similar establishments had been set up the Company was not successful in the tenders they submitted. There was, therefore, a less of work commencing from about May 1959. It was therefore decided to reorganise the business and to reduce the number of persons who were in employment at the time. Notices were given to the nine persons mentioned above discontinuing their services. The Union made representations to the Labour Department which held several conferences, but no settlement was arrived at.

7. The two employees, Gunadasa and Karunaratne, had been employed to work at the service section which had earlier been run by a company called the Auto Service Company. This had later been taken over by the present Company. As a result of the construction of new buildings the service section was closed down about the beginning of the year 1959. Thereafter these two employees were given work in the re-treading section. Their work was principally to carry tyres from one section to another while the majority of the workers in the section attended to work of a technical nature. Thus when the Company considered it necessary to discontinue certain employees, they included these two employees who had been the most junior of the employees in that section if their past service in the service section were disregarded.

8. Taking all the circumstances into consideration, I am of opinion that the retrenchment in question was justified and that the discontinuance of the two workers in question was reasonable, but the amount of compensation paid is insufficient. They have each been given two week's notice and paid an ex-gratia allowance of two week's wage. Gunadasa has been in service from July, 1953 and Karunaratne from 25th February, 1957. My award is that Gunadasa should be paid three month's gross wages as compensation and that Karunaratne should be paid one month's gross wages as compensation. These payments should be made within three weeks of the publication of this award.

THE AWARD

This is an award under section 24 of the Industrial Disputes Act, No. 43 of 1950, as amended by the Industrial Disputes (Amendment) Acts, No. 25 of 1956, No. 14 of 1957 and No. 62 of 1957.

It relates to an industrial dispute between the All-Ceylon Commercial and Industrial Workers' Union (hereinafter referred to as the "Union") and Messrs. Rowlands, Limited (hereinafter referred to as the "Company").

2. The Honourable the Minister of Labour, by his Order dated the 15th October, 1959, made under section 4 (2) of the said Act, referred the industrial dispute between the Union and the Company to this Court for settlement. According to the statement issued by the Deputy Commissioner of Labour dated 7th October, 1959, the matter in dispute between the parties is the demand made by the Union for the payment of one month's gross wages for each year of service as gratuity to the 39 workers whose names are mentioned therein.

3. On the 9th June, 1960, Mr. Freddie M. Fernando, an official of the Union, and on the 10th June, 1960, Mr. Advocate K. Palakidnar, instructed by Mr. R. Savaranagabhavan, Proctor, represented the Union. Mr. Lyn Wirasekera of the Employers' Federation represented the Company.

4. The admitted facts of this case are as follows. The Company had an establishment at Navinna where among other works it carried on the business of building bus bodies for a number of bus Companies. The 39 workers referred to in the statement were employed by the Company in this business. When the Ceylon Transport Board was established, and the bus Companies ceased to own or run buses, the Company lost its business, and had to close down the bus body building section of its establishment. The workers had accordingly to be retrenched. On the 29th November, 1958, they were given a month's notice of the termination of their contract of service and they ceased to be employed as from 31st December, 1958. They were all daily-paid workers who were in receipt of a basic wage and a dearness allowance. Their periods of service ranged, according to document R. 1, from one year to 14 years.

5. The Union does not challenge the bona fides of the retrenchment. It demands that, in retrenching, the past services of the workers be considered and that they be paid a gratuity of one month's gross wages for each year of service. According to the statement filed by the Company under Regulation 20 of the Industrial Disputes Act, these workers were given a month's notice of termination of their services, though they are only daily-paid workers, and were offered a month's wages, whether they worked during the month or not. That was to enable them to go about seeking fresh employment. They were also offered the Provident Fund contributions and, except in the case of 9 workers to whom I shall refer presently, they were all offered an ex gratia payment of Rs. 25 for each year of service. They were also given the annual bonus as paid to other workers for that year and holiday pay for the official closing week from 1st to 8th January, 1959.

6. With regard to the nine workers referred to above, to wit., Nos. 18, 21, 23, 24, 25, 27, 29, 35 and 36 in the statement, they were treated as being retired on account of physical unfitness, and were given special benefits in excess of what the others were getting. These are the men with the longest years of service, except for M. Charles, No. 36, who has only 9 years of service. The answer filed by the Union does not deny the averments made by the Company, but states that the Provident Fund contributions are totally inadequate.

7. For the moment, I will leave out of consideration the nine workers referred to above, and deal with the dispute with regard to the other workers. I must state that I agree with the Union that the Provident Fund contributions are totally inadequate. This fund was established after the Walkers' Award, I. D. 7, on 1st January, 1957. In terms of I. D. 7 the workers contributed 4% of their basic wages and the employer contributed 6%; so up to the date of retrenchment, 31st December, 1958, the Fund has been in existence only for two years. The amounts lying to the credit of each individual worker must indeed be small. The money that stands to the credit of each worker belongs to him and should be paid to him (unless, of course, the provisions of the Employees' Provident Fund Act require that these sums be paid to Government for the Government to hold the money till the workers actually retire). The payment of the Provident Fund cannot be considered a retrenchment relief. It is provision for their period of retired life.

8. The question of retrenchment relief should be considered apart from the Provident Fund. The Company has offered to pay Rs. 25 for each year of service. This offer is not acceptable to the Union. The Union's demands are a month's gross wages for each year of service, but at my hearing it was stated that it would be satisfied if half a month's gross wages were paid for each year of service. The Company was agreeable to it, provided a ceiling limit of five years was fixed. The limitation of five years was not acceptable to the Union.

9. At this stage, it would be useful to examine Awards made by the Industrial Court in other cases of a similar nature. I. D. 35, The Nidahas Karmika Saha Velanda Sevaka Vurthiya Samithiya versus Messrs. Parakramas, Limited, decided on the 26th March, 1958, would appear to be the earliest case where retrenchment relief was considered. In that case a claim for gratuity based on a month's wage for each year of service was considered and rejected, though there was no Provident Fund. The Court then considered the question whether the employees, who had been thrown out of employment as a result of the closure of the foundry and workshop, are entitled to receive any remuneration, and if so, what is the quantum of compensation that should be paid. The Court proceeded to examine the unemployment relief granted to workmen in India, and went on to say,

"It is difficult to lay down a general formula applicable to all cases without taking into consideration the several factors which should be made applicable to the particular case." Taking all the factors of that particular case into consideration, the Court directed that ten days' basic wage and dearness allowance be paid for each year of service, but not exceeding in the aggregate the wages and dearness allowance payable for a period of 52 days; that would be roughly for a period of five years. In I. D. 154 and 165, The Nidahas Karmika Saha Velanda Sevaka Vurthiya Samithiya and the Eksath Engineeru Saha Samanya Kamkaru Samithiya versus The Ceylon Coconut Industries, Limited, after taking all the peculiar features of that case into consideration, the Court made award as follows:—

"15 days' gross wages for each year of service, if he is a daily-paid or a piece-rated employee, and one half of a month's gross salary for each year of past service, if he is a monthly paid employee. But, the maximum payable to each employee will be limited to the amount he would be entitled to, if his services were for a maximum period of five years. This compensation is granted to help the employee over the difficult period of possible unemployment."

In I. D. 258, The Nidahas Karmika Saha Velanda Sevaka Vurthiya Samithiya versus Messrs. Ceylon Cold Stores, Limited, the Court made award as follows:—

"Our award therefore is that retrenchment relief should be paid at the rate of two weeks' wages for each year of service, subject to a maximum of 2½ months' wages in the case of retrenched bakers, and 2 months in the case of other retrenched employees."

In I. D. 60, The Ceylon Workers' Congress versus the Superintendent of Carfax Group, the retrenched labourers were granted one month's wages in lieu of notice and compensation based on wages for three months.

10. If there is one outstanding principle which can be inferred from these cases, it is that the demand for gratuity for past service has been rejected. It is unemployment relief which has been granted to enable the workers to tide over the difficult period of unemployment between their ceasing to work under one employer and taking up work under another. Except in the Carfax case, that relief had been measured on the basis of 15 days' gross wages for each year of service up to a maximum of five years (10 days in the Parakrama case). In the result what was awarded was 2½ months' gross wages for those of five years of service and longer, and proportionately less for those with lesser number of years of service. In the Carfax case, taking into consideration that the workers had to vacate their line rooms where they resided and seek other places of residence, the award was 3 months' gross wages, irrespective of length of service.

11. The question of retrenchment relief should, as stated by me earlier, be considered apart from the Provident Fund. The Union's demand now is half month's gross wages in respect of each year of service. The Company has offered Rs. 25 for each year of service. Of course, half month's gross wages for each year of service would be much higher than Rs. 25 for each year of service. Let me take an illustration:—H. M. Fonseka's (No. 17 in the list attached to the statement of the Deputy Commissioner) basic wage was Rs. 2.92 and gross wage Rs. 5.11. He had 8 years' service; if he is paid half a month's gross wage for each year of service, this would amount to Rs. 531.44. If he is paid Rs. 25 for each year of service, this would amount to Rs. 200. If, on the other hand, he is paid on the principles laid down in the cases referred to above, he would receive Rs. 5.11 × 26 × 2½ equalling Rs. 332.15. I see no reason for not following the principles decided in the above cases. There had been no practice in this Company of paying any gratuity at all to retired workers. After the publication of the Award in I. D. 7, the Company had drawn up rules for paying a gratuity, to which I shall refer later. Based on these rules, if a worker had worked for 15 years or more, then he would have been entitled to a gratuity; but that gratuity would be less than what is now claimed on the basis of half month's gross wages for each year of service. I see no justification for a worker who is retrenched to be in a better position than a worker who has worked for many years and is retired on account of physical unfitness. I would like to follow the precedents set up by the earlier Courts, but with a slight variation. In those cases it was decided that each worker should get half a month's gross wage for each year of service up to a maximum of five years. That is to say, a worker with, say, only one year's service would get only half a month's wage, and one with two years would get only a month's wage. In my opinion, a worker with a longer service may find it easier to obtain new employment than one whose service is short, because of his lack of experience. I do not see how I can discriminate and direct that one whose service is short be paid a lesser sum as unemployment relief than one with a longer period of service. Of course, it may be urged that one with longer service is probably a married man and has a greater burden to carry than one who has a shorter period of service, who may be single. I think that situation is balanced by the fact that opportunities for early re-employment are greater in the case of one with a longer service than in the case of one with a shorter service. I direct that every worker, irrespective of length of service, be paid 2½ months' gross wages as retrenchment relief.

12. Now, with regard to the 9 workers, to wit., Nos. 18, 21, 23, 24, 25, 27, 29, 35 and 36 in the statement, as stated earlier, they were not treated by the Company as having been retrenched, but as having been retired on account of physical unfitness. According to the Union only one of them is really unfit for further work. The others are still fit to carry on for some more years. Two of them were called before me, and I judged them to be capable of some more years of work. The fact that the Company treats them as retired does not in any way prevent them from seeking fresh employment. In their case, the question is really which is of greater advantage to them—to treat them like the others as having been retrenched and entitled to the same unemployment relief that others are getting, or to treat them as retired and as having qualified for the retirement benefits the Company grants. The reason why the Union asks that they be treated like the rest is because the Union had asked for a gratuity on retrenchment of one month's gross wages for each year of service. If that were granted to the others, it should also be granted to these, as the sums they would then be entitled to will be larger than the retirement benefits. But the others have not been granted what they asked. If these men are granted the same relief as the others get, it would be 2½ months' gross wages; that would be much less than the retirement benefit. The retirement benefit is the one which has been recommended in I. D. 7. That is to say, the retiring benefit is the basic daily wage multiplied by 26 (the number of days a daily-paid worker works in a month) multiplied by the number of years of service and divided by 1.5. Dividing by 1.5 is the same as multiplying by 2/3; that is to say, a retired worker would get two-thirds of the monthly basic wage for each year of service. One may take the case of one of these workers, Charles Thisera (No. 25 in the list), for an illustration. His basic wage at the time of his discontinuance was Rs. 3/52. This multiplied by 26 multiplied by 14, his years of service, multiplied by 2/3, would equal Rs. 854/18. His gross wages were 5/71; this multiplied by 26 and by 2½ would equal Rs. 371/18. So he would obviously be much better off with retirement benefits. I direct that these nine workers be paid retirement benefits, as proposed by the Company. They will, of course, get their Provident Fund contributions in addition.

I make award accordingly. The payments referred to in this Award should be made through the Department of Labour within one month of the publication of this Award in the *Ceylon Government Gazette*.

## MUTTON AND BEEF

## THE CONTROL OF PRICES ACT, No. 29 OF 1950

## Order

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Hettige Don Tudor Bodidasa, Assistant Controller of Prices (Food), Matara District, do by this Order—

(i) revoke with effect from this date the Food Price Orders mentioned below:

(a) Food Price Order No. NT/6/58 dated June 11, 1958, and published in the *Ceylon Government Gazette Extraordinary* No. 11,862 of June 17, 1958;

(b) Food Price Order No. MT/6/59 dated September 12, 1959, and published in the *Ceylon Government Gazette Extraordinary* No. 11,855 of September 15, 1959;

(ii) fix with effect from this date the prices specified in columns 2 to 5 of the schedule hereto to be the maximum prices per pound above which mutton or country beef of the description and grades specified at the heads of those columns shall not be sold within the areas specified in the corresponding entry in column 1 of that schedule;

(iii) direct that for the purpose of this Order—

(a) "mutton" shall mean the flesh of a sheep or goat but shall exclude all forms of offal;

(b) "country beef" shall mean the flesh of domesticated Indian or Sinhala cattle or of a buffalo but shall exclude all forms of offal;

(iv) direct that when mutton or country beef is sold with bones the weight of the bones sold therewith shall not exceed 25 per cent of the total weight sold;

(v) direct that in the areas where maximum prices are fixed by this Order every trader who has any mutton or country beef of the description and grades specified in

the schedule in his possession or under his control at any place or in any vehicle shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for mutton or country beef of the description and grades specified in the schedule fixed by this Order in that area;

(vi) direct that when mutton or country beef is sold together with offal in the course of one transaction the mutton or country beef shall be weighed and sold separately from the offal;

(vii) direct that every trader when selling mutton or country beef shall so place his weighing scale or scales that the purchaser of the mutton or country beef shall be able to ascertain easily the true weight of the mutton or country beef he purchases;

(viii) direct that every trader who sells mutton or country beef of the description and grades mentioned in the schedule hereto shall give the purchaser of the mutton or country beef on demand a receipt in which there shall be set out—

(a) the date of sale;

(b) the quantity of mutton or country beef sold (by weight);

(c) the description of mutton or country beef sold;

(d) the price paid for the quantity of mutton or country beef sold;

(ix) direct that in every area where maximum prices are fixed by this Order no person shall sell the articles specified in the schedule which is adulterated with any other meat or flesh;

(x) direct that when the article specified in the schedule is sold the maximum prices referred to in columns 2 to 5 of that schedule shall include the price of wrapper or container if any in which such article is sold;

(xi) direct that for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight.
