Decision

Reference under section 34 of the Industrial Disputes Act, No. 43 of 1950

The above reference was sent to me by the Acting Commissioner of Labour by his letter dated 7th July, 1960.

- 2. The Deputy Commissioner of Labour, by his statement of 7th July, 1960, annexed to the reference, detailed the matter in dispute as one of interpretation of paragraph 16 of my Award published under section 18 (1) of the aforesaid Act in the Ceylon Government Gazette No. 12,125 of May 6, 1960. The point sought to be clarified was: "Should Peter Fernando be employed in the capacity of a Machine Operator to satisfy the requirement of the said Award?"
- 3. The parties, as required by the Industrial Disputes Regulations, 1958, forwarded their statements outlining their respective submissions. The employer, in his submission, contended as follows:—
 - (a) that it would satisfy the requirement of the Award if the employee referred to was paid the same wages and enjoyed the same privileges as before;
- (b) that "the exigencies of the service" did not warrant the continuance of the business in that section.
- 4. The Union, in their statement, averred—
- (a) that the work of a machine operator was a skilled job demanding specialised knowledge;
- (b) the term "reinstatement" would mean that the employee should be given back the post he last held.
- 5. The parties were then notified to be present on 30.8.60, on which date they were called upon to make their submissions.
- Mr. N. Sanmugathasan amplified the Union's statement and stressed the fact that the case was simple in that it hinged on the precise interpretation of the word "reinstatement". The term merely meant "putting a person back to where he belonged", or in the alternative to a similar job of the same status and wages. He further stated that on the day Peter Fernando reported for work, a person named Kuruppu was working the machine, but Peter Fernando was ordered to do a labourer's work by Mr. C. B. Mody, the Managing Director.
- 6. Mr. Kanagarajah, Proctor S.C., prefaced his counter-submissions by remarking that these workers were originally employed unconditionally, "so that they had to do whatever work that

was entrusted to them ", and that Peter Fernando was first employed in the yard and gradually "was put on to the machine". Peter Fernando and his assistant, Dhanapala, who had since left the job on his own accord, were engaged in beading and moulding timber, which business had been closed down.

- 7. Mr. Peter Fernando in his evidence stated that when he reported for work a few days after the publication of the Award, Mr. C. B. Mody, the Managing Director, informed him that he should carry logs and that his job of machine operator was not available to him. He supported the submission of Mr. Sanmugathasan, who appeared for the Union, that Kuruppu who was then working the machine had offered the work to him.
- 8. It would appear that the Union's allegation that Peter Fernando was offered the work of a labourer was not refuted by Mr. Kanagarajah, for the employer; but on the contrary it was supported in the main by him. He referred to the unconditional employment of these workers, including Peter Fernando, when they were first employed. He stressed the position and the attitude of the employer in unequivocal language in the following words:—
 - (a) "these workmen originally were employed on no conditions, so that they had to do whatever work was entrusted to them."
 - (b) "like Kuruppu who was in charge, this person was also employed in the yard as we'l as for work in the machine, and as gradually time went on, he was put on to the machine."
- 9. The words quoted in the preceding sub-paragraph (a) would mean the reservation of absolute right by the employer to offer an employee any work. The phrase "whatever work" is significant, and implies the allotment of work of even that of a labourer. In this context I would mention that the statement of the Union representative that "there is no similar job in the factory, but only one machine operator "was unchallenged by the management. "Reinstatement" as distinct from "reemployment " is the restoration of the same job or similar job of same emoluments and status to an employee. This definition is in full accord with the authority cited by Mr. Kanagarajah himself from an article from the "Law of Industrial Disputes, 1958" by Row and Sethi, which reads as follows: "all that is required is that an ex-employee should be restored to his previous position so far as capacity, status and emoluments are concerned, and there is nothing extraordinary in such restoration being ordered when considered necessary in the interests of peaceful settlement of industrial disputes ".
- 10. According to this definition of the term "reinstatement", the crucial issue lies on the words "capacity" and "status". It cannot be conceived by any stretch of imagination that the job of a machine operator—the only machine operator, as submitted by Mr. Sanmugathasan—is commensurate with the duties of "whatever work" as explained by Mr. Kanagarajah. The words "like Kuruppu who was in charge" might refer to the submission of Mr. Sanmugathasan about Kuruppu working the machine when Peter Fernando reported for work, or to some other time. If it was the latter, it would be of interest to know when Kuruppu was in charge of the machine, since Peter Fernando had been employed as a machine operator from 1947, almost from the inception of the business on its present site. If it was the former, it would be a tacit admission that this section of the business had not been closed down.
- 11. Pursuing Mr. Kanagarajah's line of argument, I should analyse that an employee who was originally employed "on no conditions"—to quote the words of Mr. Kanagarajah—and was engaged as a labourer but had worked his way up to do skilled work after a few years would start life all over again from the lowest rung of the ladder, in the event of his reinstatement being ordered. Such a proposition is fallacious and untenable and is repugant to the very spirit and concept of social justice. It tends exclusively to support the allegation by the Union that the management has acted maliciously by assigning to Peter Fernando the work of a labourer on reinstatement. It should, however, be noted to the credit of Peter Fernando that he was employed as a machine operator since 1947, almost from the start of the business at the present site.
- Mr. Kanagarajah argued that even as a machine operator, a certain amount of manual labour such as cleaning the machine, etc., was involved, implying thereby that any other form of manual work should not be considered derogatory by Peter Fernando. It will be admitted that this work of cleaning the machine is incidental to his main work, and is only a composite part of his work as a machine operator, and bears no analogy to any other form of manual labour.
- 12. Mr. Kanagarajah's second submission, on behalf of the management, was that they had ceased operating the machine, as that section of their business was closed down. This is undoubtedly a later theory—an afterthought—devised as a seemingly plausible explanation for the employer's action. This plea was not put forward by the employer at the departmental conference held so recently as 22.6.60, presided over by the Assistant Commissioner of Labour, Industrial Relations, Colombo, vide notes of the conference marked A1. Moreover, the machine had been in constant use for fifteen to twenty years as deposed to by Mr. Kanagarajah. It is inscrutable that

the machine which was considered indispensable for several years could have gone into sudden disuse now, synchronizing with the reinstatement order. If it was true that the machine was in disuse from the time Peter Fernando was dismissed from the service of the firm, this plea should have been brought out in support of their defence at the original inquiry. But at no stage of that hearing was such a submission presented to Court. I am compelled, therefore, in the context of the circumstances to disbelieve the story.

- 13. In this enlightened age, it is expedient and desirable that employers should cultivate a sense of sobriety and kindliness of heart towards their employees with a view to harmonising employer-employee relations. The achievement of this ideal is of the ultmost importance in the industrial sphere. It cannot be achieved, however, by an employer adopting such an offensive and uncompromising attitude, by expecting an employee to do "whatever work" as stated by Mr. Kanagarajah, that was allotted to him on his reinstatement. Such an attitude does not accord with the true significance and implication of the term "reinstatement", as pointed out earlier. It seeks to lower the normal standards of democracy and to retard rather than advance the progressive trend of the present age.
- 14. In the light of my earlier observations, I hold the view that the Award published in the Government Gazette No. 12,125 of May 6, 1960, entitles Peter Fernando to be reinstated as machine operator, the post he last held in the Burma Teak Trading Company, Limited. I answer the question quoted in the foregoing paragraph 2 in the affirmative, and give my decision accordingly.
