#### GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE PUBLIC SERVICE ADVERTISED IN THE “CEYLON GOVERNMENT GAZETTE”

**1. Allowances.**—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

**2. Conditions of Service.**—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

**3. Terms of Engagement.**—(i) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay) appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute, at their option, a further 5 per cent. The Government contribution in either case will be equal to 7½ per cent. of the salary paid in at the close of each financial year.

(ii) Appointees may be required to furnish security in terms of the Public Officers (Security) Ordinance, if so required by the Head of their Department.

(iii) Appointees other than those already in the Public Service will be required to pass a medical examination by a Government Medical Officer as to their physical fitness to serve in any part of the Island.

**4. New Entrant Officers.—**

(i) The period of probation/trial of “New Entrant Officers” appointed to pensionable posts/non-pensionable posts, as the case may be, shall be 3 years unless a longer period is prescribed in respect of any posts.

(ii) “New Entrant Officers” will be required to comply with any rules already made or that may hereafter be made for giving effect to the Language Policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

(iii) (a) These officers will be required to acquire proficiency in Sinhala during their period of probation/trial.

(b) Their confirmation, at the expiry of the period of probation/trial, will depend, *inter alia*, on the passing of a proficiency test in Sinhala.

Those who fail to reach the prescribed standard of proficiency in Sinhala during their period of probation/trial are liable to be discontinued, but discontinuance may be deferred if the appointing authority is satisfied that a genuine attempt had been made to acquire proficiency in the Official Language. Loss of seniority may be waived at the discretion of the appropriate authority if the officer passes the test within a reasonable time after the due date.

(iv) New Entrant Officers who qualify for entry into the Public Service through the Sinhala medium will be exempted from the Proficiency Test in Sinhala.

*Note.*—The term “New Entrant Officers” in this context means officers appointed to posts in the Public Service on or after September 24, 1956, who are not deemed to be old entrant officers in terms of sub-paragraphs 2 (ii) (b) and 2 (ii) (c) of Treasury Circular No. 379 of 23rd May, 1957.

**5. Qualifications required.**—Every applicant must furnish satisfactory proof that he is a Ceylonese. A “Ceylonese” is a citizen of Ceylon by descent or by registration.

**6. War Service Concession.**—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty’s Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service commencing from September 3, 1939, at the earliest, and up to December 31, 1949, at the latest, from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

**7. Other Requirements.**—(i) Applications from officers of the Public Service who are qualified must be forwarded through the Heads of their respective Departments. In the case of applications from officers holding permanent posts in the Public Service, the Heads of the Departments concerned should, in forwarding the applications, state whether or not they are prepared to release the applicants (if selected) in accordance with Administrative Regulation 109 of the Manual of Procedure.

(ii) Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.

(iii) Anyone desiring to recommend a candidate should do so by giving a testimonial. Any form of canvassing or attempt to influence the selection of a candidate will disqualify such candidate.

(iv) Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection, and to dismissal if discovered after the selection.

#### Training Classes for Typists in Sinhala

APPLICATIONS are invited from persons (males and females) qualified for admission to the above training classes to be conducted by the Official Language Department. The classes are expected to continue for about six months and will be held during office hours in Colombo. There are vacancies for 20 trainees.

2. *Qualifications required.*—Every applicant must furnish satisfactory proof that he/she—

- is a Ceylonese. (A "Ceylonese" is a citizen of Ceylon by descent or by registration);
- has passed the S. S. C. or equivalent or higher examination with a credit pass in the Sinhala Language and at least two credit passes in any other subjects;

- is of excellent moral character and physically sound.

3. Candidates will be required to present themselves for an interview and examination at Colombo at an appointed time and place which will be indicated later. No travelling or other expenses will be paid. Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection and to discontinuance if discovered after selection.

4. No allowance whatsoever will be paid during the period of training. Employment of a temporary or permanent nature either in the Department or in the Public Service is not guaranteed at the conclusion of training. But the candidates, if otherwise eligible, will have a chance of taking up the examination for Typists (Sinhala) to enter the Typists' Transferable Service under Government, if and when such an examination is held.

5. During the course of training periodical tests will be held according to the results of which the trainees will be allowed to continue. Any trainee who does not satisfy the Department with regard to his/her attendance, studies, general suitability or behaviour is liable to summary rejection at any time during the period of training. Any trainee so rejected will not be eligible for selection for subsequent training classes. At the end of the period of training there will be held a qualifying examination and a certificate will be issued to those trainees who successfully complete the examination. 2. The selected candidate will be granted a regular Commission in the Ceylon Army in the rank of Second Lieutenant or Lieutenant depending on qualifications and will be appointed to the post of Army Education Instructor.

3. On appointment the selected candidate will draw the pay and, if married, the marriage allowance appropriate to his rank. Ration and other allowances will also be payable as prescribed in the Army Pay Code. The basic rates of pay for officers up to the rank of Major are as follows :—

**Examination for Recruitment of Postmasters and Signallers**

DATE of Examination—January 20 and 21, 1961.

2. A competitive examination for the recruitment of male candidates as Postmasters and Signallers will be held in Colombo and at the following Centres :—

Gampaha, Kalutara, Moratuwa, Negombo, Galle, Hambantota, Matara, Batticaloa, Trincomalee, Anuradhapura, Kegalla, Ratnapura, Kandy, Matale, Jaffna, Mannar, Point Pedro, Vavuniya, Badulla, Chilaw, Kurunegala and Puttalam.

Note.—Any Centre for which a sufficient number of candidates do not enter will be cancelled.

3. Medium in which the Examination will be held—

- (a) The Examination will be held in all three media, viz., Sinhala, Tamil and English.
- (b) Candidates who have passed the qualifying examination in the Sinhala medium must take the examination in that medium. Those who have passed the qualifying examination in the Tamil or the English medium must take the examination in that medium provided that they may elect to take up the examination in the Sinhala medium. Those who possess the qualification at (e) in paragraph 4 (3) below, must take up the examination in the medium in which they passed the J. S. C. Examination provided that those who have passed the J. S. C. Examination in the Tamil or in the English medium may elect to take the examination in the Sinhala medium.
- (c) Officers already employed in the Post and Telecommunications Department who are permitted to sit for this Examination irrespective of educational qualifications and who have not passed any of the qualifying examinations prescribed in para 4 (3) must take up the examination in the medium in which they had been taught, provided that those who had been taught in the Tamil or the English medium may elect to take it in the Sinhala medium.

4. Eligibility: General conditions of—

- (1) Candidates must be of good character;
- (2) Candidates must be Ceylonese. For the purpose of these appointments, a Ceylonese is a citizen of Ceylon by descent or by registration.
- (3) Candidates should have passed at least—
  - (a) The Senior School Certificate (Sinhalese); or
  - (b) The Senior School Certificate (Tamil); or
  - (c) The Senior School Certificate (English); or
  - (d) The Final Commercial Certificate of the Ceylon Technical College; or
  - (e) One of the following :—
    - (i) Cambridge Junior Certificate;
    - (ii) J. S. C. (Sinhalese or Tamil or English) Education Department;

- (iii) J. S. C. (Sinhalese or Tamil or English) School approved by the Education Department;

Together with one of the following :—

- (iv) Either the Commercial Education Certificate (General Commercial or Shorthand Typists' Section) (Overseas) or the Higher Commercial Education Certificate (General Commercial or Shorthand Typists' Section) (Overseas) under the Ceylon Scheme of the London Chamber of Commerce.
- (v) Either the Commercial Education Certificate (General Commercial or Shorthand Typists' Section) or the Higher Commercial Education Certificate (General Commercial or Shorthand Typists' Section) awarded by the Ceylon Chamber of Commerce and the Ceylon Education Department.
- (vi) The Commercial Certificate or the Higher Commercial Certificate (for Book-Keepers or for Shorthand Typists) of the Ceylon Technical College.

(4) Candidates must—

- (a) be not less than five feet in height ;
- (b) possess good sight and hearing ;
- (c) not stammer or have any other defect of utterance which would prevent them from efficiently carrying out telegraph and telephone duties ;
- (d) be capable of writing legibly and be able to take down dictation at 15 words per minute in Sinhala or Tamil or at 22 words per minute in English. Candidates should not be left-handers ;
- (e) candidates must not be less than 17 years or more than 26 years of age on October 8, 1960.

5. Eligibility—Special concessions for officers already employed in the Post and Telecommunications Department—

(A) Postal Assistants :

(i) Postal Assistants are eligible to sit for this examination irrespective of age, educational qualifications and length of service. They should offer subjects (1), (2) and (3) under para. 14 Part I together with the Paper in Departmental Procedure under Note (ii) to Part I of para. 14. Those who obtain 40 per cent. and over of the aggregate marks allotted to these four subjects will be appointed to the Postmasters' and Signallers' Service.

(ii) The requirements that candidates should not be less than five feet in height and should not be left-handers as laid down in paragraph 4. (4) (a) and (d) above, will not apply to Postal Assistants.

(B) Permanent Employees :

(i) All employees in the Post and Telecommunications Department with over 4 years' permanent and satisfactory service in the Department (employment in another Department in a permanent or temporary capacity or in this Department in a temporary capacity will not be reckoned to make up the period of 4 years' service) will be allowed to take up this examination irrespective of age and educational qualifications.

(ii) All such employees with over 4 years' permanent and satisfactory service in the Department who were initially recruited to a grade for which the minimum educational qualification now required is less than the J. S. C. who fail to secure places in the general competition will be allowed to compete among themselves for 25 per cent. of the vacancies in the Postmasters' and Signallers' Service provided they obtain a minimum of 40 per cent. of the aggregate marks for the examination. If the number of candidates who qualify falls short of the 25 per cent. reservation the remaining vacancies will be filled from among those who succeed in the general competition and secure a minimum of 50 per cent. of the aggregate marks.

(iii) All employees in the Post and Telecommunications Department with over 2 years' permanent and satisfactory service in the Department will be allowed to take up this examination provided they have passed the J. S. C. (Sinhala or Tamil or English).

(iv) Permanent employees in the Post and Telecommunications Department, irrespective of length of service, will be allowed to take up this examination provided they possess the educational qualifications specified in paragraph 4 (3).

(C) Temporary Employees :

(i) All Temporary Employees of the Post and Telecommunications Department, who have completed 4 years' continuous and satisfactory service in the Department are allowed to take up this Examination provided they have passed the J. S. C. (Sinhala or Tamil or English).

(ii) All Temporary Employees in the Post and Telecommunications Department, with 1 year's continuous and satisfactory service in the Department are allowed to take up this examination provided they possess the educational qualifications stipulated in para. 4 (3) and are under 45 years of age on October 8, 1960.

(D) Sub-Postmasters :

(i) Sub-Postmasters who have completed 4 years' continuous and satisfactory service in the Department are allowed to take up this examination irrespective of age and educational qualifications.

(ii) Sub-Postmasters with 1 year's continuous and satisfactory service in the Department are allowed to take up this examination provided they possess the educational qualifications stipulated in para. 4 (3).

Note.—All employees taking up the examination in either the Sinhala or Tamil medium must offer the qualifying paper in Special English appearing as subject (7) under para. 14—Part I of the Scheme of Examination.

6. (1) Only employees in the Post and Telecommunications Department belonging to a Grade or Service the recruitment to which is controlled by the Postmaster-General are eligible for the concessions mentioned in para. 5 above.

(ii) Officers belonging to the Combined Services attached to this Department, Assistants and Substitutes to Sub-Postmasters and Substitutes to the Minor Grades, are NOT ELIGIBLE TO THE CONCESSIONS mentioned in para 5 above.

7. Salary and Conditions of Service—

(i) (a) During period of training Rs. 60 per mensem plus cost of living allowance.

(b) On appointment as Postmaster and Signaller, Class II, Rs. 960 per annum (1st year), Rs. 1,080 per annum (2nd year). Thereafter Rs. 1,260—120—Rs. 3,780 per annum with efficiency bars before Rs. 1,740 and Rs. 2,940.

(ii) Successful candidates will be required to undergo a course of training at the Post and Telegraph Training School and at a Post Office for a period of about six months not including vacations. The period of training may be extended or curtailed at the discretion of the Postmaster-General. Should circumstances necessitate it, the Department may arrange a shorter course of training initially. In this event, the detailed course of training will be arranged later, after appointment, as convenient to the Department. During the period of training candidates will be trained as Telegraphists, Tele-typists and Telephone Operators and also for Counter duties which involve cash transactions. The training will include procedure regarding the acceptance and delivery of phonograms and telegrams in Sinhala, Tamil and English including transliteration of Sinhala and Tamil telegrams. They will not be required to pay any fees or deposit. The allowance payable during the period of training will be subject to a proportionate deduction during vacations or absence from any cause whatever, but payment of the allowance is contingent on satisfactory behaviour and progress. Any candidate who does not satisfy the Postmaster-General as regards progress in his studies and good behaviour is liable to summary rejection at any time during the period of training and forfeiture of his allowance, and any candidate so rejected will, for the future, be ineligible for service in the Post and Telecommunications Department.

(iii) At the end of the period of tuition, candidates will be examined in the subjects in which they have been trained. Those who pass will be appointed to the Postmasters' and Signallers' Service as vacancies occur on probation for three years. Subject to the provisions of condition (iv) below, those candidates who are rejected at this examination will be ineligible for service in the Post and Telecommunication Department.

(iv) The Postmaster-General may, on the recommendation of the Superintendent of Telecommunication Traffic, permit a candidate in exceptional cases to remain at the School at his own expense for such period as may be considered desirable. Any such candidate will be specially examined at the close of that period.

(v) A candidate who resigns at his own request before completion of his entire course of instruction at the Post and Telegraph Training School shall be required to refund all allowances drawn by him while attending the School.

(vi) Candidates appointed to the Postmasters' and Signallers' Grade prior to the full course of six months training being given will at the time they are brought to the Post and Telegraph School for training, enter into a Bond and Agreement to the effect that in case they leave the Postmasters' and Signallers' Service during the first three years after the end of their period of training they will refund all moneys drawn by them during the period of training.

(vii) Candidates selected as Postmasters and Signallers will not be permitted to sit for any examination for entrance to any other Government Department or apply for, or accept an appointment in any other Government Department except as provided for under the Agreement.

(viii) Postmasters and Signallers are liable for duty on all days including Sundays and holidays. They will not be entitled to any additional remuneration for duty on holidays other than on Post Office Holidays. They are required to attend for periods of duty which may begin or end at any time of the day or night. They are liable for transfer and may be posted to any station in Ceylon.

(ix) Postmasters and Signallers are required to furnish security in a sum of Rs. 2,000. Security will be deducted in monthly instalments from the salary at Rs. 7.50 per mensem where the annual salary does not exceed Rs. 1,000 or Rs. 10 per mensem where the annual salary exceeds Rs. 1,000.

(x) The appointment will be subject to the Manual of Procedure, Public Service Commission Rules, the Financial Regulations, Departmental Orders and any other Rules and Regulations which may be issued from time to time by the Government.

(xi) Successful candidates will be required to pass a medical examination by a Government Medical Officer as to their physical fitness for service in any part of Ceylon. If a candidate is found medically unsuitable at this examination the provisional appointment will be cancelled.

(xii) The successful candidates will be required to comply with any rules already made or that may hereafter be made for giving effect to the Language Policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

(xiii) Candidates who take this examination in the English or the Tamil medium and who are selected for appointment should learn Sinhala during their probationary period. Confirmation of these candidates at the expiry of the probationary period will depend, among other things, on the passing of an examination in Sinhala.

(xiv) Those who fail to reach the prescribed standard of proficiency in Sinhala during their probationary period may not be discontinued if the Postmaster-General is satisfied that a genuine attempt has been made to study the Official Language. Loss of seniority may be waived at the discretion of the Postmaster-General if the probationer passes the test within a reasonable time thereafter.

#### 8. Applications—

(i) Applications for admission to the examination must be addressed to the Postmaster-General on forms which may be obtained from his office (P. M. G.'s Office, G. P. O., Colombo), up to September 30, 1960. Candidates should specify the medium in which they wish to sit for the examination, viz., Sinhala, Tamil or English, when they apply for forms.

(ii) Completed application forms must be sent by registered post to reach the Postmaster-General, G. P. O., Colombo, on or before October 8, 1960. Any application received after this date will be rejected. The name of the Examination "Postmasters' and Signallers' Examination", should be clearly written on the left-hand top corner of the envelope.

(iii) The application must bear duly cancelled stamps to the value of Rs. 15. (Officers already employed in the Department, i.e., those officers belonging to Grades and Services the recruitment to which is controlled by the Postmaster-General are exempted from the stamp fee.)

(iv) Candidates already employed in Government Departments must forward their applications through the Heads of their respective Departments. If any candidate fails to do so, he will be regarded as disqualified.

#### 9. Admission to the Examination—

(i) The Postmaster-General will issue admission forms to all candidates whose applications have been received. Candidates who present themselves for examination must produce to the officer appointed to supervise the examination their forms of admission. A candidate not producing such form will be refused admission to the examination.

(ii) Candidates must sit for the examination at the examination hall assigned to them. A candidate presenting himself at an examination hall other than the one assigned to him will be refused admission to the examination.

(iii) A copy of the Time Table and the Rules for candidates and directions to them for their guidance will be forwarded together with the Admission Form. Candidates will be bound by these rules. The decision of the Postmaster-General on any breach of the Rules will be final. Every candidate presenting himself for the examination must give up his admission form to the Supervisor on the day of the examination.

(iv) If a candidate does not receive his admission form at least seven days before the date of the examination, he should communicate without delay with the Postmaster-General informing him that he has not received the admission form and furnish the following information:—

- (a) Name of examination;
- (b) Full name;
- (c) Full postal address;
- (d) Post Office Registration number with date;
- (e) Centre selected for examination.

(v) Admission to the examination does not constitute acceptance of eligibility.

*Note.*—The Postmaster-General may, however, grant to a candidate provisional admission to the examination at his discretion. Such candidature will subsequently be either confirmed or cancelled.

#### 10. Identity Cards—

(i) Candidates will be required to prove their identity in the examination hall to the satisfaction of the Supervisor for each subject they offer. For this purpose any one of the following documents will be accepted:—

- (a) Identity Card issued by the Postmaster-General;
- (b) A valid passport issued not more than 3 years before the date of this examination;
- (c) Any certificate, licence or other document embodying a photograph of the holder and issued not more than 3 years before the date of this examination on the authority of a Government Department.

(ii) No candidate will be admitted to the examination hall without one of the documents referred to above in addition to his admission card.

#### 11. Documents of Eligibility—

(i) No documents whatever should be forwarded with the application form but the necessary particulars should be provided in the form as required. An application which is not complete in all respects will be judged on its own merits and may be rejected.

(ii) Documentary evidence in proof of eligibility will be required from candidates who have qualified. Such candidates should produce these documents at the viva voce test or forward them promptly under registered cover when called for by the Postmaster-General.

(iii) The following documents will be necessary:—

- (a) a certificate of good character signed by a responsible person;
- (b) a certified copy of the candidate's birth registration entry—(see note below):—

*Note.*—(i) The special certificate of birth issued for school or educational purposes or a certified extract from the birth registration entry will not be accepted.

(ii) Affidavits or baptismal certificates will not be accepted as substitutes for birth certificates.

(iii) If the name/names appearing in the birth certificate differs/differ from the name/names which the candidate ordinarily uses and under which the candidate enters for the examination, action should be taken immediately in terms of section 27 or 28 as the case may be of the Births and Deaths Registration Act, No. 17 of 1951, to get the name in the birth registration



entry amended. A certified copy of a birth registration entry effected more than one year after the date of the birth under section 24 (6) of the Births and Deaths Registration (Amendment) Act, No. 15 of 1953, will be accepted for purposes of making appointments only after consideration of the evidence by which the date of birth was established.

- (c) certificate of registration as a citizen of Ceylon or original official letter of acceptance of claim to citizenship by descent or registration (where applicable);
- (d) original certificate of educational qualification.

(iv) Candidates are warned to have all the documents in readiness at the time of application. Any candidate who is unable to produce the necessary documents at the viva voce test or who delays in producing them when called for by the Postmaster-General will have his entry rejected.

12. *Penalty for furnishing false particulars—*

(i) If a candidate is found to be ineligible according to the regulations for this examination, his candidature is liable to be cancelled at any stage prior to, during or after the examination.

(ii) If any of the particulars furnished by a candidate are found to be false within his knowledge or if he has wilfully suppressed any material fact or if it is proved at any time during the period of his service that he was ineligible to sit for the examination, he will be liable to immediate dismissal from the service.

13. *Refunds—*

(i) No refunds will be made under any circumstances.

(ii) Fees paid for this examination cannot be transferred to any other examination.

14. *Scheme of Examination.*—The subjects of the examination and the marks assigned to each subject are given below. In all written papers, marks will be deducted for bad writing and mistakes in spelling. Candidates whose writing is illegible are liable to be disqualified.
