#### GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE PUBLIC SERVICE ADVERTISED IN THE “CEYLON GOVERNMENT GAZETTE”

**1. Allowances.**—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

**2. Conditions of Service.**—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

**3. Terms of Engagement.**—(i) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay) appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute, at their option, a further 5 per cent. The Government contribution in either case will be equal to 7½ per cent. of the salary paid in at the close of each financial year.

(ii) Appointees may be required to furnish security in terms of the Public Officers (Security) Ordinance, if so required by the Head of their Department.

(iii) Appointees other than those already in the Public Service will be required to pass a medical examination by a Government Medical Officer as to their physical fitness to serve in any part of the Island.

**4. New Entrant Officers—**

(i) The period of probation/trial of “New Entrant Officers” appointed to pensionable posts/non-pensionable posts, as the case may be, shall be 3 years unless a longer period is prescribed in respect of any posts.

(ii) “New Entrant Officers” will be required to comply with any rules already made or that may hereafter be made for giving effect to the Language Policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

(iii) (a) These officers will be required to acquire proficiency in Sinhala during their period of probation/trial.

(b) Their confirmation, at the expiry of the period of probation/trial, will depend, *inter alia*, on the passing of a proficiency test in Sinhala.

Those who fail to reach the prescribed standard of proficiency in Sinhala during their period of probation/trial are liable to be discontinued, but discontinuance may be deferred if the appointing authority is satisfied that a genuine attempt had been made to acquire proficiency in the Official Language. Loss of seniority may be waived at the discretion of the appropriate authority if the officer passes the test within a reasonable time after the due date.

(iv) New Entrant Officers who qualify for entry into the Public Service through the Sinhala medium will be exempted from the Proficiency Test in Sinhala.

*Note.*—The term “New Entrant Officers” in this context means officers appointed to posts in the Public Service on or after September 24, 1956, who are not deemed to be old entrant officers in terms of sub-paragraphs 2 (ii) (b) and 2 (ii) (c) of Treasury Circular No. 379 of 23rd May, 1957.

**5. Qualifications required.**—Every applicant must furnish satisfactory proof that he is a Ceylonese. A “Ceylonese” is a citizen of Ceylon by descent or by registration.

**6. War Service Concession.**—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty’s Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service commencing from September 3, 1939, at the earliest, and up to December 31, 1949, at the latest, from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

**7. Other Requirements.**—(i) Applications from officers of the Public Service who are qualified must be forwarded through the Heads of their respective Departments. In the case of applications from officers holding permanent posts in the Public Service, the Heads of the Departments concerned should, in forwarding the applications, state whether or not they are prepared to release the applicants (if selected) in accordance with Administrative Regulation 109 of the Manual of Procedure.

(ii) Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.

(iii) Anyone desiring to recommend a candidate should do so by giving a testimonial. Any form of canvassing or attempt to influence the selection of a candidate will disqualify such candidate.

(iv) Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection, and to dismissal if discovered after the selection.

He also must have a sound knowledge of the construction of wooden and steel vessels, the maintenance of slipways and be conversant with all equipment associated with ship repairs.

III. Assistant Foremen (Motor Transport)—Every applicant must furnish proof that he—

- (a) has passed the J. S. C. or equivalent or higher examination;
- (b) has successfully completed at least 5 years' apprenticeship in a recognised Engineering Firm or Government Department and should have served at least 2 years in a supervisory capacity;
- (c) has at least 3 years' experience in the working repairs and maintenance of motor vehicles powered by petrol, and diesel engines;
- (d) has a thorough knowledge of the organisation of a large motor vehicle repair shop and be conversant with the most up-to-date testing equipment and all associated sub-sections of a vehicles repair organisation.

5. *Other qualifications required:*—Every applicant must also furnish proof that he—

- (a) is not less than 25 years and not more than 35 years of age on November 1, 1960;
- (b) is of good moral character and is physically sound.

(e) should be able to supervise and direct new construction work and correct maintenance of existing installations. ### CADETSHIPS IN THE CEYLON ARMY

APPLICATIONS are invited for four cadetships in the Ceylon Army. Upon selection the cadets will be sent to the Royal Military Academy at Sandhurst for training.

2. After successful completion of the period of training at Sandhurst, cadets will return to Ceylon and will be commissioned as officers in the commencing rank of Second Lieutenant in an arm of the Service of the Army suited to their aptitude as well as the needs of the Army. Officers will be expected to serve in the Army for a minimum period of ten years after commissioning. The prospects and conditions of pay and service for officers of the Army are as published in the *Government Gazette* and reproduced in the Press.

3. Applicants for cadetship must fulfil the following conditions :—

- (a) *Nationality*—Candidates must be citizens of Ceylon.
- (b) *Age*—Candidates must be not less than 19 years and not more than 21 years of age on 7th October, 1960.
- (c) *Education*—Candidates should have obtained the Senior School Certificate at the ordinary level of the General Certificate of Education Examination (English medium). Subject to general suitability, preference will be given to candidates who have passed the examination with credits in English, Physics and Mathematics.
- (d) *Status*—A candidate must be unmarried. No cadet will be permitted to marry while at the Royal Military Academy, Sandhurst.
- (e) *Medical standard*—A candidate must conform to the required medical standard. All candidates selected for final interview by the Selection Board will be medically examined under Ceylon Army arrangements at the time of the interview.

4. Application for cadetships should be submitted in writing in the terms of the form given in paragraph 9 below and should be forwarded to Army Headquarters, P. O. Box 553, Colombo, so as to reach there not later than 7th October, 1960. The envelope enclosing the application should be marked "APPLICATION FOR ARMY CADETS".

5. Applications should be accompanied by two certificates of character, one of which should be from a responsible person of mature age who has known the applicant for the previous one year in private life. The other should be from the Principal of the last school attended by the applicant.

6. All applicants who fulfil the above conditions will be required to answer a written test in the following subjects :—Essay, General Knowledge, and Mathematics. A preliminary selection will then be made from amongst those candidates who qualify at the written examination, and a final selection will be made after interview of these selected candidates by a Selection Board appointed by the Minister of Defence. Candidates selected for interview by the Selection Board will be informed in writing of the place, time and date of such interview. The interviews will take place in Colombo. No travelling or other expenses will be paid by the Ceylon Government in this respect. Candidates not selected for interview by the Selection Board will be so informed.

7. The following procedure and rules will apply in respect of candidates selected for vacancies :—

- (a) Candidates will be enlisted as Army Cadets on a normal regular engagement for a period of five years with the Colours and seven years with the Reserve.
- (b) On enlistment candidates will be required to undergo such training in Ceylon as may be prescribed by the Commander of the Army.
- (c) On successful completion of the training in Ceylon, cadets will be sent at Government expense to the United Kingdom, and be admitted to the Royal Military Academy, Sandhurst, for a course of training lasting 23 months.
- (d) During the period of training at Sandhurst all tuition and maintenance fees will be paid by the Ceylon Government. The status of cadets during this period will be that of other ranks and cadets will be subject to Military Law. Their basic rate of pay while under training in the United Kingdom will be 8 shillings per day at the commencement of their training, and 11 shillings per day on completion of 12 months training. No cost of living allowance is

payable. All expenses, such as pocket money, maintenance during compulsory leave periods between terms at Sandhurst, the cost of civilian clothes which may be worn when off duty, &c., will be the responsibility of the parents or guardians of the individual cadet. Such expenses should be about Rs. 2,000 per annum for the period during which the cadet is away from Ceylon. Cadets will also be entitled to approximately £1—0s—10d per diem as holiday allowance during compulsory leave periods (i.e., period of non-attachment to a Mess).

- (e) (i) In the event of a cadet voluntarily terminating his candidature for a commission during his course at Sandhurst, the parent or guardian will be required to refund to the Ceylon Government all expenses incurred up to that time by the Ceylon Government on the cadet's account. The cadet will also be required to return to Ceylon at his own expense.

#### KANTALAI SUGAR PLANTATIONS—DEPARTMENT OF AGRICULTURE

##### Cutting and Loading Sugar-Cane at "Piece-Work" Rates

CO-OPERATIVE Societies, Rural Development Societies, Colonists and any other persons who can muster groups of more than twenty workers are offered the above mentioned work at the following rates:—

- Rs. 7 per metric ton for groups of colonists who are provided daily transport up to 20 miles along the main road;
- Rs. 7.50 per metric ton for groups of colonists who are provided daily transport up to 10 miles along the main road;
- Rs. 7.50 per metric ton for groups of outstation workers who are provided with travelling to and from their villages and temporary accommodation at the worksite;
- Rs. 8 per metric ton for those groups of workers who are not given any of the above facilities.

2. The work should be carried out according to the following specification:—

- Stripping the cane stalks free of adhering leaves.
- Cutting the cane stalks at ground level.
- Lopping-off the green tops of the cane stalks.
- Loading the harvested cane stalks into trailers free of soil, stones or other foreign material.



3. The sugar-cane stalks should be loaded into 5-ton trailers in an orderly manner to provide a stable load suitable for transport to the Factory where they will be weighed to determine the tonnage harvested by each group. This arrangement does not permit the assessment of the performances of individual workers and therefore the acceptance of offers can be received only from groups of workers.

4. The leader of each group will be required to enter into an agreement to execute the work as specified, to the satisfaction of the General Manager, Sugar Plantations, Kantalai, or his representative. Payments will be made daily on the day after the loaded trailers are weighed at the Factory Weighbridge. The sugar-cane should be harvested in such a manner that it could be loaded whenever empty trailers are brought into the field. The leader of each group will be provided with one cane-cutting knife in respect of each worker in his group. He will be required to return these knives in reasonably good condition when the work is completed and pay Rs. 4 for each knife that he is not able to return.

Groups of outstation workers will be paid in addition to "piece-work" rates a sum of Rs. 7 per worker per week in respect of the number of workers in that group who have worked regularly for seven days in that week, provided the weekly output of that group has been satisfactory. If their harvesting work has to be temporarily stopped on account of adverse weather conditions, other work will be given to them at Wages Board rates applicable to casual labour, only in respect of those who have worked in the field, regularly. Any worker or groups of workers who terminate their harvesting for any reason will be required to vacate their dormitories within 24 hours.

6. This harvesting work is already in progress and about one thousand more workers will be required to complete the work in three weeks.
