 Abstract.—This invention relates to the reconditioning of closures for steel barrels and drums and to methods for effecting same.

A reconditioning collar for steel drum closures, said closures being formed with an upstanding neck formed out of the container wall stock and a closure flange having a cylindrical portion within said neck, said flange having a portion beaded over the upper end of said container wall neck and having a laterally extending base portion, at the other end of said cylindrical portion, said base portion securing a gasket between the same and the inner surface of the container wall stock at the base of the neck, said reconditioning collar being characterized by a cylindrical skirt portion (15) and an integral inwardly beaded rim portion (16) at the upper end of the said skirt portion, said bead portion (16) being formed for mated engagement with the beaded over portion of said closure flange and said skirt portion (15) formed to extend downwardly past said bead in opposition to said container wall neck spaced outwardly therefrom and for a substantial portion of the height thereof, said reconditioning collar being formed of light weight sheet steel of substantially less thickness than the thickness of said container wall stock.

A process for the preparation of a colourless or substantially colourless light hydrocarbon oil freed or substantially freed from mercaptans by treating a light hydrocarbon oil containing mercaptans, in the presence of oxygen, with an aqueous alkali metal hydroxide solution, characterised by the use of an aqueous alkali metal hydroxide solution containing a combination of a formic acid salt as solutizer to increase the extractive power for the mercaptans and an auxiliary substance for promoting the solvent power for oxygen.

According to the invention the machine for extracting juices and soluble constituents from vegetable matter comprises a chamber having means at one end for compacting, squeezing and ejecting material fed in at other end thereof, means for supplying solvent to the chamber adjacent the point at which the materials enter the said compacting, squeezing, ejecting means and outlet for said solvent nearer to the end of the chamber into which the material is fed.

An antibiotic substance herein designated spiramycin which is a nitrogenous base, and its acid addition salts, the base having the following properties: a molecular weight between (400)n and (450)n, n being equal to 2, a laevorotatory activity in alcoholic solution ($[\alpha]_D^{20} = -70$ to -75° (c=2% in ethanol)).

the composition approximating as follows:—

Carbon : 60 to 61%
Hydrogen : 8.9 to 9.4%
Oxygen : 25.5 to 27%
Nitrogen : 3.3 to 3.6%

its ultraviolet absorption spectrum in alcoholic solution (E_{1cm}^{1%} being about 346) showing a peak at 231mμ.

4. The process for the production of spiramycin consisting in aerobic cultivation of *Streptomyces ambofaciens* NRRL 2420 or a mutant thereof in a medium containing assimilable sources of carbon, nitrogen and mineral salts until substantial antibiotic activity is produced by the said microorganism in the said culture medium and recovering the spiramycin from the said culture medium.

Apparatus for filling a container of unknown weight with a predetermined weight of material, comprising a weight supporting device, a pivotable weigh bar, means for pivoting the weigh bar in dependence upon weight supported by the weight supporting device, a control member pivotable between a rest position and a limiting position the range of pivotal movement being related to said predetermined weight of material, locking means operable to block the control member to the weigh bar at any pivotable position of the latter for movement therewith, and means for controlling flow of said material into the container operable when the control member reaches said limiting position to prevent further flow of material into the container; whereby, when an unfilled container is supported by the weight supporting device, the weigh bar may take up an initial position and thereafter may be locked to the control member to ensure that only said predetermined weight of material flows into the container.
