- (b) Rent : Rs. 20 per annum ;
- (c) The lessee shall, within one year from the commencement of the lease, and in accordance with specifications previously approved by the A. C., C. D., Polonnaruwa, construct a paddy store and tobacco barns on the land.
- (d) The lessee shall use the land as a site for a paddy store and tobacco barns, but for no other purpose.

3. The lease will be granted unless valid reasons to the contrary are adduced in writing to me within six weeks from the date hereof.
