The Local Authority will contribute 3 per cent. of salary.

(d) Appointees may be required to furnish security either in cash or by Fidelity Guarantee Bond through a Guarantee Association approved by the Local Government Service Commission in a sum which may be decided upon by the Local Authority.

(a) The pension rights of officers serving under Government will be conserved if released under section 21 of the Government Minutes on Pensions, and transferred to pensionable posts in the Local Government Service.

(b) In the case of employees of Local Authorities who hold pensionable posts under the Pension By-laws or Rules of the Local Authorities, the Payment of their pension on ultimate retirement will be governed by the Pension By-laws or Rules of the Local Authority in whose employ they were on the date immediately

(e) Appointees not holding scheduled posts in the Local Government Service will be required to pass a medical examination by a duly qualified medical practitioner as to their physical fitness to serve in any part of the Island.

(f) The appointment will generally be on probation or subject to confirmation after a period of two years unless otherwise specified.

The Accounts of the Urban Council, Matale, for the year 1959, as furnished by the Chairman of the Council, have been audited under my direction.

2. The previous approval of the Commissioner of Local Government has not been obtained for the assignment to each of the posts of the three Electrical Apprentices of salaries and allowances which in the aggregate exceeded Rs. 100 per mensem. The payments made to the apprentices have, therefore, not been passed in audit and are under correspondence with the Chairman. were not entered in the register of materials as required by the Financial Rules nor certified by the technical officer of the Council as belonging to the class and quality recommended by him. A further sum of Rs. $7,277\cdot50$ paid for the construction of drains has also not been passed in audit as the work was done without preparing site plans showing cross sections, etc., in the absence of which no check on the satisfactory execution of the work was possible. An opportunity has been afforded to the Chairman to obtain the sanction of the Minister to enable both payments totalling Rs. 13,170.35 to be passed in audit.

4. The expenditure during the year includes payments of travelling allowances in respect of journeys performed by the Chairman to the office of the Council and the Minister has refused to sanction this expenditure. As the Chairman is since dead, no surcharge action is possible.

5. The expenditure for the year exceeded the revenue by Rs. 21,541.42 and this resulted in the deficit which stood at Rs. 8,026.22 being increased to Rs. 29,567.64 at the end of the year.

6. Subject to the above observations I am of opinion that the Statement of Assets and Liabilities gives a true and fair view of the state of affairs of the Urban Council, Matale, as at December 31, 1959.

3. The expenditure during the year includes payments totalling Rs. 5,892.85 which have not been passed in audit. These payments represent cost of purchase of G. I. pipes, which




