THE HEALTH SERVICES STATUTE

A Statute to provide for the establishment of a Northern Province Department of Health Services, to provide for the continuation of services for the promotion and preservation of the health of the people in the Northern Province ; and to provide for all the matters connected therewith and incidental thereto.

This Statute is inconsistent with the Health Service Act, No. 12 of 1952 as amended.

Be it enacted by the Provincial Council of the Northern Province as follows :-

1. This Statute may be cited as the Northern Province Health Services Statute, No. 1 of 2015, and shall come into force on the date on which it receives the assent of the Governor.

PART I

ESTABLISHMENT OF THE NORTHERN PROVINCE DEPARTMENT OF HEALTH SERVICES, ITS CONSTITUTION AND RESPONSIBILITIES

Establishment of Northern Province, Department of Health Services

- 2 (1) There shall be a Northern Province Department of Health Services (hereinafter referred to as "the Department") which shall be administered in accordance with the provisions of this Statute.
- (2) The appointment, transfer, dismissal and disciplinary control of officers of the Department (other than officers in an All-island Service seconded for service in the Department) shall vest in the Governor in terms of Part IV of the Provincial Councils Act, No. 42 of 1987.

The functions of the Northern Province Department of Health Services

- 3 The functions of the Department shall be -
- a) to establish, administer and maintain Health institutions set out hereinafter in the Schedule to this Statute, and to promote the improvement of the services provided by them ;
- b) to establish and maintain institutions set out hereinafter in the Schedule to this Statute as required for the provision of services relating to public health, educating the public on health issues, nutrition, family health maternity and child care, food and food sanitation and environmental health ;
- c) to implement the Provincial Health Development Plan and the Annual Health Plan for the Province ;
- d) to provide all facilities (other than drugs) to the hospitals and institutions referred to in sub-paragraphs (a) and (b) ;
- e) to identify the staff and other servants required for the efficient discharge of services to be provided by the hospitals institutions referred to in sub-paragraphs (a) and (b) and to make recommendations in respect of such requirements to the relevant authorities ;
- f) to provide capacity improvement programmes for all categories of staff of the Department ; and
- g) generally to do all such other things as are necessary to facilitate the proper discharge of the functions of the Department.

Provincial Director of Health Services

- 4 1. There shall be a Provincial Director of Health Services (hereinafter referred to as "the Provincial Director") who shall be the head of the Northern Province Department of Health Services and shall, subject to the direction and supervision of the Secretary, implement the provisions of this Statute.
2. There shall be appointed a Deputy Provincial Director of Health Services (hereinafter referred to as "the Deputy Provincial Director - Health Services") and a Deputy Provincial Director of Administration (hereinafter referred to as "the Deputy Provincial Director - Administration"), who shall assist the Provincial Director in the discharge of his functions, duties and responsibilities.

Regional Directors of Health Services

- 5 1. There shall be five Regional Directors of Health Services appointed respectively, for the districts of Jaffna, Kilinochchi, Mullaitivu, Vavuniya and Mannar.

2. Subject of the direction and supervision of the Provincial Director, the Regional Directors of Health Services shall be responsible for the provision of health services in their respective districts.
- 6 1. The Provincial Director shall facilities the preparation of the Annual Health Plan for the succeeding year, taking into consideration the following in respect of the Province. Annual Health Plan
- a) the increase of population in relation to the extent of land ;
 - b) the spread of disease ;
 - c) the nutritional condition of the people ;
 - d) the impact of the environment on health ; and
 - e) transport facilities available.
- The Plan shall give a description of the development and construction activities proposed to be undertaken during the succeeding year.
2. The Provincial Director shall submit the Annual Health Plan to the Secretary who shall then place it before the Provincial Health Services Advisory Board for its observations, The Secretary shall consider incorporating any observations of the Provincial Health Services Advisory Board which in his opinion facilitate the provision of health services in the Province and approve the Plan, before the thirtieth day of November of the year preceding the year to which the Annual Health Plan relates. Then the Secretary will submit the Annual Health Plan to the Board of Ministers through the Minister of Health for the approval of the Board of Ministers.
3. Any development or construction activity which is not referred to in the Annual health Plan for a particular year shall not be undertaken in that year, except with the approval of the Board of Ministers.
- 7 The Provincial Director shall submit to the Secretary, before the end of the first quarter of every year, a report with regard to the state of public health in the Province in the preceding year. The report shall identify, with statistics, the successes and the weaknesses in implementing the Annual Health Development Plan during the preceding year, and recommend measures to correct any weakness identified. Annual Report relating to the condition of Health in the Province
- 8 The Provincial Director may, by notice in writing, request the Secretary or the Commissioner, as the case may be, of any local authority in the Northern Province to provide necessary particulars and information with regard to health conditions within the respective administrative limits. The Secretary or Commissioner, as the case may be, shall assist the Provincial Director by providing the relevant information. Health activities within the local authority areas
- 9 1. The Minister may make regulations in respect of any matter required by this Statute to be prescribed or in respect of which regulations are authorized or required by this Statute to be made. The powers of the Minister to make regulations
2. Every regulation made under this section shall be published in the *Gazette* and shall come into operation on the date of such publication or on such later date as may be specified in such regulation.
3. Every regulation made by the Minister shall, before the expiration of one month after its publication in the *Gazette*, be brought before the Provincial Council for its approval, Every regulation which is not so approved shall be deemed to be rescinded as from the date of such disapproval but without prejudice to anything previously done there under. Notification of the date on which any regulation is deemed to be rescinded shall be published in the *Gazette*.

PART II

PROVINCIAL HEALTH SERVICES ADVISORY BOARD AND HOSPITAL DEVELOPMENT COMMITTEE

Provincial Health Services Advisory Board

- 10 1. There shall be established a Provincial Health Services Advisory Board (hereinafter referred to as "the Advisory Board")
2. The Advisory Board shall be appointed by the Minister and shall consist of not more than Nineteen (19) members appointed in the following manner.
- a. ex-officio members, namely -
- i. the Provincial Director of Health Services ;
 - ii. the Provincial Director of Education ;
 - iii. the Provincial Commissioner of Local Government ;
 - iv. the Provincial Director of Social Services ;
 - v. the Provincial Commissioner of Indigenous Medicine ;
 - vi. every Regional Director of Health Services in-charge of a district ; and
- b. the following members who shall be known as "appointed members" -
- i. four members from amongst medical practitioners working in the hospitals and institutions referred to in sub-paragraphs (a) and (b) of Section 3, and specializing respectively, in Community Medicine, General Medicine, Obstetrics and Paediatrics ;
 - ii. five members from amongst persons with at least ten (10) years of experience in the fields of Health and Social Services to represent Jaffna, Kilinochchi, Mullaitivu, Vanuniya and Mannar districts respectively
3. No person shall be qualified to be appointed or continue as a member of the Advisory Board if -
- a) he is not a citizen of Sri Lanka ;
 - b) he has not attained the age of eighteen years ;
 - c) he is or becomes a Member of Parliament, any Provincial Council or any Local Authority ;
 - d) he has been declared an undischarged bankrupt or insolvent under any law in force in Sri Lanka or any other country.
 - e) he is under any law in force in Sri Lanka or any other country found or declared to be of unsound mind ;
 - f) he is convicted of any offence involving moral turpitude or punishable with imprisonment for a term not less than six months.
 - g) he is serving or has served a sentence of imprisonment imposed by a court of law in Sri Lanka or any other country ; or
 - h) he has any financial or other interest as is likely to affect the discharge of his functions as a member of the Advisory Board.
4. The Provincial Director shall be the Chairman of the Advisory Board and the Secretary of the Advisory Board shall be elected from amongst the ex-officio members of the Advisory Board.
5. The terms of office of every ex-officio member shall be the period during which he holds the post by virtue of which he is a member of the Advisory Board.

6. Each members has rights to cast one vote. in case of tie, the Chairman has the right to exercise his casting vote.

7. An appointed member may resign from office by letter addressed to the Minister.
 8. The Minister may, for reasons assigned, remove and appointed member from office.
 9. Subject to sub-sections (7) and (8), the term of office of an appointed member shall be two years.
 10. An appointed member, who ceases to hold office by effluxion of time, shall be eligible for reappointment.
 11. Where an appointed member vacates, office by resignation, death, removal by the Minister or otherwise, the Minister shall, having regard to the provisions of sub-paragraph (b) of sub-section 2, appoint another person to fill such vacancy. The person so appointed shall hold office for the unexpired period of the term of office of the member whom he succeeds.
 12. The Advisory Board shall meet at least once in three months or whenever necessary.
 13. The Secretary shall summon meetings of the Advisory Board, and shall maintain minutes of the meetings of Advisory Board.
 14. The quorum for a meeting of the Advisory Board shall be eleven (11), including the Chairman.
 15. Members who attend meetings of the Advisory Board shall be paid allowances of such amount as may be determined by the Minister in consultation with the Minister in-charge of the subject of Finance and with the concurrence of the Governor.
- 11 The functions of the Advisory Board shall be to make recommendations and observations to the Minister on matters referred to it by the Minister for the planning and provision of health services in the Province, the improvement of the services provided by the Department and generally, for the promotion and preservation of the health of the people in the Province. Functions of the Advisory Board
- 12 1. The Secretary shall, with the approval of the Minister, appoint for every hospital and institution set out in sub-paragraphs (a) and (b) of section 3 a Development Committee for the development of such institution. Development Committee
2. Every Development Committee appointed, under sub-section (1) shall consist of -
 - a) ex-officio members, namely -
 - i. the Medical Officer in-charge of that hospital or institutions ;
 - ii. the Divisional Secretary of the Division within which that institution is situated ;
 - iii. A representative of the Buildings Department not below the rank of Technical Officer ;
 - iv. the Secretary or Commissioner, as the case may be, of every local authority within the administrative limits of which that institution is situated ; and

- b) the following members who shall be known as “appointed members”
- i. four representatives of the staff of that institution ;
 - ii. not more than six persons from amongst persons engaged in health and social service activities in the area within which that institution is situated.
3. No person shall be qualified to be appointed or continue as a member of a Development Committee if -
- a) he is not a citizen of Sri Lanka ;
 - b) he has not attained the age of eighteen years ;
 - c) he is or becomes a Member of Parliament, any Provincial Council or any Local Authority ;
 - d) he has been declared an undischarged bankrupt or insolvent under any law in force in Sri Lanka or any other country ;
 - e) he is under any law in force in Sri Lanka or any other country found or declared to be of unsound mind ;
 - f) he is convicted of any offence involving moral turpitude or punishment with imprisonment for a term not less than six months.
 - g) he is serving or has served a sentence of imprisonment imposed by a court of law in Sri Lanka or any other country ; or
 - h) he has any financial or other interest as it likely to affect the discharge or his functions as a member of the Advisory Board.
4. The term of office of every ex-officio member shall be the period during which he holds the post by virtue of which he is a member of the Committee.
5. Each member has rights to cast one vote. In case of tie, the Chairman has the right to exercise his casting vote.
6. An appointed member may resign from office by letter addressed to the Secretary.
7. The Secretary may, for reasons assigned and subject to the approval of the Minister, remove an appointed member from office.
8. Subject to sub-sections (6) and (7), the term of office of an appointed member shall be two years.
9. An appointed member, who ceases to hold office by effluxion of time, shall be eligible for reappointment.
10. Where an appointed member vacates office by resignation, death, removal by the Secretary or otherwise, the Secretary shall, having regard to the provisions of sub-paragraph (b) of sub-section 2, appoint another person to fill such vacancy. The person so appointed shall hold office for the unexpired period of the term of office of the member whom he succeeds.
11. The Medical Officer referred to in sub-paragraph (a) of sub-section 2 shall be the Chairman of the Development Committee appointed for that institution. A person elected by the members shall be the Secretary of the Development Committee. The Secretary shall maintain minutes of the meetings of the Committee.

12. Every Development Committee appointed for a particular institution may, subject to the approval of the Secretary, take measures for the development and rehabilitation of that institution.
13. A Development Committee appointed for a Hospital prior to the coming into force of this Statute shall, for all purposes, be deemed to be a Committee appointed under this Statute. Members of such Committee shall continue to hold office as members of a Hospital Development Committee appointed in accordance with the provisions of this Statute until a new committee is appointed in accordance with the provisions of sub-section 1.

PART III - GENERAL

13. Subject to the national policy on health, all services provided in the Hospitals and institutions referred to in sub-paragraphs (a) and (b) of section 3 shall be provided without any charge. Free Health Services
- 14 In case of any inconsistency between the Tamil and the Sinhala or English text of this statute, the Tamil text shall prevail. Language Inconsistency
- 15 In this Statute unless the context otherwise requires - Interpretation

“Department” means the Northern Province Department of Health Services ;

“Local authority” means a Municipal Council, Urban Council or Pradeshiya Sabha in the Northern Province ;

“Governor” means the Governor of the Northern Province ;

“Medical practitioner” means a person registered as a medical practitioner under the Medical Ordinance.

“Minister” means the Minister of the Board of Ministers of the Northern Province, in-charge of the subject of health ;

“Province” means the Northern Province consisting of the administrative District of Jaffna, Kilinochchi, Mannar, Vanuniya and Mullaitivu ;

“Provincial Director of Health Services” means the Director of the Northern Province Department of Health Services ;

“Secretary” means the Secretary to the Ministry of the Minister of the Board of Ministers of the Northern Province, in-charge of the subject of health.
