Local manufacturers cheated

Industries Minister Wimal Weerawansa has urged President Gotabaya Rajapaksa to ensure that local suppliers are given priority in matters of procurement and purchases by the State authorities. Though this is a *sine qua non* and is guaranteed under the law in the State procurement guidelines, the fact is that various State bodies have found loopholes to somehow circumvent these provisions.

This should not happen but the existence of these loopholes is owed mostly to the fact that there is connivance by officialdom. Those in high positions in many Government institutions have been in connivance with foreign companies to flout the guidelines that generally call for priority to be given to local suppliers.

One way that compliance could be ensured is to tighten the existing laws. The entire rule book has to be rewritten in other words. There should be penalties for the senior Government officials who help any foreign companies that are not licensed in the country, for instance, to secure local procurements.

It is obvious that these State appointed officials are well 'looked after' by some foreign companies that operate here. Even when there are Court orders these have been flouted in certain instances just so that companies that operate from overseas with dubious credentials can get the lucrative contracts.

It is shocking that this type of corruption exists when we as a country can least afford it. But officials in the pay are too greedy and too involved with their foreign paymasters to care about the country's foreign exchange problems, and the need to support the local entrepreneurs.

The State cannot ask the citizens of the country to 'Buy Sri Lankan' if the national corporate entities do not abide by the call themselves. But this seems to be the norm — the citizens are expected to contribute their mite, but the State bureaucracy that is supposed to work for the people hold themselves to a different standard.

Our foreign reserves have been stretched to a point at which even car spare parts are not available, and this has according to the exporters association for automobiles led to an unhealthy situation of non-roadworthy vehicles plying the streets. The Government has however revisited these laws and ensured that only the most non-essential items are restricted when it comes to car maintenance and the automobile import business.

But the penchant among the State bureaucracy to exclude local suppliers even in the backdrop of all these dire circumstances is not just disturbing — it is almost an act of treachery in the light of the broader reality.

It is why there should be a zero-tolerance policy for those who flout State procurement guidelines with impunity. A State oversight body must ensure that there is compliance with the rules at all levels of the State apparatus, including law enforcement.

It has come to a point where the enforcers are also in tacit connivance at least with the unscrupulous elements that flout the procurement guidelines that ensure support for the local manufacturers.

National oversight bodies that already exist today are largely toothless. They may make recommendations but at some other level, there are unscrupulous elements that use another arm of the State machinery to sabotage the intent of the oversight bodies.

When the entire apparatus is hijacked in this way the only means by which local entrepreneurship could be supported under the circumstances is to undertake an overhaul of the entire system of procurement and procurement-oversight.

Even if it requires the input of international expertise, there should be a reappraisal of what ought to be done to recalibrate the workings of the procurement system. There have been several procurement guidelines issued in the past few decades that have lulled the policymakers into a state of complacency.

They think that if the rules are there in the rule book, they must be naturally being followed by and large with a few exceptions. But the rule and not the exception has been that the guidelines are regularly flouted.

The powers that be that are able to alter this reality have to be alert to this situation as a first measure. They must undertake a study of the number of instances in which procurement guidelines have been blatantly observed in the breach, just so that a foreign supplier with some dubious local connections gets precedence over the local manufacturers and service providers.

As things stand, local manufacturers lose faith in the system and quickly wind up operations when they feel that nobody looks after their interests. Then, we complain that there is a drain on our foreign exchange reserves. The State bureaucracy is largely to blame for this situation. People have been conditioned to believe that politicians are corrupt across the board, but very often the bureaucrats outdo the politicians in the area of financial

irregularity and bribery.

When law enforcement also gets in on the act, the situation becomes hopeless. The only answer is for the people to order a 'reset' and that can be done through the agency of policymakers and politicians, and nobody else. Change is called for sooner rather than later.





week is connected to the latest method used by drug addicts to snatch money from all types of vehicle owners, especially car owners. This is the tactic they use. Maybe you have already become one of their victims or you will become one of their victims soon if you are not aware of what they do.

The drug addicts get hold of a three wheeler and organise another two or three drug addicts. They somehow manage to hit your car and get the paint of their three wheeler on the backside or front of your car. It depends on whether they hit the backside or front of your car. Then they stop your car by force and threaten you demanding Rs. 2,000, Rs. 2,500 or something. By this time two or three of their supporting drug addicts enter the scene created by one of them. By the time you will not notice how they arrive all of a sudden from nowhere without anyone apparently informing them.

When you say you want to go to the nearest Police station, they try to prevent that and may reduce the amount of money they demand from you. Maybe they will give up, scold you and leave when you assure them that first of all you need to go to the Police to settle the issue.

Sometimes they hit your vehicle when you park your vehicle inside the parking area of a large supermarket or a similar place. They make sure that the paint of their three wheeler is on your car front or rear bumpers or some other corner.
