



of these attacks would be done by any such party. Therefore, we would definitely take to the streets

against all those groups," he added. These comments came after Sirisena's recent meeting with several MPs at which certain MPs representing the main Parliamentary Opposition Samagi Jana Balawegaya (SJB) also attended.

Sri Lanka makes its first debt default

The Sri Lankan Government yesterday (12) announced that it is suspending debt servicing of selected debts, amidst what is considered the worst economic crisis the country has ever endured.

With international media reports having mentioned that it is only a matter of time as to whether Sri Lanka will default right before its upcoming International Sovereign Bond (ISB) payment in July or even earlier, the Ministry of Finance, via a five-page release, stated that the suspension is for an interim period, "pending an orderly and consensual restructuring of these debt obligations in a manner consistent with an economic adjustment programme supported by the International Monetary Fund (IMF)".

Several hospitals running out of drugs, surgical consumables

espite the State Ministry of Production, Supply, and Regulation of Pharmaceuticals having claimed that all pharmaceutical drugs are being received in manageable quantities, several hospitals are running out of many drugs

and surgical consumable items, *The Morning* learnt.

According to several hospitals, many drugs and surgical consumable items have been identified to be in deficit or not available at all. Sources also said that

several surgical consumable items such as the urethral

catheter (14, 16 and 18 g), 10 cm³ syringes, glucose drips, dialysers, close-wound suction bottles, and respirometers are either in deficit or unavailable at hospitals, adding that they are now in the process of gathering information and preparing a list of such.

Sabry said the Sri Lankan delegation is expected to engage in discussions with the International Monetary Fund (IMF) from 18-23 April, adding that many rounds of talks with the IMF, World Bank, Asian Development Bank, and representatives of foreign countries are also expected in the future.

CEB awaits \$ 34.6 mn to pay for coal shipments

CBSL yet to disburse sum; torn between medicines and fuel as priority

he Ceylon Electricity Board (CEB) is yet to receive \$ 34.6 million that is required to pay for two coal shipments to be used to power the Norochcholai Coal Power Plant, as the Central Bank of Sri Lanka (CBSL) is struggling to prioritise between payments for medicines and fuel.

Official sources at the Ministry of Power told The Morning on 11 April that they have informed the relevant authorities, including the CBSL, that \$ 34.6 million is needed to open letters of credit so that the two coal shipments can be unloaded before the expected monsoon begins at the end of April.

"However, we have been

informed that the CBSL is trying to prioritise money for a number of things at the moment, especially medicine. We cannot expect them to prioritise coal before medicine," they added.

The country imports the required coal shipments until August before the monsoon begins in April. The next batch of coal imports begin



again in October. With hydropower reserves

declining to record low levels and only picking up very recently, and

the CEB increasingly being unable to obtain fuel for thermal power plants due to the US dollar crisis hampering fuel imports by the Ceylon Petroleum Corporation, the Norochcholai Coal Power Plant has been adding a valuable 900 megawatts of power to the national grid.

Fuel shortages have severely impacted the country's electricity generation, as thermal power plants have faced routine shutdowns due to a lack of fuel. As a result of this, the Sri Lankan public has been forced to endure lengthy power cuts, sometimes lasting even up to 13 hours per day.

In what may have been the largest crowd witnessed at a protest not organised by a political party or a trade union in recent decades in Sri Lanka, tens of thousands of people converged on Galle Face and its surrounding areas on Saturday (9) to demand the resignation of President Gotabaya Rajapaksa, increasing the pressure on the Government and the President himself.

Estimates of the attendance ranged from 100.000 to over 500,000, although no official count is available. The protestors were seen still standing outside the Presidential Secretariat yesterday (12), having commenced the protest on Saturday (9) morning. As the day went on, the protestors who had left returned to the site to boost the

Protestors have vowed to continue their protests until their demands are met. However, Chief Government Whip Johnston Fernando stated in Parliament that the President would not be resigning under any circumstances.

Several...

Among the drugs that are in deficit or unavailable at hospitals are: Filgrastim (medication used to treat low neutrophil count), Paclitaxel (a chemotherapy medication used to treat a number of types of cancer), Anastrozole (used to treat early hormone receptor-positive breast cancer), Imatinib (a type of cancer-growth blocker), Capecitabine (a chemotherapy medication used to treat breast cancer, gastric cancer, and colorectal cancer), Chlorambucil (an anti-cancer chemotherapy drug), Melphalan (a chemotherapy medication), Doxorubicin Hydrochloride (an anti-cancer medicine), Cytarabine (a chemotherapy medication), Etoposide (a chemotherapy medication), Leucovorin (medication is used to treat or prevent serious blood cell disorders caused by certain drugs), Procarbazine (a chemotherapy medication), Irinotecan (a medication used to treat colon cancer and small cell lung cancer), Azathioprine (an immunosuppressive medication), Rituximab (used to treat certain types of cancer), Exemestane (a medication used to treat breast cancer), Abiraterone (a medication used to treat prostate cancer), Mercaptopurine (a medication used for cancer and autoimmune diseases), Goserelin (a medication which is used to suppress the production of the sex hormones, particularly in the treatment of breast and prostate cancer), Lenalidomide (used to treat various types of cancers), Megestrol (medication is used to treat cancer of the breast or uterus) and Sorafenib (used to treat kidney, liver, and

thyroid cancer). However, claiming that several parties are attempting to agitate the public for personal gain by publicising that there is a shortage of pharmaceutical drugs in the country, State

Ministry Secretary Dr. S.K. Rathnayake said on 7 April that all drugs are being received in manageable quantities. He said: "Certain groups are currently

staging a drama saying that there is a shortage of pharmaceutical drugs. They do this for various personal gains. There is no shortage of drugs as such. Even with a delay of a week or two due to issues caused by the prevailing US dollar deficit, all the drugs are being received in manageable quantities.'

He said that there was a shortage of 10 life-saving drugs in the last few days, adding however that nine of them are now available in the country in required quantities while the other is still in short supply. He added that other stocks of drugs are sometimes depleted due to issues in issuing letters of credit, but noted that new stocks continue to

Meanwhile, the Government Medical Officers' Association (GMOA) staged a protest in front of the Health Ministry on 6 April, demanding that the Government immediately address the shortage of essential pharmaceutical drugs in the country and provide the necessary financial allocations for the health services on time.

Speaking to the media on the day, GMOA General Secretary Dr. Senal Fernando stated that although the GMOA had, on a number of occasions, requested former Health Minister Keheliya Rambukwella for an opportunity to discuss the shortage of essential drugs in the country, they had not been given an opportunity.

Dr. Fernando also accused the Government of not providing accurate information to the public and the health staff including doctors about the shortage of drugs despite the crisis. He added that in the face of the shortage of drugs, doctors would even have to limit certain treatments as they would have to save on drugs for emergencies.

"The CEB is monitoring this carefully," officials at the Power Ministry told *The* Morning on Monday (11).

"Thus, we still have to receive our diesel stocks although we are hoping to definitely reduce this dependency if we receive the expected rains," they added.

The Meteorology Department said yesterday (12) that the low-level atmospheric disturbance in the vicinity of Sri Lanka, which has caused the rains, is moving away from the island but that several spells of showers will occur in Western and Sabaragamuwa Provinces and in Galle and Matara districts today.

"Showers or thundershowers will occur at several places elsewhere during the evening or night. Fairly heavy showers above 75 mm can be expected at some places in Eastern, Uva, North-Central, and Northern provinces," it added.

The CEB said on 10 April that electricity generation using hydropower has increased to about 29% since the heavy rainfall experienced over the weekend.

In a statement made to the media over the weekend, the Public Utilities Commission of Sri Lanka (PUCSL) Chairman Janaka Ratnayake said that the island-wide heavy showers would aid in the generation of electricity using hydropower.

"Islandwide heavy showers which are being experienced at the moment will enhance the capacity to generate more hydropower," said Ratnayake.

Ada Derana reported on 10 April that the Maussakelle and Castlereagh catchment areas, which provide water to the Wimalasurendra, Laxapana, New Laxapana, and Polpitiya hydropower plants, have been receiving heavy downpours since 8 April afternoon.

Water reserves have drastically reduced during this year's dry season, thus

hampering the generation of electricity using hydropower. Alongside this, a series of issues has plagued the country's energy related sector since the beginning of the year.

Since January 2022, the CEB has been struggling to find fuel for its thermal power stations, as the Ceylon Petroleum Corporation, which imports fuel, has been throttled by the foreign exchange shortage in the country. Ultimately, the Sri Lankan public has been forced to endure lengthy power cuts, sometimes lasting even up to 13 hours per day.

The CEB Engineers' Union President Anil Ranjith, speaking to *The Morning* last month, said that power cuts are likely to continue despite expected rains due to the fuel shortage in the country.

The PUCSL, announcing the power cut schedule for this week, said that there will be no power outages today (13) and tomorrow (14). Power cuts will last two hours and 30 minutes each on 15 and 16 April.

UNP...

The statement issued yesterday (12) by the UNP, led by former Prime Minister and current MP Ranil Wickremesinghe read: "Sri Lanka has had an unblemished record since Independence of honouring our debt repayments. Even during difficult times, we as a nation have tightened our belts and made the payments.

"However, the mismanagement of the Government has resulted in the current economic crisis. The suspension of all external servicing will also bring undue pressure upon the banks that have obtained foreign loans to facilitate letters of credit (LCs) and those who hold International Sovereign Bonds (ISBs)."

The statement further mentioned that since 2020, the UNP had recommended that the assistance of the International Monetary Fund (IMF) be sought to help restructure Sri Lanka's financial obligations, and that the delay by the authorities to act on this advice has resulted in the crisis that is unfolding.

"Had the calls made by the UNP and the others been heeded, this default could have been avoided. The Parliament, under Article 148 of the Constitution, has control over public finance. The Government must therefore present a full explanation to the House on what led to this situation when the Parliament meets on 19 April," the statement added.

The statement also mentioned that the UNP will be calling for the establishment of a PSC on the matter.

"The PSC will be tasked with inquiring into the decision to devalue the currency prior to securing IMF funding, as well as the Government's decision to delay the restructuring of the country's debt, which has led to this default," the statement concluded.

Weerasekera also said that the investigations have been completed in a "very short" period of about two-and-a-half years, and that therefore, no one could charge that the Government or the Police did not conduct a proper investigation into the Easter Sunday terror attacks.

"We had to analyse about 110,000 phone calls in a very short period. Also, 24 accused parties who planned these attacks have been indicted. About 23,700 charges have been filed in this regard. So, no one can say that we are trying to sweep the investigations under the carpet," he added.

Trade Secretary cites high demand for pack

he high demand for the "Sathosa Sahana Malla" (Relief Pack) programme, where consumers could purchase essential food items from Sathosa outlets for the reduced price of Rs. 1,950, has caused shortages of essential

Speaking to *The Morning*, Trade Ministry Secretary Bhadranie Jayawardhana said that the unexpected and unusual demand for the same is causing shortages of essential items in Sathosa outlets.

"We didn't expect such a response from the public. We have essential food items in our stores in Jaffna, Ratmalana, and Boossa, but we need to distribute them according to the demand, which is a bit difficult."

She said that the Sathosa outlets provide rice and dhal for a reasonable price compared to the current market prices.

"The cost of 1 kg of nadu rice and kekulu rice is around Rs. 200 in the market, but we provide it for a price of Rs. 110. A kilogramme of samba rice in the market is around Rs. 250, but we provide it for Rs. 130. A kilogramme of dhal is around Rs. 400 in Sathosa outlets, whereas outside it is around Rs. 450-500."

She however said that it is impossible to control the prices of certain products such as sugar.

The Sathosa "Sahana Malla" programme is being implemented on a concept introduced by the former Trade Minister to provide consumers with the opportunity to obtain high quality products at the lowest possible prices, avoiding the hassle of purchasing essential items in the face of the then rapidly spreading Covid-19 pandemic in the country.

Last year, the Rs. 1,000 "Sahana Malla" programme offered consumers 1 kg of samba rice, 1 kg of nadu Technology Institute, 100



rice, 1 kg of flour, 1 kg of Australian red dhal, 200 g of Thai sprats, 1 kg of white sugar, 50 mm of disinfectant hand washing liquid manufactured by the Government's Industrial

g of tea certified by the Tea Board, 50 g of soya meat, and 100 g of chilli flakes.

However, this year, it only offers 10 kg of nadu rice, a 400 g packet of Highland Milk powder, 100 g of tea and 1 kg of sugar.

Police record statements from CPC employees over threat against Olympian

• Sugath Thilakaratne accuses SLPP Govt. supporters of being behind verbal threat over his opposition to President Gotabaya

The Wellampitiya Police has recorded statements from a group of Ceylon Petroleum Corporation (CPC) employees who allegedly threatened former Olympian and Asian Games gold medallist Sugath Thilakaratne at the CPC, over his opposition to President Goatabay Rajapaksa.

Speaking to The Morning, Thilakaratne said that while his statement was recorded on 9 April, he had been informed that the Wellampitiya Police would record statements from the persons who threatened him on 11 April.

He had previously lodged a complaint with the Police over a verbal threat he received after attending a protest in Independence Square a

"This group who threatened me constitute supporters of the ruling Sri Lanka Podujana Peramuna (SLPP). I am just a citizen of Sri Lanka who is working for a Government institution. But it is my right to voice out against that which

He also said that the same group of people had attempted to assault him after he was verbally threatened.

Thilakaratne was a former Sri Lankan athlete who competed in the 400 m events at the 1996 Olympic Games in Atlanta, USA and the 2000 Sydney Olympic Games in Australia. He won the 400 m Bronze Medal at the 1995 Asian Championships in Jakarta, Indonesia and produced a repeat performance at the 2002 event held in Colombo.

Sathosa 'Sahana Malla' leads | SL envoy Kohona confident China will give \$ 2.5 bn

Sri Lanka's Ambassador to China Dr. Palitha Kohona said he is very confident that China will come through on \$ 2.5 billion in financial support, as Sri Lanka's inflation-driven crisis becomes more dire.

Ambassador Dr. Kohona said that he had received reassurances as recently as last week from authorities in China that arrangements for loans and credit lines were progressing.

Sri Lanka is looking to borrow \$ 1 billion from Beijing so that it can repay existing Chinese loans due in July, as well as a \$ 1.5 billion credit line to purchase goods from the world's No. 2 economy, such as textiles needed to support the apparel export industry,

"For us, it can't come any sooner," Dr. Kohona said, adding that it could be a matter of weeks. He was not able to give a precise time frame, and did not disclose the terms of the funding.

"Given the current circumstances, there aren't that many countries that can step out on to the pitch and do those countries that can do something very quickly."

Sri Lanka is embroiled in its worst economic crisis in decades, as consumer prices rose the fastest in Asia at about 19% last month.

Soaring costs, widespread power outages, and shortages of food and medicine have fuelled street protests and left President Gotabaya Rajapaksa with a minority in Parliament.

Beijing has long enjoyed warm relations with Colombo but has yet to deliver a much-needed lifeline to Sri Lanka.

Rajapaksa had recently written to Chinese President Xi Jinping directly to seek credit support, Dr. Kohona said, and Sri Lanka officials are still encouraging Beijing to address the issue as soon as possible.

"Our request will be honoured, but they have to go through the Chinese system," he said. "We are very confident that sooner than later, these two facilities will be made

Dr. Kohona said that Sri Lanka had also sought China's help to buy items such as fuel that it was struggling to secure because of the nation's foreigncurrency shortage. He said he was unsure whether China could provide such support, given that it is a net importer of such goods.

Separately, Sri Lankan officials will meet with counterparts from the International Monetary Fund (IMF) later this week to iron out details of a potential financial package to help it meet \$ 8.6 billion worth of debt payment due this year.

Dr. Kohona said he was hopeful to secure Chinese support that would enhance its chances for closing the deal.

"Given the nature of our relationship - this very close and warm relationship - and Sri Lanka's dire situation, I would say that I am confident that China will respond positively to our request," Dr. Kohona said of his nation's overall efforts to secure funding from Beijing.

Ratmalana International Airport, in the emperor's new clothes

in the papers that Sri Lanka opened another airport, the Colombo **International Airport Ratmalana** (CIAR), on 27 March. There was a photograph too – the arrival of the first plane, a Maldivian Airline Dash-8, twin turboprop 50 seater that flew from the **Velana International Airport in** Hulhule, North Male Atoll, to Ratmalana.

few days ago, I read

The aeroplane was welcomed with arches of water-cannon salutes created by the fire engines of the airport fire brigade. There were Kandyan dancers in attendance too, plus a contingent of very, very important persons to celebrate the opulent opening of the new international airport. Of course, the day's fanfare cost millions, which is what the newspapers said.

The Ratmalana Airport has a remarkable history. It began its life as a cleared grass patch of 600 square feet, which had galvanised roofing sheds on the side, which was the terminal. This was in 1935, when the first plane, a Puss Moth flown by Royal Naval Air Service Force Flight Lieutenant (Flt/Lt) Harold L'Estrange Tyndale-Biscoe landed on levelled grass, making it a softopening for the new airport. There was no marked runway, only a blackand-white striped windsock that stood like a sentinel to tell the pilot which direction to land or take off.

The official opening of the Airport was on 28 February 1938, when a Tata Airways mail plane, a Waco, took off from Ratmalana.

In between Tyndale-Biscoe's Puss Moth and the Tata Airways mail plane, there were people learning to fly on the Ratmalana grass patch, which included expatriates as well as locals. They were the aviators of the Ratmalana Flying Club.

Then came the Royal Air Force, followed by commercial planes, and Ratmalana saw its glory days. Prominent airlines such as Trans World Airlines, British Overseas Airways Corporation, and Koninklijke Luchtvaart Maatschappij landed and took off from Ratmalana. They flew their Lockheed Constellations, de Havilland Comets and Douglas DC-4 Skymasters using Ratmalana as a pit stop to operate their long haul flights. Then, in 1948, the National Carrier, Air Ceylon took over Ratmalana as its operating base.

I have seen Ratmalana from the first day I flew a little airplane as a fledgling pilot. I learnt to fly there, taking off and landing on the grass strip. I did my first commercial flight on a DC-3 from Ratmalana and trained a host of student pilots at

Yes, I have fond memories and cherished moments of flying aeroplanes from this wonderful old airstrip that laid the foundation for my flying career. Remembrance swells

with admiration, not just for me, but for all those who had some connection with this ancient hallmark aerodrome.

So, what are they doing to Ratmalana? Bad enough that we have the magnificent mistake in Mattala. Do we need another fiasco of spending to add to our country's financial woes? Mattala is known as the emptiest airport in the world. Are we making attempts to take the runner-up prize too with Ratmalana?

Ratmalana can definitely prove to be a very good airport to cater to internal flights. It is good to operate Sri Lanka Air Force (SLAF) planes too, which fly to all the airfields in Sri Lanka. Ratmalana had its day and faithfully served Sri Lanka and now needs to give way to Katunayake and Mattala to handle international arrivals and departures.

The RML has only a 1,400-metre runway, which cannot take even the smallest of passenger jets, a Boeing 737 or an Airbus 320. How are we to fly international, or for that matter, even regional, flights from such a short runway? Extending the length is not financially viable, as you either have to send the Galle Road underground, or go towards the Diyawanna Oya on the other side.

Yes, maybe it can handle a business jet, but one must remember that a business jet does not bring loads of passengers. They are used by the rich and the famous, and to have 50 passengers in the Airport terminal, one would need at least 10 business jets. That brings in a parking problem. Somebody sure did not count his marbles when he decided to play this

Yes, I saw the paved great approach road to the new-look RML, almost like the four-lane highway we have in Mattala. Ratmalana too would be another "all hat and no cattle" story. Someone whispered that it cost Rs. 200 million to construct the road and re-furbish the terminal. Maybe, whoever was in charge should have taken that money and done something to improve the navigational facilities of the Ratmalana runway. That is an uncompromisable safety factor that has been totally ignored.

On 27 March 2022, when the first international flight came in to land, there were no landing aids

functioning except for a set of Precision Approach Path Indicators (PAPI) lights on the northeast side of runway 22, and nothing on runway four. The PAPI lights will help a pilot to adjust his final approach path, but it does not assist him/her in any way to make an instrument "let down" to locate the runway in bad weather.

Let us take a look at that business of landing aids. In 2014, on 11 December, a SLAF Antonov aeroplane flew from Katunayake to Ratmalana in the morning. The visibility was marginal with mist and low cloud, and the aeroplane, on the approach phase, hit the ground, 10 miles before the runway threshold, and crashed. Of course, the voices that had power blamed the pilots. No one mentioned that the Ratmalana Airport at that time had no landing aids at all. No instrument landing system, no very high frequency omnidirectional range/distance-measuring equipment, and the non-directional beacon was unserviceable. The crash was said to be a pilot error. But I do not think that it was the correct conclusion. Pilot error may not be the pilot's error.

There is a mile-long difference between pilot error and the pilot's error (sorry, I have no space to explain). Squadron Leader Abeywardena and Flt/Lt Jayatunge plus three others died in vain, simply because there were no landing aids at Ratmalana on that fateful December day. If there was at least one good operable landing aid, that unfortunate accident could have been avoided. And today in 2022, we have the same runway rated as an International Airport.

Can you believe that the same landing aids that were not there in 2014 are still not there in 2022? I am not whistling Dixie here. I checked the Notice to Airmen or Notice to Air Missions for Ratmalana on 27 March, 2022. No landing aids for the runway. That sure is tempting providence. Pity, when they were thinking of upgrading Ratmalana to an International Airport, they completely forgot why the SLAF Antonov went down in Hokandara.

Who makes these colossal mistakes of opening new International Airports without evaluating safety or seeking and confirming marketability? Only the Diyawanna Oya would do

that. And the Yahapalanaya (good governance) United National Front-led Government too are totally guilty of the same mortal sin though they do wash their Pontius' hands, claiming that they are lily white.

Let us not forget that it is the Yahapalana brethren who opened the Jaffna International Airport with a 1,400-metre runway and brought Alliance Air ATR 72-600 twinturboprop aircrafts, which were to operate a daily Chennai-Jaffna-Chennai service. What happened to those promised flights is the same thing that happened to the hoards that were to come to Mattala.

As for Ratmalana, the Maldivian operator has already executed the first flight with a flamboyant arrival ceremony that cost a few millions. Then they took a U-turn and cancelled the next flights for the lack of passengers. No doubt, there would have been some brilliant planning and marketing done to achieve a fascinating result like that.

Let us be realistic, Diyawanna Oya. We, along with the whole world, got bashed by Covid-19. As we started raising our heads, we had the wicked US dollar pandemic. Today, the people of our beautiful paradise are suffering multiple calamities with not even a mirage in sight. And we open an International Airport that at best will only have a propeller plane arriving from Male. That too, only if they can find passengers.

Of course, business jets would be fighting to come – That is the hope? If wishes were horses, beggars would

We have Katunayake, Mattala, Jaffna, and now Ratmalana designated as International Airports. Do not do the same to Batticaloa too. Leave that to the next lot who will win at the Diyawanna Oya musical chairs and get their seats to serve the nation. Let them open the Batticaloa International Airport. They too might want to get some coins to jingle in their pockets.

As for aviation answers, let me be serious. We are definitely coming to the capacity limits of air traffic in Katunayake. Maybe we have already exceeded that, and are operating on borrowed time and pleaded tolerances. We need a 2,500metre second parallel runway in Katunayake. That length is adequate for smaller passenger jets such as A320s and Boeing 737s.

If a twin runway concept can be achieved, the authorities can use Katunayake as an international hub, handling all the international flights (including business jets) that will arrive in Sri Lanka. Then, we can use our so called international airports, Ratmalana and Jaffna, plus all the small local airfields such as Ampara, Batticaloa, China Bay, Weerawila, Anuradhapura, Minneriya, Sigiriya, and Katukurunda for twin-engine propeller planes to operate and run an efficient internal flying service.

As for Mattala, for years, the authorities have tried to sell or lease it and have failed to make a transaction. Why not give it to the SLAF? Give it lock, stock and barrel and make them the custodians of Mattala. They sure can take care of any civil aeroplane movements and share with them the aerodrome. There is space for both and more.

Whatever you do, Diyawanna Oya, do not make a mockery of Ratmalana, she deserves better.

Changes to senior citizens' FDs: Fortunes changing for the worse

Elderly bemoan negative quality of life owing to impact of Govt.'s move

he economic crisis is not a new phenomenon for Sri Lanka, but it has now become the biggest issue the country is facing. It is a time when every citizen is scrambling to save as much money as possible, even though it is becoming an uphill battle owing to inflation, which has gotten out of the Government's hands.

In this context, saving money is a dream for many, and those who have saved money are trying to get the maximum benefit out of their savings.

Last month, it was reported that the Central Bank of Sri Lanka (CBSL) had instructed licensed commercial banks to convert senior citizens' fixed deposit accounts that come under the category of the "special high interest rate scheme" into regular fixed deposit accounts. They were allowed to do so in the event that account holders do not appear before the relevant banks and submit a request in writing to extend the scheme by another year.

According to what was reported, this new regulation was applicable to senior citizens' fixed deposits that had reached maturity before 21 March, and the account holders had been required to visit the relevant bank before 31 March, and submit the said request.

The issue attracted attention mainly due to the considerable difference between the interest rates of the two types of fixed deposits. The interest rates offered for normal fixed deposits were around half of the interest rates offered for fixed deposits that fall

under the special high interest rate scheme, which is 15%.

Senior citizens who have completed 60 years of age are eligible to open a fixed deposit account under the special high interest rate scheme, and they are allowed to open only one such account with a maximum deposit of Rs. 1.5 million.

To discuss how senior citizens view this move, The Morning spoke to several senior citizens who have fixed deposit accounts.

In this regard, Jayasinghe (name changed on request), a 62-year-old retired public sector employee, said that this move is a completely insensitive one, especially given the health condition of most senior citizens, and that it can easily worsen the impacts of the present economic burden on them.

"I have had a fixed deposit account for years, and this is the first time that such an additional and irrational requirement was imposed by the Government regarding such fixed deposits. This is unacceptable, due to the deteriorating health situation of most senior citizens. I cannot even leave the house without the help of someone else, and having to go to the bank to renew my own account to which I have deposited my own money, just to continue to enjoy the benefits I was promised when I opened that account, is ridiculous."

He expressed concerns that this is not just a matter of the senior citizens' health condition, but is also a matter of the senior citizens' economy at a time when the country is in a deep economic crisis.

"Like me, many retired senior citizens depend largely on the interest they receive from their fixed deposits, because we can no longer work like we did before. Some depend

completely on the interest. Some are living in rented houses or in elders' homes, and it is with this interest that they pay their rent or fees, and cover their basic expenses. If they fail to appear before banks personally and renew their fixed deposit accounts, it directly affects the interest rate that they receive since the type of their fixed deposit changes.

"It is not something that most senior citizens can afford, especially not in the current economic situation. The country is going through an economic crisis it cannot get out of, and we are living in an era where we cannot waste a single rupee. Every rupee is more important now than before, since the value of every rupee has decreased significantly.'

He opined that this situation will affect the quality of life of a large number of senior citizens who have deposited all their savings in fixed deposits with the hope of living the latter part of their lives without being a burden to anyone. He opined that this situation will in turn increase the burden of rising inflation on others such as families and the guardians of senior citizens.

Amarapala (name changed on request), a 64-year-old retired businessman who has a fixed deposit account, noted that in a context where Sri Lanka does not have a proper social security mechanism, what the Government should do is further strengthen the available systems through which senior citizens survive in their old age.

He opined: "I understand that the Government as well as the country's banking system are faced with severe economic and financial challenges. However, people, especially senior citizens who cover their expenses with the interest received for the little money that they have saved over a lifetime, are facing worse economic challenges.

. Therefore, passing the burden of the deteriorating economy and the consequences of the rulers' wrong

decisions, to senior citizens, who have contributed to the country in a plethora of ways, is unacceptable."

He also raised concerns as to whether the said decision was clearly communicated to senior citizens who have fixed deposits that fall under the category of the special interest rate scheme.

"At the same time, there has been no proper discourse or explanation about the reasons that led to the said decision or its objectives. Even if there were such, the relevant information or explanation has not reached us senior citizens who have fixed deposits. I do not even know how many fixed deposit holders got the message about this decision.

"The Government or the banking system must have had a good reason to take this decision, but, educating senior citizens who have fixed deposits is crucial, because, at the end of the day, it is their money. In fact, decisions such as these can easily confuse senior citizens and put an additional burden on them, especially those who do not associate with the outside world much or watch news. Such sudden decisions, which are also unfavourable to the account holders, should be discussed and conveyed in a better manner."

He further noted that the said

decision sets a bad precedent, as it implies that with short notice, the benefits given to senior citizens, or any citizens for that matter, by banks or by the Government, can be controlled or curtailed in unexpected

"Those who have fixed deposits are not people who are waiting for the Government to spend public funds to feed them. They have earned and have saved. They should be given the benefits that they were promised, and should not be subjected to confusing or unfair regulations," he opined.

Adding that Sri Lanka is going through a time where senior citizens should receive easy and more opportunities and benefits, he said: "When it comes to supporting the elderly population, Sri Lanka has a long way to go. How many banks issue a loan to a senior citizen, how many financial institutions support senior citizens planning to start their own business, and how many Governments have at least talked about introducing a social security system for senior citizens who have no income or someone to support them?

"Senior citizens are often viewed as people who are waiting for free food or special benefits. But a large segment of senior citizens can still look after themselves, be financially independent, and contribute to the country's economy in some way. However, it requires some support from financial institutions, civil society organisations, and the Government."

Senior citizens are an integral part of any population, and their contribution has helped build the society that exists today. Therefore, as those who spoke with The Morning pointed out, decisions that affect their savings of a lifetime should be clearer and should not affect their confidence in the banking system.

he estimated prevalence of **Bovine Tuberculosis (bTB)** - a disease that carries the risk of transmission from cattle and buffaloes to humans and other susceptible animal species - among cattle in the Central Province is 22.6%.

This finding was made in a research article on the "Prevalence of bTB among cattle and buffaloes in the Central Province" which was authored by Y.H.P.S.N. Kumara, A. Amarasinghe, P.G.A. Pushpakumara, W.M.T.D. Rathnakumara and B. Alexander (all five attached to the Peradeniya University's Veterinary Medicine and Animal Science Faculty's Farm Animal Production and Health Department), H.M.S. Wasana (attached to the same University's Postgraduate Institute of Agriculture) and G.A. Gunawardana (attached to the Gannoruwa Veterinary Research Institute's Molecular Biology Division) and published in the *Tropical* Agricultural Research Journal 33 (2) in March 2022.

"The dairy industry plays a key role in livestock production. The Government has taken steps to increase milk production by introducing improved exotic cattle such as Holstein Friesian, Jersey, and their crossbreds. However, exposure of these cattle herds to a new tropical environment has posed the threat of attracting animal diseases," Kumara et al. observed.


Kumara et al. selected study sites in the Districts of Kandy, Matale and Nuwara Eliya in the Central Province in order to determine the prevalence of bTB. The study spanned from October 2013, to August 2016.

Visible swelling at the injection sites was not observed in cattle with negative results. However, a noticeable swelling at the injection sites was observed in cattle with positive results. These observations were based on 72 hours after injecting Purified Protein Derivative (PPD).

Among the total of 616 cattle tested by injecting PPD, 139/22.6% were identified as reactors for the SICCT test and the majority (77.4%) were negative for the SICCT test.

In the present study, 248 cattle from the Nuwara Eliya District, 286 from the Kandy District and 82 from the Matale District were tested where only 85/34%, 54/19% and zero/0% showed reactions to the SICCT test from the respective

The highest number of reactors was recorded from a herd in the Nuwara Eliya District, where 57 cattle out of 91 tested (62.6%) were positive to the SICCT test. However, 10 herds which were tested for the SICCT (50%) (one herd from the Nuwara Eliya District, five herds from the Kandy District and four herds from the Matale District), were found to be negative and free from



exposure to bTB within the study area.

A herd level prevalence of 50% (10/20) resulted in the large and medium-scale dairy farms that were tested in the study area. There were no significant associations observed with bTB

prevalence and the tested parameters such as the herd category, the duration of the farm establishment and the type of management practice.

The individual level prevalence of 22.5% was observed (139/616) in the

present study. A significant association of the prevalence of bTB with the body condition score, the breed, the origin of the cattle, and the reproductive status were observed.

A total of 33 cattle (six males and 27

females from eight herds) which showed positive results in the SICCT test were subjected to the rapid antibody (Ab) test. Only seven cattle (two males and five females from four different herds) out of 33 were positive for the rapid bTB Ab

Based on this study, a high prevalence of bTB was observed at both the individual and herd levels. The high prevalence (50%) of bTB at the herd level poses a high risk towards future dairy farming.

The findings also revealed that there was a significant association between the prevalence of bTB with breeds of cattle. The highest disease percentage for bTB was observed in the Ayrshire breed (63.6%) indicating five-fold more susceptibility than the other breeds (12.85%). However, a definitive risk factor for the Ayrshire breed has not been identified.

Herd level investigations suggested that cattle and buffaloes managed under intensive and/or semi intensive management systems may carry a high risk of bTB transmission among animals.

"Possible underlying causes for high herd prevalence of bTB could be intensification, stress, and overcrowding due to limited land availability. It is also suggested that these farming systems cannot avoid close contacts among animals and thereby create a favourable environment in the spreading of the disease from one animal to another. Water and feed sources were common for all the animals managed under the semi intensive management system in the study, where animals were herded to a common area in the yard for concentrated feeding every day. Horizontal transmission of the disease is inevitable in such situations," Kumara et al. pointed out.

The results revealed that the gender of an animal was not significantly associated with the status of bTB. "This could be due to the small number of male animals included in the study due to the low representation of male animals in dairy farming systems," Kumara et al. added.

Among the individuals who tested positive for the SICCT, the highest percentage (34.7%) was the cattle with poor body condition scores. "This could mainly be due to the fact that animals with poor body condition scores are immune compromised and thus become susceptible to diseases. Animals with good body condition scores were the least (5%) affected by the disease. Hence, maintaining a good body condition score with optimum environmental conditions are of utmost importance in order to prevent the disease," Kumara et al. emphasised.

The results further indicated that the herd level prevalence of bTB was proportionate to the herd size. Therefore, the tendency of the spread of bTB in large-scale farms was higher than in medium-scale farms.

Russian soldiers raped me and killed my husband' Warning: This report contains graphic descriptions of sexual violence Women caught up in the Ukraine conflict speak up about atrocities

In a quiet, rural neighbourhood 70 km (45 miles) west of Kyiv, we spoke to Anna, who is 50. We have changed her name to protect her identity.

Anna told BBC that on 7 March she had been at home with her husband when a foreign soldier barged in.

"At gunpoint, he took me to a house nearby. He ordered me: 'Take your clothes off or I'll shoot you.' He kept threatening to kill me if I didn't do as he said. Then he started raping me," she said.

Anna described her attacker as a young, thin, Chechen fighter allied with Russia.

"While he was raping me, four more soldiers entered. I thought that I was done for. But they took him away. I never saw him again," she said. She believes she was saved by a separate unit of Russian soldiers.

Anna went back home and found her husband. He had been shot in the abdomen.

"He had tried to run after me to save me, but he was hit by a round of bullets," she said. They both sought shelter in a neighbour's house. They couldn't take her husband to hospital because of the fighting. He died of his injuries two days later.

Anna never stopped crying while telling us her story. She showed us where she and her neighbours buried her husband in the backyard of their home. A tall, wooden cross stands at the head of the grave. Anna told us that she is in contact with the local hospital

and is receiving psychological support. The soldiers who saved her stayed in her

house for a few days. She says they would point their gun at her and ask her to give them her husband's belongings.

"When they left, I found drugs and viagra. They would get high and they were often drunk. Most of them are killers, rapists and looters. Only a few are okay," she said.

Down the road from Anna's house, we heard another chilling story.

A woman was allegedly raped and killed, and neighbours say it was done by the same man who raped Anna, before he went to Anna's house. The woman was in her 40s. She was taken out of her home, say neighbours, and held in the bedroom of a house nearby whose occupants had evacuated when the war

began. The well-decorated room, with ornate wallpaper and a bed with a golden headboard, is now a disturbing crime scene. There are large bloodstains on the mattress and duvet.

In a corner is a mirror with a note written in lipstick, appearing to suggest where the victim was buried.

Oksana, a neighbour, told us it had been left there by Russian soldiers who found the woman's body and buried her. "They (Russian soldiers) told me she had been raped and that her throat was either slit or stabbed, and she bled to death. They said there was a lot of blood." The woman was buried in a grave in

the garden of the house. A day after we visited, the police exhumed

her body to investigate the case. The body was found without clothes, and with a deep,

long, cut across the neck. Andrii Nebytov, the police chief of the Kyiv region, told us about another case they're investigating in a village 50 km (30 miles) to the west of Kyiv. A family of three – a couple in their thirties and their young child

– lived in a house on the edge of the village. "On 9 March, several soldiers of the Russian army entered the house. The husband tried to protect his wife and child. So they shot him in the yard," said Nebytov.

"After that, two soldiers repeatedly raped the wife. They would leave and then come back. They returned three times to rape her. They threatened that if she resisted they would harm her little boy. To protect her child she didn't resist."

When the soldiers left, they burnt down the house and shot the family's dogs.

The woman escaped with her son and then contacted the police. Nebytov says his team has met her and recorded her testimony.

They have been gathering evidence at the family home – only its shell is now left. Just

a few signs of a previous peaceful, ordinary life lie in the charred ruins. We saw a child's bicycle, a stuffed horse, a dog's leash and a man's fur lined winter shoe. The husband was buried in the garden by

neighbours. The police have now exhumed his body for examination. They plan to take the case to international courts.

Ukraine's ombudsman for human rights Lyudmyla Denisova says they're documenting

several such cases. "About 25 girls and women aged 14 to 24 were systematically raped during the occupation in the basement of one house in Bucha. Nine of them are pregnant," she said. "Russian soldiers told them they would rape them to the point where they wouldn't want sexual contact with any man, to prevent them from having Ukrainian children." She says they are receiving several calls on support helplines – and also getting information through channels on the Telegram messaging app.

"A 25-year-old woman called to tell us her 16-year-old sister was raped in the street in front of her. She said they were screaming 'This will happen to every Nazi prostitute' as they raped her sister," Denisova said.

We asked if it was possible to assess the scale of sexual crimes committed by Russian troops during the occupation.

"It is impossible at the moment because not everyone is willing to tell us what happened to them. The majority of them currently call for psychological support, so we cannot record those as crimes unless they give us their testimony," Denisova said.

She says Ukraine wants a special tribunal to be set up by the United Nations (UN) to try Vladimir Putin personally for allegations of war crimes including rape.

"I want to ask Putin, why is this happening?" said Anna, the woman who told us she was raped. "I don't understand. We're not living in the Stone Age, why can't he negotiate? Why is he occupying and killing?'

Sri Lanka makes its first debt default

- Suspends external debt servicing for an interim period
- Plans to restructure debt, consistent with IMF programme

ainting its unblemished track record of timely servicing its external financing obligations ever since it gained independence, the Sri Lankan **Government yesterday (12)** announced that it is suspending debt servicing of selected debts amidst what is considered the worst economic crisis the country has ever endured.

With international media reports having mentioned that it is only a matter of time as to whether Sri Lanka will default right before its upcoming International Sovereign Bond (ISB) payment in July or even earlier, the Ministry of

Meanwhile, Frontier Economic Research Group Economist Chayu Damsinghe in a Tweet yesterday (12), published soon after the announcement by the Ministry of Finance, stated that this move by the Government is better than an economic crash, and has been communicated "well enough", and added that even an agreed suspension of debts would still lead to a downgrade and would lead to a technical default.

"We are technically in default, and will likely get downgraded to a selective/restricted default setting. But 'default' has become a dirty word, and it is not all that bad," his Tweet added.

According to data compiled by Verité Research, Fitch Ratings has downgraded Sri Lanka five times since December 2015, leading the country's rating to drop to "CC" from "BB-".

Sri Lanka was downgraded to "B+" from "BB-" in February 2016 by FItch Ratings, and in December 2018 was once again downgraded to "B". The third downgrade was in April 2020 to "B-", while the fourth downgrade was in November 2020 to "CCC". The latest downgrade to "CC" was in December last year.

A little less than a month later, Standard and Poor's (S&P) downgraded Sri Lanka to "CCC" from "CCC+", keeping the outlook at a lower level, triggered by low foreign reserves and upcoming debt obligations.

is the obligor or guarantor; and all amounts payable by the Republic or a public sector entity following a call during the interim period upon a guarantee (or equivalent financial undertaking) issued in respect of the debt of a third party".

However, it added that new credit facilities and amounts disbursed under existing credit facilities after 12 April are not subject to this policy, and will be serviced normally.

The Ministry also expressed its intention

to engage, in good faith, discussions with representatives of both bilateral and commercial creditors regarding the features of a comprehensive external debt restructuring programme consistent within the parameters of what is endorsed by the IMF. Local and international economists have long been calling for an orderly default and debt restructuring, with the official foreign exchange reserve position failing to reach healthy levels even after two years into the pandemic.

The statement by the Finance Ministry noted that the Government has taken "extraordinary steps" in an effort to avoid resorting to these measures, but it is now apparent that any further delay risks inflicting permanent damage on Sri Lanka's economy and causing potentially irreversible prejudice to the holders of the country's external public debts.

It should be noted that economists and the business community have been calling on the Sri Lankan Government to seek IMF support for months now, however, the CBSL, under immediate past CBSL Governor Ajith Nivard Cabraal and the Treasury under immediate past Secretary S. R. Attygalle, have been hesitant to do so, as they were depending on "home-grown" solutions for the economic crisis.

Fed expected to increase rates The Federal Reserve is

L expected to deliver two back-to-back half-point interest rate hikes in May and June to tackle runaway inflation, according to economists polled by Reuters, who also say the probability of a recession next year is 40%.

With the unemployment rate near a record low, inflation the highest in four decades, and a surge in global commodity prices set to persist, most analysts say the Fed needs to move quickly to keep price pressures under control.

The latest 4-8 April Reuters poll of more than 100 economists forecast two halfpoint rate rises this year, the first such move since 1994, taking the federal funds rate to 1.25-1.50% by the June meeting.

That brings the end-year prediction from the March Reuters poll at least three months forward, and more in line with interest rate futures pricing.

A strong majority, or 85 of 102 economists, forecast 50 basis points in May, and a still-solid majority of 56 said the Fed would follow up with 50 basis points as well in June.

"Given the shift in official commentary and with inflation pressures visible throughout the economy, we believe the Fed will deliver half-point interest rate increases at the May, June and July policy meetings." said ING Chief International Economist James Knightley.

While the Federal Reserve, chaired by Jerome Powell, is likely to gear down to quarterpoint moves in the second half of this year, the federal funds rate is now expected to end 2022 at 2.00-2.25%, 50 basis points higher than the median forecast in a poll taken last month.

Moving so quickly with interest rates, especially in an economy that has become used to very low borrowing costs for many years, comes with risks.

"With the Fed seemingly

feeling the need to 'catch up' to regain control of inflation and inflation expectations, a rapid-fire pace of aggressive interest-rate increases heightens the chances of a policy misstep that could be enough to topple the economy

Inflation as measured by the Consumer Price Index (CPI) was predicted to have peaked at 7.9% last quarter, and average 6.8% this year, a significant upgrade from 6.1% in last month's poll.

Nepal's foreign currency reserves are double what is considered "a comfortable minimum" and

government debt "is not particularly high", Holmes said.

"Of course, things will eventually regress if the current account deficit does not narrow," he added. "But a crisis does not appear imminent."

Last week, Sri Lanka named a new Central Bank Governor and almost doubled its key interest rate to help tackle soaring prices and shortages of essential goods.



AVURUDU SALES ARE LOCKING BLRAK

Tomorrow (14), Sri Lankans will celebrate the Sinhala and Tamil New Year. The festival marks the beginning of the New Year, as per Sinhalese astrology, when the sun moves from Meena Rashiya (the house of Pisces) to Mesha Rashiya (the house of Aries). It also marks the end of the harvest season and of spring.

The past three Avurudu celebrations have been different experiences, where, in 2019, just after the festivities, we experienced the Easter Sunday bombings, and in 2020,

while still reeling from the tragedy we had faced, Avurudu took place amidst a pandemic, and in 2021, things were no better. And now, in 2022, we are faced with an economic crisis and the country in general unrest.

It would seem that for the third year in a row, Sri Lankans will be celebrating Avurudu differently from how they would have liked and hoped.

Considering the state of our nation as we experience price hikes on everyday consumer items, we reached out to a number of vendors who rely on the annual festival to meet their income targets.

We spoke to Lalitha, a Gampahabased home cook who prepares Avurudu kavili and sells them to certain families in her hometown.

She shared that this year she has not received as many orders because many families are not celebrating Avurudu in a grand way and admits that her own prices have risen considerably.

"The reason I have had to raise my prices is because if I continue to sell at my old rates, I will be doing it at a loss. Right now, I am used to buying just a quarter bottle of coconut oil, but to make kavili I need much more. Usually, we reuse the oil for other foods, but for kavili I can't use used oil, since the oil absorbs the taste of the food. And especially when it comes to making kokis, I absolutely can't use old oil, as it will taste funny.

"So it is so much more expensive," she said, also adding: "We buy the quarter bottle at Rs. 180, but the coconut oil bottle is Rs. 700. I can't imagine buying multiple bottles to make kavili, but I need a lot of oil to prepare it."

Similarly, speaking to Namal, who has a temporary stall at the Pettah private bus stand, he shared that he usually sells firecrackers to people coming to take the bus. "Avurudu season is when I would make the sales, but this year all the vendors had an understanding that there will be less purchases, so we all restocked almost

half less than what we usually would,"

"In 2020, we thought that people might not buy firecrackers, but we bought our full stocks anyway, just in case, and the people ended up buying everything, because last year people

had money. But this year we know full well that unless you have young kids for whom you want to provide a good Avurudu, people are not going to buy firecrackers."

Several other vendors also shared that foods like mung beans and kithul jaggery are particularly hot items during this season, however, with mung beans, especially, being so expensive and people resorting to buying only 100 g for Rs. 40, sales have been severely affected.

Sadly, when speaking to these vendors, the general sentiment was a far cry from being festive, with many of them simply stating that they have accepted their fate and all they can do is hope that things will turn around

the platform known as "Yellow for

Democracy". Telling her story, Siriwardhana shared that Yellow for Democracy happened naturally. At first, it was just Siriwardhana, a few friends, and family hoping to head to Independence Square for a peaceful protest after the curfew was lifted. "After that very blatant expression of the Government curtailing people's rights (with the curfew), we decided to exercise our defiance," she told us, adding that she took to social media with the plans for a peaceful protest at Independence Square on 4 March. Her message was strong and powerful, and so it urged the masses to join her cause, which, over the last weeks, has become our cause, as well. Last Monday (4), there were many youth, who Siriwardhana told us would normally not even be seen at such protests. After seeing the amount of people present, all shouting for their rights and fighting for a better life, she was motivated to create Yellow for Democracy – a platform for the youth to voice out what they want for their future and what they believe is necessary for this country to move forward. Once she launched the Instagram page for the platform, she saw a massive amount of traction within days – in just a week, she amassed over a 1,000 followers. While they recognise protests as an expression of dissent, Siriwardhana told us that she realised what was most important is educating the youth about why we are on the

streets today, the constitution,

economics, and politics. "We



When talking about a key detail that led us to the current crisis, Siriwardhana pointed at political apathy and the lack of political knowledge. "We can blame those in power as much as we want, and while they are abusing their power, it is us, as citizens, who voted them in." She explained that the Sri Lankan political culture is such that one can have inherent political affiliations; one can vote for their family and vote based on promises of immediate, short-term solutions. With her platform, she hopes to motivate the youth to know who they're voting for and what their goals are.

Going into more detail about the name behind the platform, Siriwardhana explained that she chose yellow because the yellow in our national flag is supposed to represent unity amongst Sri Lankans. "It's symbolic of a brighter future – we are the youth, we are the future of this country, and we are calling for a brighter

Speaking of short-term solutions, she noted that we must understand what exactly we are calling for at protests, how we can move forward, and what the immediate first step should be. "There are a whole bunch of people calling for a bunch of different things right now. It's a messy situation and even the experts don't have a single answer," she told us, adding that Yellow for Democracy is trying to speak to as many legal, political, and economic experts as possible, to figure out what the first step to get out of this crisis is.

Yellow for Democracy is hosting a protest as well as a "teach out" session today (13) at Independence Square and another tomorrow (14). Sharing more about what is being organised for tomorrow, she told us that it will be quite a symbolic event. "We want to come together as a country and join in bringing in the Sinhala and Tamil New Year," she told us, adding that they will be boiling milk at the auspicious time and the setting will be adorned in gold to represent the movement and the New Year. She requested anyone who is able to bring along New Year kavili as well, and highlighted that this is not a celebration, but a symbol of unity.

Quick fixes with just three ingredients

In light of the crisis our country is currently facing, food has been scarce; ingredients are not found easily and cooking has become a game of substitution. With a week of holidays approaching, we decided to let you in on some of our three-ingredient recipes - all made with ingredients that are not too difficult to source. If you're in a pickle, these are super easy to whip up and are bound to satiate your hunger.

Carrots + butter + honey = honey roasted carrots

This is a great way to enjoy a healthy meal that still tastes like comfort food. You will need six whole carrots, or chopped (if you prefer bite-sized pieces), peeled with tips and ends cut off. First, preheat your oven to 400°F (200°C). Evenly coat the carrots in two tablespoons of butter and two tablespoons of honey and place them in a medium-sized casserole dish. Add salt and pepper to taste. Bake it for 25-30 minutes and you've got your dinner! If you're facing power cuts, this can just as easily be done over a low flame, and it's a great snack that can be kept refrigerated and eaten hot or

Chocolate spread + eggs + flour = mug cakes

Now milk is undoubtedly

a little hard to come by these days, but just a splash should suffice – you can substitute it with heavy cream or any kind of cream base you have at home. In a medium-sized mixing bowl, whisk together 3/4 cup chocolate spread (if you don't have chocolate spread, you can use melted chocolate) and two eggs. Fold in the flour. Evenly distribute the mixture into two mugs. Microwave each mug for two minutes. Let it cool for five minutes. Frost the cakes with the remaining chocolate spread and serve warm. Again, this is super filling and can be kept refrigerated to be consumed at a later date.

Chicken + soy sauce + brown sugar = teriyaki chicken

We love Japanese food, but unfortunately, with all the recent price hikes, eating out has become almost impossible. So here's a quick fix we came up with to satisfy your cravings. Sear about one kilogrammes (kg) of chicken evenly in a pan, then flip. Add one cup of soy sauce and ½ cup of brown sugar; stir and bring to a boil. Stir until the sauce has reduced and evenly glazes the chicken. Serve with rice, if desired. This recipe is great for a quick lunch fix when you're in a hurry. One can even substitute the chicken with any meat desired. This recipe works with sausages, meatballs, and even tofu, so feel free to change it as you like.

Tomatoes + butter + onion = fresh tomato sauce

Want to make pasta only to find

you don't have sauce? Here's an easy solution. Put two cups of sliced tomatoes, with the juice, into a saucepan. Add five tablespoons of butter and one mediumsized chopped onion and salt to taste. Cook uncovered at a very slow but steady simmer for about 45 minutes, or until it is thickened to your liking and the fat floats free from the tomato. Stir from time to time, mashing up any large pieces of tomato with the back of a wooden spoon. Taste and correct for salt. This can be served over pasta or even as a dip – it's delicious however it's served.

Potatoes + butter + oil = hash browns

Crispy hash browns are a great breakfast option. With just three ingredients and being freezable, too, they're easy to add to your next fry-up. All you need are three potatoes, 50 grammes (g) of butter, and four tablespoons of an





oil of your choice. Cook the potatoes in a saucepan of boiling water for 10 minutes, then drain and set aside until cool enough to handle. Once that's done, coarsely grate the potatoes into a bowl discarding any skin that comes off in your hand as you grate. Season well with salt and pepper and pour over half the butter. Mix well then divide the mix into eight portions and shape into patties or squares. The hash browns can be prepared a day ahead and chilled until ready to cook or be kept frozen for up to a month.

Victoria confirmed as 2026 **Commonwealth Games host**

Five cities and regions set to stage minimum of 16 sports

total of five cities and regions are set to play a role in the 23rd Commonwealth Games 2026 after the **Australian state of Victoria was** officially confirmed yesterday (12) as the host of the next Games.

The announcement followed a successful and exclusive dialogue period launched in February between the Commonwealth Games Federation (CGF), Commonwealth Games Australia, and Victoria, where a proposal to stage the major multi-sport competition across the state was agreed by all parties.

In what will be a first-ever predominantly regional Commonwealth Games, Victoria 2026 will be staged in March of that year in multiple cities including Melbourne, Geelong, Bendigo, Ballarat, and Gippsland.

Final programme end of this year

The Opening Ceremony will take place at the iconic Melbourne Cricket Ground (MCG), it was confirmed at a launch attended by CGF President Dame Louise Martin and the Premier of Victoria Daniel Andrews, revealed Duncan Mackay of Inside the Games yesterday (12).

The approach will showcase the best of what the State has to offer and ensure a uniquely Victorian experience for the athletes and spectators, it is claimed.

An initial 16 sports have been put forward for the Games, including T20 cricket, a figure which could increase by up to seven when the final programme is announced at the end of this year.

Massie relief for CGF

Along with cricket, swimming and diving, athletics, badminton, boxing, beach volleyball, cycling, gymnastics, hockey, lawn bowls, netball, rugby sevens, squash, table tennis, triathlon, and weightlifting are the first group of sports to be confirmed on the programme for Victoria 2026.

Swimming, athletics, lawn bowls, table tennis, and triathlon will host Para sports, while power-lifting will also be included.

Official confirmation that Victoria will follow Birmingham 2022 as the next host will be a massive relief for CGF officials, who had been struggling to find somewhere to stage the Games.

Geelong sports

Currently, Melbourne, which hosted the 2006 Commonwealth Games, is scheduled only to stage the Opening Ceremony.

Geelong, Victoria's second-largest city behind Melbourne, is currently scheduled to host seven sports, including swimming and diving at the GMHBA Stadium, which recently underwent a multi-million-dollar investment, including the open-air swimming pool.

The port city is also due to host beach volleyball, gymnastics, hockey, table tennis, and triathlon.

Cricket too

Geelong is also set to stage T20 cricket along with Ballarat, Bendigo, and Gippsland.

It is currently not clear whether cricket will be contested by both genders and, like Birmingham 2022, there will be only a women's tournament.

Ballarat, Bendigo, and **Gippsland**

Ballarat, where gold was discovered in 1851, sparking a massive boom in the city's fortunes, will stage athletics and boxing, as well as cricket.

Bendigo, 100 miles north-west of Melbourne and which hosted the 2004 Commonwealth Youth Games, is currently scheduled to stage lawn bowls, netball, squash, and weightlifting and power-lifting. It will also be the final destination for the cycling road race, which will start in Gippsland.

Gippsland, a rural region that makes up the south-eastern part of the stage, mostly comprising the coastal plains to the southern side of the Victorian Alps, is also due to host badminton and rugby sevens.

The plan fulfils Andrew's promise for the Games to be spread around Victoria.

'A privilege'

"It's a privilege and honour to have Victoria chosen as the host venue for the 2026 Commonwealth Games – we can't wait to welcome the world to Victoria," he said.

"Sport is part of the fabric of our state and regional Victoria will provide the ideal hosting environment for the 2026 Commonwealth Games.'

Sixth time in Australia

This will be the sixth time that Australia has staged the Commonwealth Games. Besides Melbourne 2006, they have been staged in Sydney in 1938, Perth in 1962, Brisbane in 1978, and the Gold Coast in 2018.

"The Commonwealth Games is a pinnacle of world sport and Victoria 2026 will bring a comprehensive sports programme to world class stadia across regional Victoria, after an Opening Ceremony on the hallowed turf of the MCG," Victoria's Minister for Tourism, Sport and Major Events Martin Pakula said.


The background

Former Sri Lanka cricket Captain Marvan Atapattu and his wife Neluni joining the ongoing anti-Government protest in Colombo in the past week posting a placard that states "Kaputas' go home", meaning "go home crows" - a direct hit at the present Rajapaksa dispensation which is widely considered corrupt and nepotistic.

What the photo reveals

Marvan Samson Atapattu, 51, is former Mahinda College, Galle and Ananda College, Colombo cricketer who later played for Sri Lanka during 1990-2007. He played in 90 Tests and 28 One-day Internationals (ODIs) scoring 5,504 Test runs at an average of 39.02 and 8,529 runs in ODIs, averaging 37.57.

He is considered one of the most technically sound batsmen. Atapattu notably scored six double centuries in Tests after notoriously registering five ducks (0s) in his first six innings. At Lord's in London in 1998,



England, his highest score in ODIs, whilst guiding Sri Lanka to a memorable tri-series triumph in a tournament which also involved South Africa. Later Atapattu captained Sri Lanka

in 18 Tests during 2002-05 winning eight and losing five. He also led the country in 63 ODIs during 2001-06 winning 35 of them. His captaincy period fell between those of Sanath Jayasuriya and Mahela Jayawardene.

After retirement, Atapattu coached the Canada and Singapore national cricket teams before becoming Sri Lanka Head Coach from April 2014 to September 2015.

Former Sri Lanka Test batsman Marlon Von Hagt is the son of Marvan Atapattu's mother Diana's sister Marina - both Marvan and Marlon are cousins. Later, Marvan's younger sister got married to World Cup-winning Captain Arjuna Ranatunga's younger brother Nishantha Ranatunga, another former Sri Lanka Test cricketer.

Neluni is reportedly an accountant by profession.

Asia Rugby suspends Sri Lanka Rugby

Sports Director General appears clueless about decision

ri Lanka Rugby (SLR) is on the headlines once again as Asia Rugby has suspended SLR yesterday (12), in relation to the contradictory positions between the Ministry of Youth and Sports, and the National Olympic Committee of Sri Lanka (NOCSL).

At a meeting held last Saturday (9) in Phuket, Thailand, the Asia Rugby Executive Committee has decided to suspend the membership of SLR with immediate effect.

Amal Edirisooriya unaware

The statement read: "The Asia Rugby Executive Committee (EXCO) has discussed at length the contrary positions of the Sri Lanka Ministry of Youth and Sports, and the Sri Lanka National Olympic Committee in relation to the suspension of SLR."

The Morning Sports contacted the Director General of Sports Development Amal Edirisooriya regarding the matter last afternoon. However, he claimed to have no idea of the suspension Asia Rugby had published on their official website by yesterday.

I think it's fair to say that both the Ministry of Sports and Asia Rugby don't have good governance. Initially, the Sports Ministry suspended SLR without any inquiry. It is against sports law. You're supposed to have a hearing and give an explanation. But we are yet to receive any explanation from the Ministry.'

He further added: "We are speaking to our sources and lawyers. All these actions are only affecting the progress of SLR. We were conducting the tournament smoothly and now all these issues have hampered the sport's progress. Not only does it affect the sport, it affects the clubs, coaches, and players too. In the end, we respect the gazette but we are standing strong.'

Chelsea legend Drogba runs for FIF presidency

Chelsea legend Didier Drogba is among six presidential candidates cleared to vie for the Ivorian Football Federation (FIF) top seat in the coming elections. The 44-year-old was among the candidates, who presented their nomination papers to the Normalisation Committee and has been finally given a clean bill of health to

Confirming the news, the committee's President Mariam Dao Gabala told a press conference as quoted by Africanews: "The filing of candidacies for the presidency of the Ivorian Football Federation is closed. Six candidates have been registered. They are: Yatte Ellele Jean-Baptiste, Arnaud Aka, Laurent Kouakou, Idriss Diallo, Sory Diabate, and Didier Drogba."

Drogba is best known for his career at Chelsea, where he scored more goals than any other foreign player and is currently the club's fourth-highest goalscorer of all time.

He was named "African Footballer of the Year" twice, winning the accolade in 2006 and 2009. An Ivory Coast international between 2002 and 2014, becoming the nation's all-time top goalscorer with 65 goals from 105 appearances.

He led Ivory Coast to the 2006 Fifa World Cup, their first appearance in the tournament, and also scored their first goal.

Former Colombia captain Freddy Rincón is in critical condition after a car crash in Cali, Colombia. The 55-yearold was driving a car when it was involved in a crash with a bus. The former Real Madrid player, his four passengers, and the driver of the bus all suffered injuries, according to reports.

"Freddy Eusebio Rincón arrived in hospital this morning with a traumatic brain injury," said the Imbanaco Clinic in a statement. His condition is very serious, taking into consideration the findings in the surgery," added Laureano Quintero, a director at the Cali hospital.

Rincón played for Colombia 84 times and scored 17 goals, representing his nation at three World Cups in 1990, 1994, and 1998. He played with distinction for Napoli and Real Madrid in Europe and also won the FIFA Club World Cup in 2000 with Corinthians.
