PROCLAMATION.

By His Excellency the Right Honourable Sir J. WEST RIDGEWAY, Knight Commander of the Most Honourable Order of the Bath, Knight Commander of the Most Exalted Order of the Star of India, Governer and Commander-in-Chief in and over the

Island of Ceylon, with the Dependencies thereof.

WEST RIDGEWAY.

W HEREAS by section 289 of "The Criminal Procedure Code, 1898," it is enacted that if from the absence of a witness or any other reasonable cause it becomes necessary or advisable to postpone the commencement of or adjourn any inquiry or trial, the court may from time to time order a postponement or adjournment on such terms as it thinks fit for such time as it considers reasonable, and may remand the accused, if in custody, or may commit him to custody or take bail in his own recognizance or with sureties for his appearance; and (2) that no Magistrate shall remand an accused person to custody under the said section for a term exceeding seven days at a time, save and except at such police courts as the Governor, with the advice of the Executive Council, shall from time to time proclaim to police courts at whih longer remands may be made, when it shall be lawful to remand accused persons at any such police courts for a term not exceeding fourteen days :

And whereas it is expedient to proclaim the Police Court of Galle to be a Police Court at which longer remands than seven days may be made :

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby proclaime that from and after the First day of April, 1899, the Police Court of Galle shall be a Police Court at which longer remands than seven days may be made.

By His Excellency Sir EDWARD NOEL WALKER, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by section 14 (1) of Ordinance No. 15 of 1896 it is enacted that when it appears to the Governor, with the advice of the Executive Council, from time to time, that by reason of the existence or apprehension of crime and outrage in any district it is desirable to quarter police in such district, or, should a police force have been already established there, to increase the same, he may by Proclamation, which shall be published in the Government Gazette, declare that for the reason aforesaid such district requires police or additional police, and may order police to be quartered in such district or additional police to be employed there :

And whereas it appears to the Governor, with the advice of the Executive Council, that by reason of the existence of crime and outrage in the district defined in the schedule hereunto annexed it is desirable to quarter police in the said district :

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby declare that by reason of the existence of crime and outrage therein the said district in the Southern Province requires police, and do hereby order that a police force consisting of one sergeant and six constables be quartered in the said district in the said Southern Province as from and after the First day of April, 1899, for a period of six months.

And We do further hereby define the limits of the said district to be those set out in the schedule hereunto annexed.

Given at Colombo, in the said Island of Ceylon, this Twentieth day of March, in the year of our Lord One thousand Eight hundred and Ninety-nine.
