WHEREAS by section 8 of "The Road Ordinance, 1861," it is enacted that it shall be lawful for the Governor, with the advice of the Executive Council, by Proclamation, to declare that any road, canal, or river shall be deemed to be a principal thoroughfare for the purposes of the said Ordinance, and such road, canal, or river shall from the time specified in such Proclamation be deemed to be a principal thoroughfare accordingly:

And whereas it is expedient to declare the road from the termination of the road known as the Madawela to Teldeniya and Nugatenna Gap to the commencement of the Nugatenna-Kobonella branch road, about 462 ft. in length, a principal thoroughfare for the purposes of the said Ordinance:

Now know Ye that We, the said Governor, with the advice of the Executive Council, do by this Our Proclamation declare that the road from the termination of the road known as the Madawela to Teldeniya and Nugatenna Gap to the commencement of the Nugatenna-Kobonella

branch road, about 462 ft. in length, shall for the purposes of the said Ordinance be deemed to be a principal thoroughfare from and after the First day of April, 1899.

WHEREAS by section 289 of "The Criminal Procedure Code, 1898," it is enacted that if from, the absence of a witness or any other reasonable cause it becomes necessary or advisable to postpone the commencement of or adjourn any inquiry or trial, the court may from time to time order a postponement or adjournment on such terms as it thinks fit for such time as it considers reasonable, and may remand the accused, if in custody, or may commit him to custody or take bail in his own recognizance or with sureties for his appearance; and (2) that no Magistrate shall remand an accused person to custody under the said section for a term exceeding seven days at a time, save and except at such police courts as the Governor, with the advice of the Executive Council, shall from time to time proclaim to be police courts at which longer remands may be made, when it shall be lawful to remand accused persons at any such police courts for a term not exceeding fourteen days :

And whereas it is expedient to proclaim the Police Courts of Point Pedro and Chavakachcheri to be Police Courts at which longer remands than seven days may be made :

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby proclaim that from and after the Thirtieth day of March, 1899, the Police Courts of Point Pedro and Chavakachcheri shall be Police Courts at which longer remands than seven days may be made.

W HEREAS by a Proclamation bearing date the 27th day of July, 1897, issued under the provisions of section 7 of "The Police Ordinance, 1865," a Police Force was duly established in the town of Anuradhapura, in the North-Central Province, within the limits in the said Proclamation set out and described :

And whereas by section 34 of the said Ordinance it is enacted that for the purposes of creating a fund from which the expenses of the Police Force payable by each town not created a Municipality are to be defrayed a tax shall be payable on the 31st day of March, on the 30th day of June, on the 30th day of September, and on the 31st day of December in every year, for the quarter ending on the said days respectively, on all houses and buildings of every description and on all lands and tenements whatsoever within every such town to an amount equal to such percentage on the bond fide annual value of such houses, buildings, lands, and tenements as the Governor, with the advice and consent-to of the Executive Council, shall by Proclamation from time to time appoint, except in cases where such amount shall fall below the sum of twenty-five cents per quarter, in all which excepted cases twenty-five cents per quarter shall be assessed and payable: Provided that such tax shall not in theory aggregate exceed the sum necessary for the maintenance of the force in such town, except as aferences said, and which sum it shall be lawful for the. Governor, with the advice and consent of the force in such town, except as aferences and, and which sum it shall be lawful for the. Governor, with the advice and consent of the force in such town, except as aferences appropriated to religious worship and such as are placed in charge of military sentries shall, berge exempted from the payment of such tax :

And whereas the town of Anuradhapura aforesaid has not been, created a Municipality : And whereas the Governor, with the advice and consent of the Executive Council, has determined and, appointed that the sum necessary for the maintenance of the force in the said town of Anuradhapura, is Rs. 1,369-82:

Now therefore know Ye that We, the said Governor, with the advice and consent of the Executive Council, do hereby appoint that for the purposes aforesaid the tax payable on all houses and buildings of every description and on all lands and tenements whatsoever in the town of Anuradhapura aforesaid, within the limits specified in the schedule to the Proclamation dated the 27th reday of July, 1897, aforesaid, shall, save in such excepted cases as aforesaid, and in the case of such buildings which are exempted from the payment of such tax as aforesaid, from and after the First day of January, 1899, be at the rate of four per cent. on the bond fide annual value of such houses, buildings, lands, and tenements aforesaid.
