BY virtue of the powers vested in terms of paragraph (01) of Article 57(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka, Part I of the Schedule published in *Gazette Extraordinary* No. 1941/41 dated 20.11.2015 by which the Public Service Commission delegated powers is hereby amended with effect from 11.02.2016 by substituting the following provisions set out under No. 14(a) and (b) in place of the provisions relating to the delegation of powers set out under No. 14 of the said Part I of the Schedule and inserting the provisions hereunder set out in No. 17 and 18.
