SUBSIDIARY FOODSTUFFS

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Ivan Samarawickrema, Deputy Controller of Prices (Food) for the Administrative District of Polonnaruwa, do by this Order—

- (i) revoke with effect from this date Food Price Order No. PL. 8/62 dated 12th November, 1962, published in Ceylon Government Gazette Extraordinary No. 13,391 of 7th November, 1962;
- (ii) fix with immediate effect the prices which for the time being have been fixed under the Control of Prices Act, No. 29 of 1950, as the Wholesale Dealer's maximum wholesale price per hundredweight gross of the articles specified in Column 1 of the Second Schedule hereto for the Colombo Municipality increased by the amounts specified in Column 2 of that Schedule to be the maximum wholesale price per hundredweight gross above which the articles specified in the corresponding entries in Column 1 of the Second Schedule hereto, shall not be sold within the Administrative District of Polonnaruwa;
- (iii) fix with immediate effect the prices which for the time being have been fixed under the Control of Prices Act, No. 29 of 1950, as the Retail Dealer's maximum retail price per pound nett of the articles specified in Column 1 of the Third Schedule hereto for the Colombo Municipality increased by the amounts specified in Column 2 of that Schedule to be the maximum retail price per pound nett above which the articles specified in the corresponding entries in Column 1 of the Third Schedule hereto shall not be sold within the areas Nos. 1, 2 and 3 as described in the First Schedule hereto respectively;
- (iv) direct that for the purpose of this Order—
 - (a) any sale of any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto for the purpose of re-sale or any sale of any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto, less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
 - (c) the maximum amount that is payable for any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto which is less than or more than one hundredweight gross and sold by wholesale shall as usual be calculated proportionately from the maximum wholesale price per hundredweight gross specified hereto;
- (v) direct that in every area where maximum prices are fixed by this Order no person shall sell any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto which is adulterated with any other article;
- (vi) direct that in every area where maximum prices are fixed by this Order every trader who has any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto in his possession or under his control at any place or in any vehicle shall exhibit conspicuously at that place or on that vehicle a quantity of such article in a suitable container with the maximum prices for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the article and the maximum prices could be clearly seen by any customer;
- (vii) direct that for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight;
- (viii) direct that in every area where maximum prices are fixed by this Order, every person who sells any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto by wholesale shall, and every person who sells any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale;
 - (b) the quantity of such article sold;
 - (c) the price paid for the quantity sold; and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;

- (ix) direct that when any article specified in Column 1 of the Second Schedule hereto and in Column 1 of the Third Schedule hereto is sold, the maximum prices referred to in Column 2 of the Second Schedule hereto and in Column 2 of the Third Schedule hereto shall include the price of the wrapper or the container, if any, in which such article is sold.

BEEF & MUTTON

THE CONTROL OF PRICES ACT

Order

BY virtue of powers vested in me by section 4 read with section 3 (2) of the Control of Prices Act (Chapter 73), I, Rajagaloda Gamage Goshaka Olcott Gunasekara, Deputy Controller of Prices (Food) for the Administrative District of Amparai, do by this Order —

- (i) fix with immediate effect the prices specified in Columns 2 to 5 of the Schedule attached hereto, to be the maximum prices per pound above which beef and mutton of the descriptions and grades specified at heads of those columns shall not be sold within the areas specified in the corresponding entry in Column 1 of the Schedule;
- (ii) direct that for the purpose of this Order—
 - (a) 'Beef' shall mean the flesh of cattle and buffaloes, but shall exclude all forms of offal, head, entrails, hooves and such other parts as are customarily excluded in the preparation of the carcass of any animal at the slaughter house;
 - (b) 'Mutton' shall mean the flesh of sheep or goat but shall exclude all forms of offal, head, entrails, hooves, and such other parts as are customarily excluded in the preparation of the carcass of any animal at the slaughter house;
- (iii) direct that when beef or mutton is sold with bones the weight of the bones sold therewith shall not exceed 25 per cent of the total weight sold;
- (iv) direct that every trader who at any premises within the areas specified in Column 1 of the Schedule hereto, has in his possession beef or mutton of the description or grade specified in the Schedule shall exhibit in a conspicuous position at those premises a notice at which there shall be set out the maximum prices fixed by this Order in respect of beef and mutton of that description or grade;
- (v) direct that beef or mutton shall be sold or exposed for sale only in stalls set aside for this purpose and no meat of any other description and grade shall be sold or exposed for sale in those stalls;
- (vi) direct that every trader who at any premises within the area specified in Column 1 of the Schedule has in his possession beef or mutton of the description and grade specified in that Schedule shall exhibit on a conspicuous position at the stall where such beef or mutton is sold a notice to the effect that only the beef or mutton of the description and grade is sold at the stall;
- (vii) direct that when beef or mutton is sold together with offal in the course of one transaction the beef or mutton shall be weighed separately and sold separately from the offal;
- (viii) direct that every trader when selling beef or mutton shall so place his weighing scale or scales that the purchaser of the beef and mutton shall be able to ascertain easily the true weight of the beef or mutton he purchases;
- (ix) direct that every trader who sells beef or mutton of the description and grade mentioned in the Schedule hereto shall give the purchaser of the beef or mutton on demand, a receipt in which there shall be set out—
 - (a) the date of sale;
 - (b) the quantity of beef or mutton sold (by weight);
 - (c) the description of beef or mutton sold; and
 - (d) the price paid for the quantity of beef or mutton sold;

- (x) direct that in every area where maximum prices are fixed by this Order, no person shall sell the articles specified in the Schedule, adulterated with any other meat or flesh ;
- (xi) direct that when any article specified in the Schedule is sold, the maximum prices referred to in Columns 2 to 5 of the Schedule, shall include the price of wrapper or container if any, in which such article is sold ; and
- (xii) direct that for the purpose of this Order ' pound ' or ' lb. ' shall be deemed to be the standard pound avoirdupois weight.
