THE FINANCE ACT No. 11 OF 1963

Order under section 53 (4) (g)

BY virtue of the powers vested in me by sub-section (4) (g) of section 53 of the Finance Act, No. 11 of 1963, I, Nanayakkarapathirage Martin Perera, Minister of Finance, do by this Order specify for the purposes of sub-sections (1), (2) and (3) of the aforesaid section the class or description of property set out in the Schedule hereto.

SCHEDULE

Any property transferred to a person carrying on an approved project, to be used by such person for the purpose of erecting on such property a factory in connection with such project or a house for the use of or occupation by any other person employed in connection with such project.

In this Schedule—

“approved project” means any such project as is approved, by the Minister of Finance with the concurrence of the Minister in charge of the subject or function of industries; and

“factory” includes a workshop and work site.
