Bay of Bengal—Burma Coast—Gulf of Martaban—Bassein River—Enterprise Flat Buoy permanent y removed.

The Port Officer, Bassein, has given notice, dated May 12, 1899, that the buoy formerly marking the channel across the Enterprise flat below Elephant island has been permanently removed owing to the channel having silted up.

All vessels now entering should pass to the eastward of Enterprise island.

China—Yang tse Kiang—Kiutoan Lightvessel, buoyage—Alterations effected.

With reference to Notice to Mariners No. 88, dated May 2, 1899, issued by this office, the British Admiralty has given further notice (No. 200 of 1899) that with the object of marking the passage south of the Middle ground, which is now the best channel on the south side, the alterations mentioned in the above notice "as intended" have been made in positions of the Kiutoan lightvessel and buoys at the entrance to the Yang tse Kiang, as follows:—

- (a) Kiutoan lightvessel is now moored with House island beacon, bearing N. 32° E., distant 3 $\frac{1}{2}$ miles, and Kiutoan beacon N. 57° W.
Approximate position: lat. 31° 13' 0" N., long. 121° 49' 15" E.
- (b) Middle ground lower buoy, marking the south-east end of the Middle ground, has been altered from a black 'nun' buoy to a buoy painted in red and black verticle stripes, surmounted by a staff and black spherical cage.
- (c) The Block House shoal buoy (red conical) has been discontinued.
- (d) A buoy named Middle ground upper buoy, painted in red and black verticle stripes, surmounted by a staff and black cylindrical cage, has been moored in a depth of 19 ft. to mark

the north-western edge of the Middle ground. From it House island beacon bears S. 81° E., distant $4\frac{1}{10}$ miles, and B beacon S. 7° W.

- (e) A red buoy, surmounted by staff and diamond, named Kiutoan flats buoy, has been moored in a depth of 13 ft. to mark the northern edge of the newly-formed channel northward of the Middle ground. From it House island beacon bears N. 71° E., distant $2\frac{1}{10}$ miles, and block House beacon N. 43° W.

Pacific Ocean—Sandwich Islands—Honolulu Harbour—Wreck Westward of entrance.

The British Admiralty has given notice (No. 204 of 1899) that the dismantled wreck of the American ship Edward O'Brien lies sunk, the starboard rail being under water, in a depth of $3\frac{1}{4}$ fathoms westward of the entrance to Honolulu harbour, with the harbour lighthouse bearing N. 32° E., distant 7 cables, and the Fairway bell buoy S. 52° E.

Approximate position: lat. 21° 17' 25" N., long. 157° 52' 30" W.

Pacific Ocean—Phoenix Islands—Reef reported to the Southward of.

The British Admiralty has given notice (No. 208 of 1899) that the master of the ship Carondelet reports that when about 60 miles southward of the Phoenix islands, his vessel passed about 2 miles distant from a dangerous reef, a quarter of a mile N.E. by N. and S.W. by S. in extent, upon which the sea occasionally broke heavily, in approximately lat. 5° 35' S., long. 173° 58' W.

It has been placed on the chart in this position, marked E.D., as the evidence of its existence is by no means conclusive.

China Sea—Palawan—Port Royalist—Light Beacons, shoal.

The British Admiralty has given notice (No. 209 of 1899) of the following particulars respecting the light beacons and shoals in port Royalist, Palawan:—

- (a) The light (white fixed) on Tide pole point has been discontinued.

Approximate position: lat. 9° 43' 45" N., long. 118° 43' 5" E.

- (b) A coral patch about half a cable in extent, with a depth of 7 ft. on it, exists with Tide pole point bearing S.E., distant $11\frac{1}{2}$ cables, and north extreme of River island W. by S. $\frac{1}{4}$ S. This shoal is marked by a wooden beacon surmounted by a spherical cage.

- (c) A shoal, the extremity of which is marked by a similar beacon, extends for about $1\frac{1}{2}$ cable S.W. by W. $\frac{1}{4}$ W., from the south extreme of point Buckle.

- (d) A similar beacon marks the edge of the shoal water north-westward of Tide pole point. From it Tide pole point bears S.E. by E. $\frac{1}{4}$ E., distant 4 cables, and point Buckle N. $\frac{1}{4}$ W.

Persian Gulf—(1) Nabiyu Farur—(2) Abu Shahr.

- (1) *Reef and sounding off Nabiyu Farur.*

The British Admiralty has given notice (No. 216 of 1899) that the reef on the north-west side of Nabiyu Farur extends from the shore for a distance of about 1 mile, the sea breaking heavily at that distance.

Also, that a depth of 10 fathoms was found with Saddle hill bearing west, distant 6 cables.

Approximate position of Nabiyu: lat. 26° 7' N., long. 54° 27' E.

- (2) *Shoal sounding Southward of Abu Shahr.*

Also, that a sounding of 10 fathoms was obtained southward of Abu Shahr with Kalah Rishahr fort bearing N. 16° E., distant $11\frac{1}{2}$ miles, and Kuh Khormug (north-west extreme) N. 89° E.

Approximate position: lat. 28° 43' 30" N., long. 50° 46' 30" E.

Eastern Archipelago—Makassar Strait—River Mahakan entrance—Gas Buoys established.

The British Admiralty has given notice (No. 223 of 1899) that the following gas buoys had been substituted for other buoys in Mahakan (Kutei) river, Makassar strait:—

- (a) The white nun buoy lying 3 miles N. 42° W. from Tanjong Bayor has been replaced by a white gas buoy exhibiting a white flashing light, visible in clear weather from a distance of 6 miles.

Approximate position: lat. 0° 40' 40" S., long. 117° 36' 25" E.

- (b) The white nun buoy lying about one-third of a mile north-westward of the west point of Pulo Bayor, or Niobe, has been replaced by a white gas buoy exhibiting a white flashing light, visible 6 miles.

- (c) The black nun buoy lying about $1\frac{1}{2}$ miles west of the west point of Pulo Bayor, or Niobe, has been replaced by a black gas buoy exhibiting a red fixed light, visible 2 miles.

The British Admiralty has given notice (No. 224 of 1899) of the existence of a reef, with a depth of 2 fathoms on it, in the approach to Ritabel bay, Tenimber islands, from which the point off Liling Luan village bears S. 11° W., distant about 2 miles, and north extreme of Barnusa island N. 58° W.

Australia—Brisbane River—Bulimba Channel—Leading Lights established, &c.

The British Admiralty has given notice (No. 229 of 1899) that leading lights have been established on Humbug (Norris) point, Brisbane river :—

(a) Humbug point front light is red fixed : from it the lighthouse under Galloway hill bears S. 50° E., distant 2½ cables, and entrance to rivulet opposite N. 73° E.

Approximate position : lat. 27° 28' 5" S., long., 153° 3' 25" E.

(b) The rear light is white fixed, and bears S. 19° E., distant one cable from the front light.

Both lights are shown from white triangular beacons, and in line S. 19° E. lead through Bulimba dredged channel.

The red fixed light north-westward of Galloway hill is obscured when bearing south of S. 30° E.

Various other alterations having taken place and been made in the river, too numerous to insert in this notice, chart No. 1,674 will receive a large correction.

Tasmania—Macquarie Harbour entrance—Cape Sorell—Intended Light.

The British Admiralty has given notice (No. 231 of 1899) that a lighthouse is now in course of erection on cape Sorell, Macquarie harbour, from which it is intended to exhibit a flashing light of the second order.

Cape Sorell light will show red and white flashes separated by eclipses, and will be elevated 175 ft. above high water.

Approximate position: lat. 42° 11' S., long. 145° 10½' E.
