NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 20th day of May, 1899, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at my office at Matara and make claim to the said lands or any of them or to some interest therein :

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The land commonly called or known as Talagahahena, situate in the village of Warakapitiya in the Matara Weligam korale, in the Southern Province, containing in extent 16 acres 2 roods and 26 perches, shown as lots 10,941, 10,942, and 10,943 in preliminary plan No. 4,210, a certified copy whereof is hereunto annexed, and bounded as follows : on the north by a portion of Talagahahena alias Delgahamullewatta sold by Crown to Batgamage Jayanhami (title plan 169,379 ; 4,210/10,940), the old Dutch irrigation channel ; on the east by Abakoratuwa (1,564/818) belonging to Crown, Kanattewatta belonging to Wanniachchige Balahami and others, Paragahakoratuwapitakelle claimed by Don Cornelis Samaradiwakara ; on the south by Delgahalangkelle claimed by Don Cornelis Samaradiwakara, Hindeniya belonging to Kolagodage Punci Appu, Nagahamullewatta belonging to Batgamage Jayanhami, a portion of Talgahahena sold by Crown to Batgamage Jayanhami (title plan 169,378 ; 4,210/10,939) ; on the west by a portion of Talgahahena sold by Crown to Batgamage Jayanhami (title plan 109,376 ; 4,210/10,937).






