NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 17th day of June, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at my office at Matara and make claim to the said land or to some interest therein :

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

The land commonly called or known as Panwilehena, Urubokkehena, Alahentenna, Burullagahakoratuwa, Boraluwinnehena, Kekundeniyehena, Paragahahena, Irrikudahena, Gidangalahena, and Iddagalahena, all lying adjacent to each other and forming one block of land, situate in the village of Beralapanatara in the Morowak korale of the Matara District, in the Southern Province, containing in extent 454 acres 2 roods and 2 perches, as shown as lots 1, 2, 3, 4, and 36 in sheets O 10/35, 36, 43, 44, and O 10/51, 52, 59, 60 and described in the annexed plan, and bounded as follows : on the north by Aninkandemukalana belonging to Crown ; on the east by Urubokkehena sold by Crown and now in possession of D. M. Rajapaksa, the Urubokkehena, the Gansabhawa road from Deniyaya to Beralapanatara, the Beruwadola, Galgodawatta belonging to Wickremaradage Dingise and others, Wattaliyadda belonging to Francis Silva, Mudaliyar ; on the south by Galgodewatta belonging to Wickremaradage Dingise, the footpath from Galgodewatta to Piniketiyakumbura and Lindagawahena belonging to Crown, Nugehena belonging to Crown, Welikumburehena claimed by Madolagodagamachcharige Hin Naide, Panismullehena claimed by Gamachcharige Don Carolis and others, Dediagalawatta and deniya belonging to Millage Balappu and others, Dediagalakumbura belonging to do. ; on the west by Pinnaketiyawatta belonging to Miellage Appu and others, Kongahadeniyakumbura claimed by Wellappulige Thomis and others, Kongahadeniyawatta belonging to Miellage Luwis Hami and others, Irikondchena claimed by Wellappulige Babehamy and others, Bulatwattahena claimed by do., Nawadehena claimed by do., Puwakpeladeniya belonging to Ranamukage Don Bastian and others, Udahawattahena belonging to Crown, Hiraluappulagewatta belonging to Ranamukage Don Andris, and Dotalugalamukalana belonging to Crown, Dandeniyawattakumbura claimed by Kandewewalage Dissan Hami and others, in extent 1 rood and 8 perches, marked as lot C in the annexed plan, Dandenikandewatta belonging to Ranamukage Wattuhami and others, in extent 5 acres 3 roods and 8 perches, marked as lot A in the annexed plan, Batahenawatta, Batahenawattadeniya and Dikela belonging to Kandewewalage Dissan Hami and others, in extent 11 acres 1 rood and 7 perches, marked as lot B in the annexed plan, Puwakpeladeniya belonging to do., in extent 1 acre 2 roods and 5 perches, marked as lot D in the annexed plan, and Kekundeniya belonging to Francis Silva, Mudaliyar, in extent 3 roods and 26 perches, marked as lot E in the annexed plan—all these, with the above boundaries, are excluded.
