NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 20th day of May, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at my office at Matara and make claim to the said land or to some interest therein :

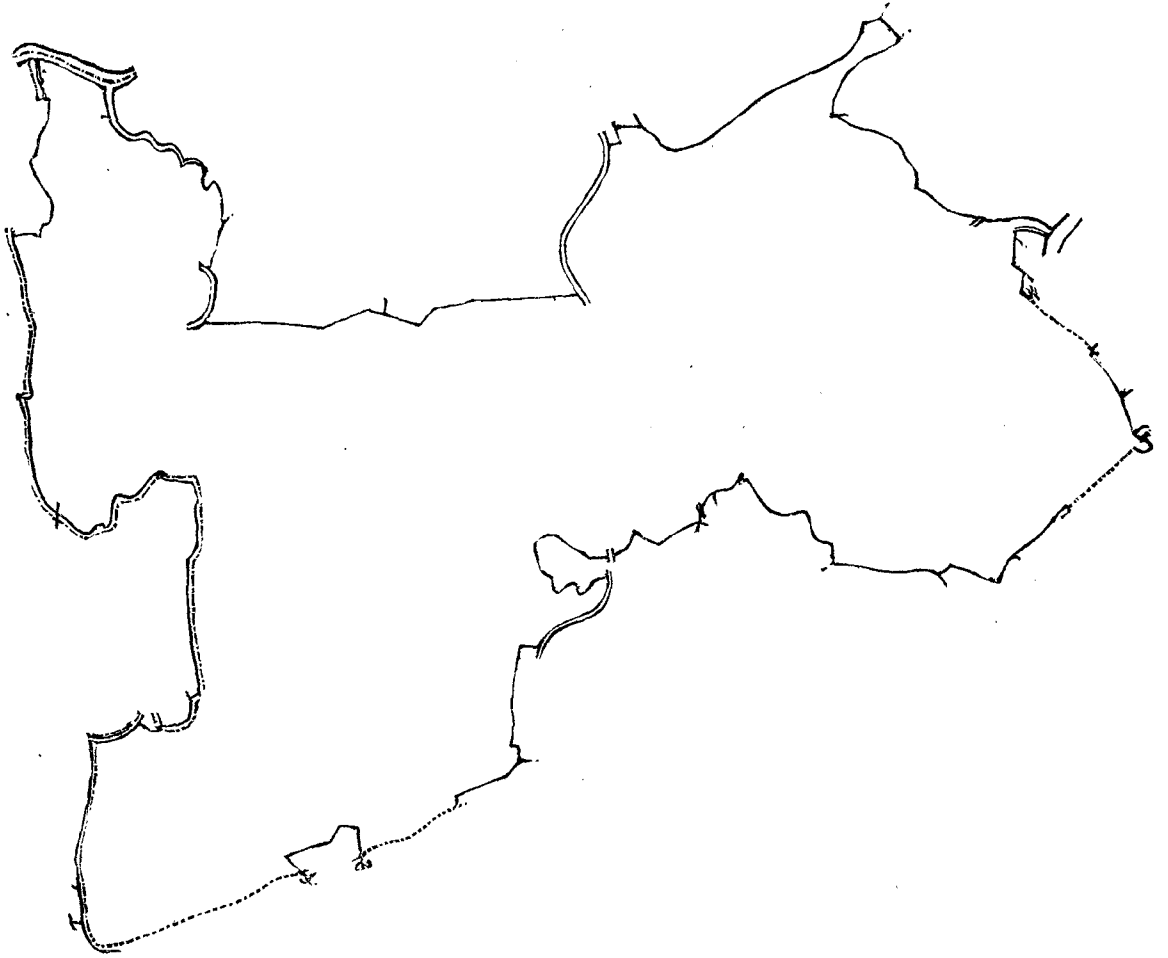
