










I am especially thankful for the blessings and strength received from you. During this time, the support of the Maha Nayake Theras gave me the strength to fulfill my respective duties.

As the President, I wish to start a

new journey. I would like to get all the parties together and go on that journey as well as to form an all-party gov-

There are two ways to do it. The first one is that we should reinstate the 19th Amendment. It should be revised according to everyone's desires. From there we can take the national government forward. Secondly, the Oversight Committee of the parliament can be appointed and given the opportunity to participate from there. Accordingly, the National Assembly concept policy proposed by the Sri Lanka Freedom Party has been acknowledged.

At the same time, how do scholars organize this, get those ideas about reforms, and all that is done. These are important things for us. Therefore, I informed all the party leaders that if there is no All-Party Government, all the parties should come together and make the parliament a

government. I will act according to your advice and adhere to the policies, and I hope that the assistance of the Maha Nayake Theras and the people will receive in this regard. This is the last time we all need to face these problems together. At least a common minimum programme should

be established. Doing that work is our primary task. While doing those tasks, we should not forget the task of protecting our Buddhism. If we follow the advice given by Licchavi Kings today, we can make this country a developed country. Our future depends on that. I particularly express my gratitude for the Maha Sangha. "BA.5 has the same key L452R mutation that the Delta variant had. We all know what happened when Delta was here with us," he added, strongly recommending to get the COVID-19 booster, mask up at least indoors and test if you are symptomatic.

World Health Organization (WHO) COVID-19 Technical Lead Dr.Maria Vankerkhove last week stated that the reported number of cases of COVID-19 have been on the rise for the fifth week in a row and the number of deaths have also been increasing. She noted that the increase in deaths is because of not getting vaccinated or not having the

full number of doses required. "Omicron, the latest variant of concern, is there are even further sub-lineages of BA.5. The Virus continues to evolve driven by a number of factors such as intense mixing of individuals in the absence of mitigation measures, in the absence of wearing masks and distancing," she explained.

"Among the top 50 countries that have reported an increase in deaths, 35 countries had more than 100 percent increase in the deaths reported in the last week. Three countries had more than a 1,000 per cent increase in deaths in the last week," she analyzed.

"Our good news is that our interventions continue to work against all of the variants and sub-variants. We just need to consistently apply them focusing mostly on vaccinating those who are most at risk. Also use other measures to lower your risk of infection by wearing masks, distancing, improving ventilation and working from home if unwell," she

The Minister added that all other systems such as issuing fuel based on the last digit of the number plate or issuing fuel on tokens will no longer be valid from today.

By presenting the QR code of the National Fuel Pass, customers can get the fuel

quota for the respective vehicle from any fuel station across the country. Also, it is not possible to get fuel again until seven days have passed from the date of filling the quota. Vehicles that cannot be entered into the National Fuel Pass by entering the chassis number can be registered for the National Fuel Pass by entering the vehicle revenue license number from yesterday.

Over Rs. 160 million robbery at Colombo 7 company

The Police Colombo Crime Division have arrested two suspects in connection with the recent robbery in Colombo 7, where robbers escaped with a safe belonging to a private company with gems and gold worth over Rs.160 million.

The Police say the arrested include a former driver of the company, the mastermind behind the robbery. The two sus-

pects were arrested near Thotalanga area in Colombo.

The Police also found 16 gems of different types and 10 grams of heroin in the possession of the suspects.

The Police say that the man who worked as a driver of the company run by a Chinese woman and two Sri Lankans and who had left it about 6 months is the main suspect in this largescale theft.

On the morning of July 7, six

Secretary General of the Parliament Dhammika Dasanayake has informed all Members of Parliament in writing to attend the Third Session of the Ninth Parliament which will be inaugurated by President Ranil Wickremes-

inghe at 10.30 am on August 3.

The Gazette Notification concluding the Second Session of the Ninth Parliament

Second Session of the Ninth Parliament was issued on Thursday (28) with effect from midnight.

President Ranil Wickremesinghe prorogued the Parliament in accordance with the powers vested in him with Article 70 (1) of the Constitution with effect from midnight on Thursday (28) announcing that the Third Session of the Ninth Parliament will commence on August 3 at 10.30 am.

According to Subsections (a) and (b) of Article 33 of the Constitution, after the end of one session of Parliament and a new session commences, the President has the opportunity to ceremonially declare open Parliament and preside over it to present the Government's Policy Statement.

When the Parliament is prorogued, the questions and motions which were not considered by the Parliament up until then are abolished and the Members of Parliament thus have to take it up in accordance with the Standing Orders. Furthermore, the Committees other than the Liaison Committee of Parliament, Committee on High Posts and Select Committees should be reconstituted following the beginning of the new session.

The Second Session of the Ninth Parliament was from January 18, 2022 to July 28, 2022 under which the Parliament met for 48 days.

School academic activities limited to three days

The education authorities have decided to limit academic activities in schools to three days during the week from today, (August 1) to Friday, (August 5).


On Wednesdays and Fridays, students can engage in learning activities from home through online technology.

carry out teaching activities.

Rameswaram fishermen withdraw indefinite strike

Tamil Nadu: The indefinite strike announcement made by the fishermen associations in Rameswaram since July 22 to protest against the arrest of six fishermen by the Sri Lankan Navy personnel was withdrawn as fishermen ventured into the sea on Saturday.

On July 20, six fishermen who were engaged in fishing near the Dhanushkodi waters were arrested by Sri Lankan Lankan Navy personnel on charges of poaching near Talaimannar and jailed. The mechanised boat was also impounded by the authorities.

Condemning the arrest, the fishermen association staged a demonstration near the Rameswaram bus stand on July 22 and announced that they would not venture into the sea until the arrested fishermen were freed.

However, a majority of the fishermen, due to poverty, had to go back to work, fishermen leader Jesu Raja said and hoped the Union Government would come to their rescue.

The fisheries department officials said that 532 tokens were issued from the Rameswaram jetty.

The fisher families have appealed to Tamil Nadu Chief Minister M.K.Stalin to help them by rescuing the jailed fishermen from Sri Lanka.

"At a time, when the island nation itself was reeling under severe economic crisis and the country was faced with agitations and unrest by the civilians, the arrest of fishermen from Tamil Nadu by the Lankan Navy personnel had come as a shock. The Government here not only despatched essential goods worth about 175 crore to the people of Sri Lanka, but also provided food, shelter and clothing to people who have fled the country illegally in vessels and reached the Indian shores. "Hence, considering the situation and the poverty, the Government should help the fishermen return home, the family members have written in a letter to the Chief Minister, Jesu Raja said. - The Hindu



Decoding the National Fuel Pass

An explanation of how the QR system for fuel will work

RUWINI JAYAWARDANA

In the face of the fuel crisis in the country, in addition to the long queues at the fuel stations, the problem of fair distribution of the fuel stocks became a concern due to the emergence of people selling fuel at black market prices. This forced the authorities to introduce a QR system. Aiming to provide fuel to the public in an orderly manner amidst its energy crisis, fuel passes that will guarantee a weekly quota to every vehicle owner has been introduced to the public.

The National Fuel Pass was developed with the assistance of leading tech companies in Sri Lanka and the Institute of Communication and Information Technology (ICTA) without any cost to the Ceylon Petroleum Corporation (CPC) or the Government.

Though the public was advised to register with the fuel pass website – fuel pass.gov.lk – with their personal identification and sign up to one vehicle for each identity card/passport or business registration certificate, Power and Energy Minister Kanchana Wijesekera noted that facilities have been made available for businesses with multiple vehicles to register all their vehicles with their business registration number. Vehicle users that cannot register with the chassis number will be able to register with

their revenue licence.

"Fuel requirements for machinery too can be registered under the divisional secretariats stating their weekly requirements. Information such as name, address, phone number, used vehicle, etc should also be submitted when registering for the fuel pass. The weekly quota of fuel will be refreshed every Sunday night," he added.

In case a QR code is misplaced, users can login to fuelpass.gov.lk and enter the mobile number to retrieve the QR code or via SMS by typing Fuel QR Vehicle

Number and sending it to 0766220000. Users can also check their fuel quota balance by visiting the website and logging in with their mobile number or via SMS by typing Fuel Bal Vehicle Number and sending it to the same number mentioned above. Issuance of QR for special segments of vehicles will be announced with a separate procedure.

Priority in fuel distribution will be given to fuel stations which have adopt-



ed the system. The number of users of the QR system and the stocks available will be monitored. Those who were not able to register with the chassis number will be able to register with the revenue licence from August 1.

Public transport will be given priority when distributing fuel. The fuel quota for buses will be allocated at SLTB depots. The fuel quota permitted for each bus will depend on the route permit and number of kilometres. School service vehicles, office transport vehicles, vehicles connected to tourism and other industries as well ambulances and other essential service vehicles verified by authorities will be issued diesel at SLTB depots.

Ambulances too will be given priority at all fuel stations. The requested amount of fuel will be given to fill their tanks. Police vehicles will be given an allocated quota from selected filling stations in each police division.

The Minister also highlighted that separate fuel stations will be allocated for three-wheelers and motorcycles based on their registration. All three-wheel users have been requested to register their vehicles at their respective area Police Station and nominate one fuel station before July 31. Thus, from August 1, three-wheelers will only be allowed to obtain fuel from their registered fuel station.

Users of 49cc bikes have to register with the Department of Motor Traffic to obtain their licences and register for the National Fuel Pass. All users of garden equipment, generators and other equipment requiring fuel to register the type of fuel they require, weekly fuel requirement and choice of fuel station in their

respective divisional secretariats.

Before the QR system, various other methods were introduced as a solution, such as the token card system, connecting the district and local administration

and the Security Forces for fuel distribution, did not yield the desired results. Therefore, from July 16, 2022, the Government introduced the National Fuel Pass Card (QR Code) for fair distribution of fuel allocating days according to the vehicle registration number. This system was in place till July 31, while the QR code system was undergoing a trial period. From today (01), only the QR code system will be functioning. Issuing fuel according to the last digit of vehicles, tokens or any other ways which have been in practice before will be invalid.

There are several issues related to the implementation of the new system. For example the public having to face practical problems such as the lack of smartphones, lack of technical knowledge, inability to access the relevant website, and inability to present the QR code at a gas station.

Hence the Ministry of Sports and Youth Affairs, the National Youth Service Council and the National Youth Corps jointly started a free public awareness programme on the use of the National Fuel Pass on July 19.

According to this system, the QR code will be downloaded to the smartphone and those who do not have a smartphone will be given printed copies of the QR code to keep with them or display in the vehicle using the technology they

The Power and Energy Minister noted that 746 fuel stations have used the QR system on July 30 making it the highest in a day.

"A total of 1,060 fuel stations have adopted the system as at 8.30 pm on the same day," he said.

The public is requested to send video or photo evidence of those hoarding, illegally selling fuel or not following instructions on the distribution of fuel. The evidence can be sent via WhatsApp to 0742123123.

Hence, the authorities can temporarily suspend their QR pass or take legal action against them.

"Do not overcrowd fuel stations today. Your fuel quota has been allocated. So you have the whole week to take it from any fuel station islandwide," the Ministry of Power and Energy requested the public.

the Prime Minister. These changes were triggered by the economic crisis that created shortages of fuel and fertilizer.

Unexpected involvements of the political forces in the protests yielded advantages to them. We faced fascist terrorism for the first time in Sri Lankan history. They had learnt about burning books from Hitler. LTTE used firing and bombing. Some civil organizations rallied with the fascists and created chaos. I was sworn in as President after that.

"The economic pressure has not declined although I came to power. Problems like shortages of fuel, gas, fertilizer, an increase in prices and unemployment are the same. We have no capital investments for development. We have to decide whether to increase or decrease people's problems. That's why you have rallied here. "Economically, Sri Lanka's GDP has collapsed massively to minus 7%. With our actions this year, it will decrease by 3%. After that, we can have a 1% GDP next year.

"We are before fast-growing inflation. I don't say these to frighten people. We must find solutions and enter into a new political path. Old slogans

"Now, some say the reason for the crisis is President Gotabaya banning the import of fertilizer. Our Party says it is due to a delay to go to IMF. SLPP sees that it is due to all previous governments burrowing massively. I think we have all these issues. But will debates bring a single shipload of fertilizer? Can we earn at least 50 million dollars by arguing whether Good

Governance increased the debt burden? None of these debates may develop the country. They are history. "Shall we spend our time debating or seeking solutions? Some march urging me to go home.

Please don't do so because I have no home to go. If you want you can bring a large crowd and build my house in six months. After that only you can ask me to go home. "Please don't waste your time and build your village or my house. We are in an old tradition of politics pointing fingers at each other. Will it decrease inflation or increase GDP? Now, we must find the money for fuel and fertilizer for the Maha season. That is politics we must engage in.

"After I was appointed as the Prime Minister and Finance Minister, we discussed with IMF. We found several solutions through negotiations. We aimed for an agreement in July and approval from the IMF in the first week of August. However, there were no discussions after July 9 and now the process will delay. We expect the approval in September. No one will lend us without this agreement. We need to decide whether to continue these politics or to think afresh.

"The youth started the struggle demanding reforms and I have no debate with it. Others took it into their hands and directed it towards violence. How can we develop our villages? Don't think that an agreement with IMF is the end. Our debt burden has increased. How can we pay them back? We need more and more foreign currency. We need to follow new paths. We must modernize

our agriculture. Shall we do it or continue chanting slogans? The politicians of UNP and SLPP must think of it.

'If we don't accept this challenge we shall lose our country. The next generation will curse at us. The challenge before us is to decide whether to fall back or rise. Shall we take this challenge and make a new country with a strong middle class? Shall we make an export-oriented economy with modern agriculture and industry? When former President J.R. Jayewardene initiated the present economy I was part of it. That economy is outdated and collapsed now. We cannot go back to it or the British period or the Kandyan era. We must think afresh and move forward.

"We must modernize our villages. We still don't have a digital economy. Shall we do it together or divided it? Our first duty is to safeguard law and order. I don't approve of burning the houses of a member of any party. We must not break our friendship due to political differences. & quot; We must think afresh and move forward. We must take that message to the village. Both UNP and SLPP are silent and the village is empty. Why are we keeping mum? The government is in our hands. Let's jointly deliver this message. That's why I invited all parties to form an all-party government. That's the best way to solve the problems of the country. All accept it without argument. There is no debate in the village like among some in Colombo. We must go to the village school and temple to deliver this message. Why don't we join hands to do it? "I know the suffering you encountered since May 9. Some lost houses. Some had to leave the villages. There were death threats. Now, they are over. Let's try to join and work for the country. We have UNP and SLPP in this hall and I love to see the other half of the hall filled with the representatives of JVP, SJB and other parties. We can't limit it to us and we must bring them here. We can decide later if we want to contest elections separately.

"Let's see to the problems of the suffering people in villages who have no food or employment. Local government members have the responsibility for that. We shall inform the programme for that within the next two weeks. I ask you all to go to the Pradeshiya Sabha and speak.

Deliver this message. Let's make a campaign for an all-party government. Silence is enough now. Start to speak. Let's tell the problems of the country to our people.

Tell them that we are working to solve the problems and to end the queues for fuel and fertilizer etc. Ask them to tell us the problems in the villages. I especially make this request from the representatives of the Kandy district. Don't limit to two parties. Open it to all parties and increase the force to make a stronger voice for the ordinary people of the country. I urge you to deliver this message and work as a team to solve the problems of the children and the youth of the country and to make a better future for them."























Message from the Chilf of Defence Staff



Yet, understanding how foreign interferences and influences can penetrate and affect our lives today and how to diffuse it has never been more important. Since World War II, packing one's military to invade another country has lost its appeal. Such efforts are gory, expensive and even if victorious, a pain to

It is far more effective to have the citizens of the country to be subjugated to rock their own boat. This way, which is far less expensive than waging a war, one gets to be sanctimonious whilst achieving their self-serving agenda without global condemnation. Disunity and conflicts within a nation is the best guarantee for the spoils of conquering. Any evidence of foul play can always be put down to conspiracy theories, xenophobia or tribal mindset. Politically also this is the safer option as there would not be any coffins returning home.

Influencing sections of the society, generally those with a chip on their shoulder or the impressionable youth, to hate their Government and instigating them to be destructive elements is the foundation of any such conflict. In such externally manufactured agitations, the second phase would be to step in, often uninvited, in the guise of humanitarian concerns or as democratic advocates. The actual motive would be to take control of the situation into one's own hands to engineer the desired outcome, which could be anything from installing a puppet regime to seceding regions from the

The recent anti-Government protests is a case in point. The unbridled protests made governance impossible and had a debilitating effect on the rasping economy. The Presidential Secretariat, the highest State office, could not function for 100 days. The democratically elected President and Prime Minister were forced to resign. Both State and private properties were looted and vandalized.

Yet, any attempt to bring the escalating violence under control was denounced as undemocratic by a section of the diplomatic corps, Western-oriented civil societies and other notable personalities.



Sri Lanka's Longest **Standing Conundrum**

The worst experience Sri Lanka suffered due to foreign interference is when India throughout the better part of the 1970s and 1980s encouraged with training, funding and arming Sri Lankan Tamil youth to take arms against their own State. JR Jayewardene Administration's tangible measures to counter India's efforts failed because,

1. Zero effort was made to engage with

2. The ally partnered with already had a vested interest in India or rather the Indian markets.

Consequently. terrorism for over 30 years. This gave India the space to push for a political solution that made little sense to most Sri Lankans. As per the 13th Constitutional Amendment (13A), the island is now divided into nine provinces, each with its own respective council.

However, the Northern and Eastern Provinces are to be merged, which would artificially create a Tamil majority. This political solution was India's answer to the separatists' demands, who refuse to live within a unitary system. Yet by merging the North and East, to be managed by one council, a unitary system is automatically created. The rest of the islanders who are happy with a unitary system under a Central Government are forced to accept a system with separate admin-

If this 13A is not handled intelligently, it will be a stepping stone to a disintegrated Sri Lanka. Currently, the nine provinces are held together by the power vested by the Executive Presi-

Therefore, the concerted effort to abolish the Executive Presidency via the proposed 21st (21A) and 22nd (22A) Constitutional Amendments must be taken in conjunction with the impact it would have on the Provincial Councils. Without the executive presidency, these provinces will become free float-Eastern

> Mischievously, those who advocate the abolishing of the executive presidency never address this outcome that will undermine the nation's sovereignty. Instead, the Executive Presidency is discredited as excessive power vested in one person allows corruption and arbitrary action.

Both the 21A and 22A are pushed by Sri Lankan politicians. A discernible foreign hand is not visible, except India's insistence on the full implementation of the 13A. If this is a joint operation or a pure coincidence is a moot point for the result would be the same if the Executive Presidency is abolished whilst the 13A remains intact, unchanged.

Since the adaptation of the 13A, 34 years have passed. Other than the additional administrative layer with its corresponding expenses, Provincial Councils are yet to make an impact on Sri Lankans' lives. Without certain tweaks such as merging the North and East, this system does not even satisfy those seeking autonomy.

At the same time, we are yet to understand the importance the 13A holds for India. We still do not know what it is that India is trying to solve or gain via 13A.

Our lawmakers are more interested in consolidating power, even if in the midst of one of the worst economic crises. As those who are pushing to abolish executive presidency are either constitutional experts or well versed with the constitution, they cannot be ignorant of these dangers. Their silence over the possibility of losing the unitary status with the abolishing of the presidency indicates a slyness on their part.

This deceit on the part of our own politicians must be addressed if we are to successfully counter adverse foreign interferences and influences. Otherwise, all our other efforts, such as eradicating terrorism would only be short term solutions for immediate problems. In the long term, this matter would never be allowed to be put to rest.

The Mahinda Rajapaksa Administration avoided both cardinal errors of the JR Government. The whole nation was encapsulated into the notion of regaining peace. The military was marketed as an important part of the society, who treats every citizen with equal respect and care.

The international community, especially India, was not only briefed on the developments on the war front, but also involved in crucial matters such as sending food and essentials to those trapped in the conflict zones and providing medical assistance to those injured. The humanitarian concerns raised by the international community were immediately addressed. As per India's concerns, using heavy weaponry was refrained even though it meant heavier casualties for the military.

However, Mahinda Rajapaksa's Administration could not retain its victory as it failed to,

1. Understand the US foreign policy vis-a-vis Sri Lanka;

2. Keep intact the national unity that converged to eradicate the war;

3. Establish the purpose of the war, sacrifices made and the significance of the peace regained,

4. Maintain the confidence in Mahinda Rajapaksa Administration's integrity;

5. Counter the rise of the Tamil Diaspora and the LTTE international network.

Consequently, the military victory of 2009 was overturned by our sheer inability to manage our international image and relations. Since then, both our political and military leadership have been humiliated and national security compromised. The present economic meltdown is also a result of our failure to safeguard our victory. More to the point, we are back right where we started with our territorial integrity under threat.

WHO Europe expects more Monkeypox-related deaths

Spanish PM Pedro Sanchez

DENMARK: The World Health Organisation's European office said Saturday that more monkeypoxrelated deaths can be expected, following reports of the first fatalities outside Africa, while stressing that severe complications were still rare.

"With the continued spread of Monkeypox in Europe, we will expect to see more deaths," Catherine Smallwood, Senior Emergency Officer at WHO Europe, said in a statement.

Smallwood emphasised that the goal needs to be "interrupting transmission quickly in Europe and stopping this outbreak."

However, Smallwood stressed that in most cases the disease heals itself without the need for treat-


"The notification of deaths due to Monkeypox does not change our assessment of the outbreak in Europe. We know that although self-limiting in most cases, Monkeypox can cause severe complications," Smallwood noted.

The Spanish Health Ministry recorded a second Monkeypox-related death on Saturday, a day after Spain and Brazil reported their first fatalities.

The announcements marked what are thought to be the first deaths linked to the current outbreak outside Africa.

According to the WHO, more than 18,000 cases have been detected throughout the world outside of Africa since the beginning of May, with the majority of them in Europe. The WHO last week declared the Monkeypox outbreak a global health emergency.

Early signs of the disease include a high fever, swollen lymph glands and a chickenpox-like rash. The disease usually heals by itself after two to three weeks, sometimes taking a month. - ARAB NEWS

HITLER'S WATCH SOLD FOR US\$ 1.1MN AT U.S. AUCTION

Adolf Hitler sold for a whopping US\$1.1 million at an auction in the US despite apprehension by members of the Jewish community, a media report said.

The timepiece made by German watch firm Huber, which has a swastika and the initials AH engraved on it, was sold to an anonymous bidder at the Alexander Historical Auctions in Maryland, according to the BBC.

The auction house which deals with historic autographs, documents, and photographs, militaria from all conflicts, and important relics, says the watch was given

US: A watch said to have to Hitler most likely on April Mignot, who returned to belonged to Nazi dictator 20, 1933, on his 44th birthday when he became the Chancellor of Germany.

"The watch and its history have been researched by some of the world's most experienced and respected watchmakers and military historians, all of whom have concluded that it is authentic and indeed belonged to Adolf Hitler," the auctioneer said in its product catalogue.

It also said that watch was taken as a war souvenir when a group of some 30 French soldiers stormed the Berghof, Hitler's mountain retreat on May 4, 1945.

Among the members of the group was Sergeant Robert German for Jew. - IANS

France with the watch, resold the timepiece it over to his cousin, according to the auction house.

The watch has remained in the exclusive possession of the Mignot family and has never been offered for sale before, it added.

But an open letter signed by 34 Jewish leaders described the sale as "abhorrent" and called on the Nazi items to be pulled from the auction, which also included a dress that belonged to Hitler's wife Eva Braun, autographed pictures of Nazi officials and a yellow cloth Star of David imprinted with the word "Jude", which is

Army corporal Dilanka wins first medal for Lanka



A 26-year-old Corporal from Sri Lanka Army Service Corps hailing from Kurunegala Dilanka Isuru Kumara Yodage won Sri Lanka's first medal at the XXII Commonwealth Games in Birmingham when he was placed third in the men's 55kg weightlifting event on

"I always had hopes of winning a medal and was confident because of the training I underwent," said an elated Dilanka Kumara after adorning himself with a bronze medal to launch Sri Lanka campaign in weightlifting.

In a highly competitive weight category where gold medallist Malaysia's Mohamad Aniq set a Games record of 249kg followed to pip India's Mahadev Sargar (248), Kumara lifted a total of 225kg (105 snatch and 135 clean and jerk) to clinch third place. He failed in his attempt to snatch 112kg and lift 137kg and 141kg in the clean and jerk.

This was Kumara's first international medal failing to win a podium place at the Commonwealth Weightlifting Championship in December but qualifying for the Games in a Singapore tournament in February.

"We had more expectations but we achieved our goal of winning a medal. Considering the situation in the country where we could not get fuel to go for



training, we have to content with this performance. Perhaps his performance was affected by the chilly weather. We are confident we can win more medals coach Rukshan Chinthaka, a Sports Officer from Wayamba Province.

Merchandise trade balance records surplus in June

First time since August 2002

The merchandise trade balance recorded a surplus in June 2022 for the first time since August 2002, reflecting the impact of historically high monthly export earnings and the continued decline in import expendi-

The balance in the merchandise trade account in June 2022 recorded a surplus of US dollars 21 million, compared to the deficit of US dollars 652 million recorded in June 2021, and a trade surplus of US dollars 110 million was recorded. Earnings from merchandise exports in June 2022 increased by 23.9% over the corresponding month in

2021, recording US dollars 1,248 million, which is the highest ever monthly export earnings recorded. Total earnings from the

exports of agricultural goods in June 2022 increased by 9.2%, compared to June 2021, with a substantial share of the increase being contributed by seafood (primarily, fresh and frozen fish) and minor agricultural products (primarily, areca nuts). Meanwhile, the cumulative deficit in the trading account during January-June 2022 narrowed to US dollars 3,514 million from US dollars 4,316 million recorded

Expenditure on the importation of consumer goods in June 2022 declined substantially by 53.8%, compared to June 2021, contributed mainly by a reduction of 46.1 per cent in food and beverages and 59.7% in nonfood consumer goods.

The year-on-year decline in import expenditure on food and beverages can be largely attributed to dairy products (mainly, milk powder), oils and fats (mainly, coconut oil), vegetables (mainly, big onions, masoor dhal and garlic), and sugar.

The decline in expenditure on nonfood consumer goods was broad-based but the

Cinnamon Life opening to act as catalyst for MICE tourism

Casino operations to be facilitated under new legal framework

The Cinnamon Life project's hotel and mall are expected to act as a catalyst for the growth of MICE tourism in the broader Colombo region. The project has already earmarked space to be operationalized by another entity as a gaming centre. Internal estimates by John Keells Holdings (JKH) suggest that though currently there is an over-capacity of room inventory in the Colombo region, given the advent of a single big conference there would be a shortfall in room inventory.

The cabinet of ministers in July had just approved a new framework for the operation of casinos and that framework is expected to be gazetted in the coming months. JKH also notes that there are already 4 operational casinos in Colombo. Given JKH's investor profile they are hoping for a better more transparent legal framework to act as a venue for a gaming operation.

JKH Chairman Krishan Balendra when asked about Cinnamon Life's casino reiterated the company's long-term position. He said, "We will not operate it ourselves. It is not a business that we are in. In the Cinnamon Life complex in the area connected to the hotel, there is a space of about 165,000 square feet over three floors. One floor is over 100,000 square feet which we intend to rent out as a casino operation. We have been asking that the government introduce regulations and formally license casinos so that we can rent out the space to an operator."

Group Finance Director and Deputy Chairman Gihan Cooray and Balendra were speaking on 29 July at the JKH investor webinar following the release of their quarterly results.

Given the way the legal agreements have been structured, the accounting policies of the group, and the holding structure of the entity there has been a loss recorded by subsidiary companies for their stake in the Cinnamon Life project. On being queried about the losses and the remaining 161 apartment units to be sold Cooray noted that the losses were expected. He said given the dilution of holding by subsidiary entities which did not infuse further capital into the project and the losses associated at the beginning of a project the group had already forecast the losses.

The group also boasted considerable gains in its bunkering and leisure businesses. The bunkering business showed a 54% Year-on-Year (YoY) growth in volumes. The profits were further accentuated by higher margins on the business and new demand created by local entities importing fuel to operationalize their generators.

Success of regulatory measures depends on support from trading community - CBSL

The Government and the Central Bank of Sri Lanka (CBSL) have been implementing several measures to ease the burden of the current economic hardships on the people and to ensure adequate foreign exchange liquidity in the banking system, the CBSL had to impose surrender requirements on export earnings as one major factor that is contributing to the current crisis and the resultant hardships are the lack of foreign exchange liquidity in the banking system.

Further, measures were taken by the Government and the CBSL to discourage foreign exchange outflows, such as imposing restrictions on certain imports and payment terms and introducing margin requirements, while encouraging foreign inflows through the banking system, rather than those being channelled through the grey market.

The success of these regulatory measures and the ability to achieve the intended outcomes depend on the support and cooperation from the trading community and the banking system. However, it has been brought to the

notice of the CBSL that certain market players are not being fully compliant with these regulations. Such practice, if continued, would deprive the people of the support expected from the Government in difficult times, while undermining the moral obligation of 'equal burden sharing' that is expected of all stakeholders under difficult and extraordinary circumstances.

Against this backdrop, and in the best interest of the nation, the CBSL reiterate to all stakeholders of the economy, that, going forward, all efforts would be taken to strictly monitor and ensure compliance with all regulations on foreign exchange transactions, including repatriation requirements of export proceeds, conversions, and mandatory sales to the CBSL etc. Any instances of non-compliance will be dealt with by an action within the provisions of all applicable laws.

It is noteworthy that the CBSL has strengthened its capacity for monitoring foreign exchange transactions through the implementation of the Export Proceeds Monitoring System (EPMS) and the International Transactions Reporting System (ITRS), which is a comprehensive monitoring system of cross-border transactions and domestic foreign currency transactions.

These systems facilitate regular monitoring of foreign exchange inflows and outflows.

Further, assistance from independent professional bodies, including audit firms, is also being sought for the timely identification of any malpractic-

Hence, Licensed Banks and the trading community are urged to comply with the existing regulations and complement the efforts of the Government and the CBSL to provide much-needed assistance to all stakeholders of the economy under these extremely chal-

lenging circumstances. The export trading community is urged to continue to repatriate all export proceeds within the stipulated timeframe and surrender the residual earnings following the regulations.

The banking community is requested to ensure strict adherence to all regulations concerning foreign exchange transactions. TO PAGE 18

SLTDA registered can now obtain licenses to serve own soft liquor stocks



Nod for close to 80 FDI proposals from China to India

In the past two years, 80 Foreign Direct Investment (FDI) proposals from countries sharing a land border with India were granted permission to invest in India, according to data provided by the Department for Promotion of Industry and Internal Trade (DPIIT) under the Right to Information Act (RTI). Almost all proposals were from China, an analysis of the data shows.

Aimed at stopping the opportunistic takeover of loss-making Indian companies by Chinese firms, by possibly taking advantage of the economic situation when the COVID-19 pandemic struck in March 2020, the government tweaked the FDI policy on April 18, 2020. It made prior government approval mandatory for foreign direct investments (FDI) from countries which share a land border with India.

Earlier, some of these proposals in noncritical sectors could be cleared under the automatic route. The decision coincided with the build-up of Chinese forces in Eastern Ladakh in Âpril-May 2020 which took a violent turn on June 15, 2020, when 20 soldiers were killed in clashes with the Chinese.

In reply to an RTI query by The Hindu, DPIIT said, "388 FDI proposals have been received by the Government since April 18, 2020, from countries sharing a land border with India.'

The reply added, "80 proposals out of 388 were granted permission to invest. Information on the sector-wise breakup of accepted proposals is not maintained in this depart-



In March, however, the Commerce Ministry informed the Parliament that the total value of investments from countries sharing a land border with India from April 18, 2020, to March 1, 2022, stood at INR 13,624 crore.

Over INR 5,000 crore was invested in the drugs and pharmaceuticals sector and INR 2,907 crore was invested in the services sec-

In October 2020, an FDI Proposal Review Committee headed by the Union Home Secretary and Secretary DIPP as a member was constituted for closer scrutiny of security clearances for Chinese FDI proposals.

FDI up to 100% is allowed in non-critical sectors through the automatic route, not requiring security clearance from the Ministry of Home Affairs (MHA). (www.thehindu.

Launches 'Forex Plus'

The Commercial Bank of Ceylon has announced the launch of a special Foreign Currency Fixed Deposit (FD) scheme in further response to the requirement to attract investments from foreign sources.

The new scheme branded 'Forex Plus'offers interest rates of up to 9.5% per annum for tenures of up to five years on term deposits in four international currency denominations. 'Forex Plus' was introduced to encour-

age foreign currency investments that are pivotal for the Sri Lankan economy while also allowing customers to save their hard-earned foreign exchange in a competitive and reliable instrument, the Bank said.

These Fixed Deposit Accounts can be opened by non-nationals, Sri Lankan dual citizens, and Sri Lankans holding Permanent Residency status or citizenship in another country, who are resident in or outside Sri Lanka, as well as by Sri Lankans employed overseas and by companies incorporated overseas.

Eligible customers can start their 'Forex Plus' account with a minimum deposit of US\$ 5000 or the equivalent in the other designated currencies -Euros,

Sterling Pounds or Australian Dollars for tenures of three, four or five years. The interest rates earned will depend on the currency and the tenure, and the Fixed Deposits under this scheme will be renewed automatically, the Bank said. While United States dollar deposits for

five years will yield an interest rate of 9.5% per annum, Euro and Sterling Pounds will yield 6% per annum and Australian dollar deposits will yield 7% per annum for the same tenure. The Bank said these rates are applicable at the time of launching the product and are subject to change from time to time at the discretion of the Bank.

Credits for 'Forex Plus'include remittances through the banking system, in foreign exchange, originating from the account holder's overseas account and in favour of the account holder; from an Inward Investment Account (IIA) or Offshore Banking Unit (OBU) account maintained in the name of the account holder; out of proceeds received as inward remittances, and foreign exchange brought into Sri Lanka by the account holder upon declaration to the Customs

Operations at Colombo Port proceeding smoothly - SLPA chief

Plans to go ahead with expansion plans despite local economic conditions

The current local economic conditions, long queues for fuel and other issues have no negative impact on the smooth functioning of the Colombo Port, assured Sri Lanka Ports Authority (SLPA) Chairman PrasanthaJayamanna.

"Our day-to-day operations, expansion activities, investments, digitalization processes and other development plans are moving ahead uninterrupted," he said, adding that if development is halted or delayed the competitiveness of the Colombo Port will come into question.

The SLPA will continue with their ongoing investment plans and go ahead with the construction of the East Container Terminal (ECT) at the Colombo Port. The total investment would be USD 500 million and over 20% of the work has been completed.

With the planned investment the length of the ECT will increase to 1,320 meters and the depth would be increased from 18 metres to 20 and the first phase is scheduled to be completed in July next year. Under the first phase, six ship-to-shore cranes and 20 rail-

mounted gantry (RMG) cranes will be have aggravated this." "However, we installed at the Eastern terminal and this equipment is being imported."We are also developing the Galle Port as a tourism port and Trincomalee as an industrial port.'

The Chairman also said that they have their own finances for these developments through their cash flows and if there is an issue to raise funds they will look at other funding sources. He also said that the SLPA is only servicing a few foreign debts and they have no issue in debt servicing.He, however, said that 'ripples' of the May 9 incident at Galle Face and violence that followed is still having a negative impact on international shipping lines when they plan to 'dock' at Sri Lankan Ports."The Colombo Port is predominantly a transshipment hub with over 85% of its businesses focused in this area. The SLPA won the Best Port Authority and the Best Public Container Terminal of the Year 2021 Award at Global Ports Forum. Since we are also the 23rd best Port in the world and top in South Asia there is tremendous competition and business

rivalry towards our Port which too may

have briefed them and explained that this was an isolated incident and such events have happened in many parts of the world. The shipping lines have now realized this and are again calling at the Sri Lankan Ports," he said.

He also said that they have a very cordial relationship with workers and the Unions and they too are very supportive towards ensuring 'uninterrupted work' in the Colombo

Adequate fuel reserves are maintained at the port fuel bank and there is no disruption to port operations due to the fuel crisis. "Even our employees who use vehicles are provided fuel from these stocks ensuring that there are no disruptions due to the fuel issue."

The smooth liaison was also witnessed during the C-19 global pandemic where the Port of Colombo succeeded in continuing port activities and operations to feed the national economy wth the efficient, dedicated and productive service of all employees. The SLPA was commended for securing and safeguarding the credibility kept by the port's local and international

customers and clients."Given SLPA's role as regulator and facilitator of port development of Sri Lanka, it is important to record that the Port of Colombo will continue to develop ahead of projected demand and towards this, construction has already begun on two new deep water terminals, the East Container Terminal (ECT) by the SLPA and the West Container Terminal (WCT), by a consortium led by Adani Ports and including John Keells Holdings.

These developments will progressively add over seven million TEU of throughput capacity over the next two-five

Oluvil Fisheries Port opened after decade to public

Making a significant contribution towards rebuilding the Eastern province fisheries sector, the Oluvil Fisheries Port, (Ashraff Memorial Oluvil Port') which was defunct for over a decade in a state of stagnation was opened last week by Fishing Minister Douglas Devanenda and TESS Pvt.Ltd Managing Director Shiran Fernando.

One of the main reasons for the closure of the Oluvil Fisheries Port was that sand dunes kept accumulating at the mouth of the harbour making vessels inaccessible and TESS together with the Minister of Fisheries invested several million to correct this using dredgers and reopen the harbour Fernando said.

An official from the harbour said that credit for the reopening should go to Fisheries Minister Douglas Devananda, Fisheries Ministry Secretary Indu Ratnayake and TESS for quickly taking the necessary administrative and construction measures to assist in opening the harbour again.

"In addition to fish processing, small boat construction, repair, initiatives too would be undertaken by the SME sector opening up new livelihoods for the people.

In addition, the harbour also will soon be able to accommodate yachts helping to introduce tourism to the area. "While helping to increase fish supply to Sri Lanka the opening of the Port will also once again restore thousands of employment opportunities in the fisheries sector that was stalled due to the closure of the Port."

He also said the East Fisheries sector offers uninterrupted fishing and the Port can be the game changer to make Sri Lanka selfsufficient in fish.

He said that Oluvil is strategically positioned in an important geographical location in the East-ern province. "There is no harbour within about five hours of sail time and in a storm or any other emergency, Oluvil Port can play a major role. The harbour was constructed

by the Danish Construction Company MT Højgaard and was opened by then President Mahinda Rajapaksa in 2008 as a part of the 'Nagenahira Navodaya' Development Program. It was a Rs. 1.6 billion Danish-funded pro-

In addition, the applicants can apply for Subject No.12- Common General Test and Subject No.13- General English as applicable.

Applying for the examination should be conducted in two main stages.

Stage I - Entering information and receiving the Reference Number.

Results of above subjects will be issued only for the candidates appeared for both written and practical tests. Candidates should appear for the practical test on the same day given in the admission card. Candidates who fail to appear on the given date will not be provided any other date for the practical test. No re-tests will be conducted after completion of the practical tests as scheduled.

- (d) Candidates should select subjects in compliance with the instructions of the Ministry of Education Circular No.2016/13 dated 26.04.2016.
