#### GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE PUBLIC SERVICE ADVERTISED IN THE “CEYLON GOVERNMENT GAZETTE”

1. *Allowance.*—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

2. *Conditions of Service.*—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

3. *Terms of Engagement.*—(i) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay) appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute at their option, a further 5 per cent. The Government contribution in either case will be equal to 7½ per cent. of the salary paid in at the close of each financial year.

(ii) Appointees may be required to furnish security in terms of the Public Officers (Security) Ordinance, if so required by the Head of their Department.

(iii) Appointees other than those already in the Public Service will be required to pass a medical examination by a Government Medical Officer as to their physical fitness to serve in any part of the Island.

4. *New Entrants to the Public Service.*—(i) The period of probation/trial of New Entrants appointed to pensionable posts/non-pensionable posts, as the case may be, shall be 3 years unless a longer period is prescribed in respect of any posts.

(ii) New Entrants will be required to comply with any rules already made or that may hereafter be made for giving effect to the Language Policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

(iii) (a) They will be required to acquire proficiency in Sinhala during their period of probation/trial.

(b) The confirmation, at the expiry of the period of probation/trial, will depend, *inter alia*, on their passing within specified periods of time graded proficiency tests in Sinhala, leading up to the level of the J. S. C. Standard. Failure to pass these proficiency tests within the prescribed periods will result in the non-payment of the increments falling due, until the passing of same. Any officer who does not pass the proficiency tests of the Junior School Certificate standard by the end of his period of probation/trial will be liable to have his services terminated.

*Note.*—Those who qualify for entry into the Public Service through the Sinhala medium will be exempt from passing the proficiency tests in Sinhala as a prerequisite for confirmation.

(iv) They will also be required to pass an Efficiency Bar test in the Sinhala language of the Senior School Certificate standard within two years from the date of confirmation in appointment.

5. *Qualifications required.*—(i) Every applicant must furnish satisfactory proof that he is a Ceylonese. A “Ceylonese” is a citizen of Ceylon by descent or by registration.

(ii) A candidate for any post for which the minimum educational qualification prescribed is a pass in the Senior School Certificate examination or equivalent or higher examination shall have a pass in the Sinhala language or its equivalent obtained at the Senior School Certificate examination or its equivalent if he is a Sinhalese, educated in the Sinhala medium. (This requirement will not apply to those officers who are in the Public Service from a date prior to January 1, 1961, and who seek appointments to other posts in the Public Service.)

6. *War Service Concession.*—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty's Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service commencing from September 3, 1939, at the earliest, and up to December 31, 1949, at the latest from their ages for purposes of

eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

7. **Other requirements.**—(i) Applications from officers of the Public Service who are qualified must be forwarded through the Heads of their respective Departments. In the case of applications from officers holding permanent posts in the Public Service, the Heads of the Departments concerned should, in forwarding the applications, state whether or not they are prepared to release the applicants (if selected) in accordance with Administrative Regulation 109 of the Manual of Procedure.

**C-Plan Scholarship for a Medical Officer  
(Anaesthetist)**

APPLICATIONS are invited from Medical Officers (Anaesthetists) in the Department of Health who possess at least the minimum qualification D.A. for the award of a Scholarship, to train as an Anaesthetist, Pump Operator for the Heart Lung Machine, tenable in the United Kingdom under the Colombo Plan. The approximate tenure of the scholarship is 6-12 months.

2. *The applicants should be—*

- (a) Under 45 years of age at the closing date of applications;
- (b) in Grade II and be confirmed in service;
- (c) A Ceylonese; 'Ceylonese' means a citizen of Ceylon by descent or registration *vide* Treasury Circular No. 622 of 19.10.63.

3. A high standard of both mental and physical fitness is necessary. The successful candidate will be required to pass a medical examination by a Board of Government Medical Officers as to his mental and physical fitness.

4. Candidates will be required to present themselves for an interview in Colombo at an appointed time and place which will be notified later. No travelling or other expenses will be paid in this connection.

5. *The selected candidate will be required—*

- (a) to enter into an agreement with the Government of Ceylon undertaking among other things, to follow the prescribed course and complete satisfactorily his course of studies and to serve the Government for a specified period (to be decided, by the Government) after completion of his course of study and also undertake;
- (b) to repay to the Government of Ceylon the total cost of training (i.e. salary, allowances, cost of passages, &c., paid on account of the Scholarship, from Ceylon Government Funds and by the British Government under the Colombo Plan) in the event of his failure to comply with the terms and conditions in the agreement.

6. *The agreement will include the following clause—*

"The said trainee shall while in the service of the Government devote himself/herself exclusively to the duties of his/her office as a member of the Department of Health and shall not without the written consent of the Director of Health Services render any professional service to any person for fee or reward. Where such consent is given he/she shall be bound to strictly observe such terms and conditions as may be prescribed in writing from time to time by the Director of Health Services".

7. *The award of the Fellowship includes—*

- (a) a monthly maintenance grant as laid down by the Colombo Plan authorities;

- (c) cost of passage to and from the country of study and also cost of any internal travel in the country of study;

**DEPARTMENT OF EDUCATION**

**Guru Vidyalaya Entrance Examination (English Course) 1964**

**COURSE OF TRAINING.**—A new course of training to train English Assistant teachers will be commenced in 1965. The duration of the course of training is two years. Those who successfully complete this course of training will be awarded trained teachers certificates. After 3 years of satisfactory service, those second class trained certificates will be raised to 1st class.

2. **Salary.**—Trainees who satisfactorily complete this course of training and receive appointments as teachers, will be placed on the salary scale Rs. 1,056—2 of 72—1,200. When the Certificates are raised to 1st Class the salary scale will be Rs. 1,272—14 of 72 and 6 of 120—3,000.

5. **Centres of Examination.**—The examination will be held at the following Centres : Colombo, Gampaha, Kalutara, Anuradhapura, Batticaloa, Kegalle, Ratnapura, Kandy, Matale, Nuwara Eliya, Galle, Matara, Tangalle, Badulla, Moneragala, Kurunegala, Chilaw, Amparai, Kalmunai, Trincomalee, Polonnaruwa, Jaffna and Vavuniya.

(ii) Candidates will be required to nominate two centres. Any centre for which a sufficient number of candidates do not enter will be cancelled.

(iii) A change in centre selected by a candidate will not normally be permitted. Exceptional cases of hardship such as transfer of a teacher to a distant school will be considered on their own merits provided that sufficient notice is given.

6. **Eligibility.**—

A.—GENERAL

A candidate should—

- (i) be of good character ;
- (ii) be a citizen of Ceylon ;
- (iii) be above 17 years and below 45 years on January 1, 1965.

**N.B.**—This examination is confined to teachers who are in service now in Government or Director Managed Schools and to pupil teachers. Any candidate who does not have continuous service as a teacher from the date of sending in his application form for this examination to the date of his admission to the Guru Vidyalaya, if selected, will not be eligible for the concessions and other privileges entitled to a teacher.

- (a) The form must be prepared on a half-sheet of foolscap paper measuring approximately 8" x 13" and not on any other paper.
- (b) The form may be prepared on a typewriter. If it is prepared by hand it should be drawn up in red ink. The filling in of the cages must be done in blue or black ink.
- (c) The cages should be ruled and should be in the correct order and on the correct face of the paper. No cage should be altered or omitted. The cages should be intelligently spaced on the paper and any cramping or overcrowding avoided.

(iii) The entry form should be fully and accurately filled in by the candidates. An entry form which is not complete will be judged on its own merits and may be rejected before the examination or the candidature may be cancelled after the examination. The attention of candidates is drawn to the following:—

- (a) A Registered Teacher should give his full name exactly as it has been registered. Others are advised in their own interests to use their names as they appear on their birth certificates;
- (b) The signature of the candidate should be duly attested by a person authorised to do so, viz., Justice of Peace, Commissioner of Oaths, Proctor, Notary Public, Principal of an Approved School, Commissioned Officer of the Army, Navy or Air Force, a permanent Government Officer in receipt of an annual salary of not less than Rs. 2,400;
- (c) All the applicants should forward their application through the Heads of their schools.

(iv) Completed entries should be sent by registered post addressed to the Director of Education, Branch TC, Malay Street, Colombo 2, so as to reach him on or before Friday, July 31, 1964. The envelope containing the entry should bear on the top left-hand corner the following:—"English Gura Vidyalaya Entrance Examination" and the centre asked for.

(v) Entries will not be acknowledged.

(vi) No documents should be attached to the entry form.

10. *Entry Fee.*—The Entry Fee is Rs. 7.50 which should be paid by revenue stamps affixed to the form and duly cancelled by the signature of the candidate and the date. The Department will not hold itself responsible for stamps that are sent uncanceled.

11. *Rejection of Entry.*—(i) Entries which (a) are incomplete or defective or in any other way not in accordance with the regulations, (b) do not carry the appropriate fee, (c) are received in the Department after the date of closing entries will be rejected and the candidates concerned will be informed. If the candidate has already sat for the examination his candidature will be cancelled,

(ii) Where an entry is rejected or the candidature cancelled, the fee is forfeited.

12. *Withdrawal or Absence from the Examination and Refund of Fee.*—(i) Where notice of withdrawal from the examination is received in the Department before the date of closing entries 90 per cent. of the fee paid will be refunded.

(ii) In all other cases including absence from the examination for any reason whatsoever no refund of the fee or any part of it is authorised.

(iii) A refund of 90 per cent. of the fee however, will be made in the case of the death of the candidate or of very Serious and protracted illness (e.g., tuberculosis, paralysis, mental or nervous disorder), provided that the candidate did not sit for any paper. Application for such a refund should be made as early as possible, but not later than one month from the date of examination.

13. *Admission Forms.*—(i) About seven days before the day of the examination an announcement will be made in the newspapers and over the Radio regarding the issue of Admission Forms. Candidates should look out for this and act immediately on the instructions given therein.

The candidature of a candidate who fails to produce one of the documents referred to above will be treated as provisional. Such candidature may be cancelled at the discretion of the Director of Education.

15. *Documents.*—(i) Some or all of the following documents will be necessary:—

- (a) Certificate of registration as a citizen of Ceylon or original official letter of acceptance of claim to citizenship (where applicable);
- (b) S. S. C. (or where it has not yet been issued, the Results Sheets issued to Private Candidates or a statement from the Head of the School himself, in the case of a school candidate). The statement should give full particulars of name, month and year of examination, Index Number, subjects and grades;
- (c) Ceylon G. C. E./O. L. (or where it has not yet been issued, documentary evidence as at (b) above)
- (d) Certificate of Birth or the Special Certificate of Age. The Special Certificate of Birth issued for purposes of admission to schools will not be accepted, nor the Certificate of Baptism. Affidavits will not be accepted in lieu of Birth Certificates;
- (e) Affidavits (where necessary) in support of discrepancy in names. The affidavit should be made by a parent or by a close relative over 21 years of age, if both parents are dead. It should state that action is being taken to have the Birth Certificate amended. No revenue stamp is necessary on the affidavit.

(ii) Documents or copies of them should not be forwarded with the entry form. They should be held in readiness for scrutiny by the Interview Board if and when the candidate is summoned for the Viva Voce test. Candidates who are unable to prove their eligibility by producing at the interview the necessary and acceptable documents will be disqualified.

(iii) The Department will not hold itself responsible for the loss of any documents sent with the entry form by candidates who ignore the instructions.

(iv) The candidate is held entirely responsible for the authenticity of his documents. Candidates who submit documents that have been tampered with or are forged or not true in fact or suppress documents which are relevant will be severely punished. They will be disqualified from the examination and debarred for life from all examinations qualifying for admission to the Teaching Profession.

16. *Results.*—Candidates selected for training on the results of this examination will be informed individually. Mental or physical disabilities will render a candidate ineligible for selection. Pass Lists will not be published by the Department and no details of the performance of a candidate will be available. Correspondence and enquiries should be addressed to the Director of Education, Branch T. C., and not to the Commissioner of Examinations. No reply will be sent to letters addressed to the latter.

17. Any matter not provided for in these regulations will be dealt with at the discretion of the Director of Education.
