# RESIDENTS DEFAULTED RS.10 BN OF NHDA LOANS

Speedy action will be taken to recover the Rs.10 billion in loans granted by the National Housing Development Authority (NHDA) for the housing programmes," Chief Government Whip, Urban Development, and Housing Minister Prasanna Ranatunga said

Minister Ranatunga has instructed the relevant officials of the Authority to immediately implement the targeted programme to recover Rs.300 million loans monthly from the loan recipients. It has been reported that nearly Rs.563 million in loans have to be recovered by the National Housing Development Authority monthly.

The Minister made these remarks at a special workshop held in Kandy yesterday to make aware the District Managers of the Authority regarding the prompt recovery of loans and the future activities of the NHDA.

It has been reported that the total debt to be recovered from loan recipients of this country is Rs.10 billion since the inception of NHDA in 1979.

However, the Authority has been able to collect only Rs.127 million by last July and it is about 23 percent from the total debt.

During 2015-2019, loans were granted using all assets and money owned by the Authority. However, the Authority has been unable to grant full installments for recipients and it has resulted in creating many problems in recovering loans during this period. TO PAGE **02**



While the amendment to the public administration circular would enable the depositing of remittances at least once in three months, it would also enable the relevant officer to open an account in his name to deposit money or open a joint account or even designate an account to receive funds that are deposited.

It has been decided to implement a programme to identify potential foreign employment segments and inform target groups by quickly finding foreign employment opportunities for applied Government employees and forwarding the applications to the relevant parties. It has been planned to encourage public service development officers to pursue foreign education opportunities through foreign scholarships by making a wide coverage under the program to effectively send them abroad.

In this discussion, attention was also paid to opening the data obtained by the Sri Lanka Foreign Employment Bureau for the reference of the Pension Department to regularize the payment of pensions to Government employees who go for foreign employment.

Discussions also focused on issuing instructions and a time frame to the head of the institution regarding the procedures to be followed in forwarding applications for obtaining leave, and to establish an online appeal system for applications that are delayed in approval of leave. The crew of the ship had stated that the deceased was engaged in cleaning the tanks of the ship and that he was found dead between the tanks at around 4 p.m. on August 17. At the time of the incident, the ship was located in the sea near Kirinda.

"On information on the death, a team including the Coroner, a doctor and a Public Health Inspector who went there in a vessel called Johanna, received the body at around 2 a.m. yesterday (19). The autopsy on the body was scheduled to be held at the Galle Teaching Hospital, after which a decision will be taken to send the body to India," the Coroner further said.

They were released on a surety of Rs.500,000. The Magistrate also imposed a travel ban on actor Jehan Appuhamy. The Magistrate made this order pursuant to a request made by the Slave Island

The Slave Island Police further informed the Magistrate that they had received intelligence information that the IUSF members would again enter to President's Secretariat and the Ministry of Finance.

The police also claimed that a suspect named Jehan Appuhami, who was arrested in connection with this incident, has now escaped from the police custody.

Police requested the Magistrate to remand all the suspects as the investigations related to the incident have not been completed.

The President's Counsel Saliya Peiris appearing on behalf of the suspects said that the police are trying to remand these suspects by presenting false facts before the court.

The President's Counsel Rienzie Arsacularathne appearing on behalf of the suspects stated that the police had arrested a group of suspects by misusing

The Attorney-at-law representing Jehan Appuhami informed the court that his client went to the Maradana police station and left because the Maradana police officers said that there was no need

After considering the facts, the Magistrate fixed further inquiries for September 12.

Meanwhile, Police said that three suspects including the Convener of Inter University Students Federation Wasantha Mudalige were detained for questioning for three days in connection with the incidents that took place on July 09.

The prepaid card system was initially implemented in private buses plying from the Makumbura Multimodal Transport Center in Kottawa to Galle on the Southern Expressway under the patronage of Transport, Highways, and Mass Media Minster, Dr. Bandula Gunawardena yesterday.

A prepaid credit card functions like a regular debit card and allows passengers to deposit the money required for the prepayment method and thereby pay the money related to the journey. As a very secure payment method.

this card is currently available through the People's Bank. This payment facility is also available for existing cards.

### NAU highlights importance of cultivating traditional crops in abandoned lands

The importance of cultivating traditional crops such as manioc, sweet potatoes and varieties of yams in abandoned paddy fields and other cultivable lands were highlighted by the National Agrarian Union (NAU) which also stated that these food items could also be used instead of our staple food

Speaking to the *Daily* News, NAU organiser Suriya Seneviratna said a recent research revealed that over 70 per cent people especially in the plantation sector are in the habit of eating either rice or flour based food items rather than using varieties of yams.

He suggested that people should get used to consuming manioc, sweet potatoes and varieties of yams at least for one meal twice a day, so that the country could greatly reduce its imports of wheat flour.

Referring to a statement made by Agriculture Minister Mahinda Amaraweera on cultivating yams in home gardens, the NAU Organiser said currently yams are used even in most plantation sectors instead of wheat flour considering

its nutritious value. Seneviratna said it is reported that there are large extents of uncultivated lands and abandoned paddy fields in the country and the Divisional Secretariats should urge the owners of such lands to cultivate them without keeping idle. **Recalling Minister** 

Amaraweera's statement, he said even agriculturists predict that there will be a food shortage in the country and such a shortage will not happen if people start cultivating these types of food

He said even the NAU commenced a programme to cultivate manioc, sweet

potatoes and other yams in certain areas with the assistance of area agricultural experts, Agrarian service officials and farmer organisations.

The NAU Organiser also urged Divisional Secretariats to encourage the owners of lands which are lying idle in their respective areas to cultivate manioc, sweet potatoes and verities of yams and help the Government's islandwide cultivation

### Mervyn Silva and law's delays

he arrest of former MP Mervyn Silva on Wednesday for an incident that took place 15 years ago lays bare how the law applies differently to individuals depending on which side of the Government he/she is in and in whose good books he/she may be. It also brings into question the whole issue of the implementation of the law itself. Is the law operational only when it suits someone while at other times it is made to lie dormant?

The maverick politician together with a mob broke into the Sri Lanka Rupavahini Corporation (SLRC) in December 2007 and attempted to rough up its Director General for the latter's failure to air a speech made by Silva in Matara derogatory of a fellow MP who had by then quit President Mahinda Rajapaksa's Government. However, Rupavahini employees turned tables on Silva and the mob, resulting in the latter getting beaten up while also being held hostage until the arrival of the Police to their rescue.

In the ordinary course of events, Silva would have been immediately arrested for trespass and criminal intimidation. Besides, breaking into a State institution and running amok smacked of a direct challenge to the Government itself which should have prompted the Police to act fast. The then Defence Secretary Gotabaya Rajapaksa likened the incident to a coup against the Government.

However, Police took no action to apprehend Silva and Co. on that occasion. Nor was any case against Mervyn instituted by Rupavahini itself. When asked by the media why no arrests were made, the prompt reply given by the then IGP was that Silva and Co. were given their just deserts by Rupavahini employees, and, as such, the matter need not be taken further.

What would have been the position if another party acted in this manner inside a Government institution? Wouldn't the Police have gone into action immediately? Fifteen years later, though, another IGP and the CID have had a change of heart and are seeing things differently and did what should have been done in December 2007, by arresting the former MP and producing him before Courts.

Had another invasion of Rupavahini not taken place in July 2022 and the main suspect arrested by the Police, in all probability nothing would have been heard about Mervyn Silva who recently rejoined the Sri Lanka Freedom Party (SLFP).

This is just one incident of the unequal application of the law under all Governments and all political parties to suit their whims and fancies. The Rupavahini incident is just one episode of Silva's antics during the Rajapaksa era. He personally tied a Samurdhi officer to a tree for failing to attend an event graced by the politician. On that occasion too, Police looked the other way. When one is ensconced in power and his/ her antics entertained by the powers of the day- a privilege enjoyed by Mervyn to the fullest under the then regime - the law is made to remain silent. Only when out of power with no political leader to give backing, one becomes susceptible to the long arm of the law - in this instance taking 15 long years to mete

This is why we need an Independent Police Commission which will function outside the remit of the political authority. Then the Police will be free to implement the law and take action against all wrongdoers whoever they are, regardless of the influence they wield. Implementing the law or failure to do so becoming contingent on who is in power not only makes a mockery of the law but is also a travesty of justice against the victims. We have seen how the law is being implemented against politically connected offenders only when a change of Government takes place. If the Government continues to remain in office for a further term, justice gets further delayed. And we talk of law's delays when all the while the delay is brought about for political reasons and Mervyn Silva's case clearly stands out in this regard.

All Governments that come to power after a prolonged stay in the Opposition always want to dig up cases against their political rivals as a means of taking revenge, although in this instance it was not a case of political revenge but a means of balancing the odds.

The Rupavahini incident involving Silva is another instance where the Police were made to look helpless due to the political clout wielded by the MP. In the same way, we see the MPs who misbehaved inside Parliament during the 52-day illegal Government in a far worse manner than Mervyn and Co. inside Rupavahini, going scot-free.

Now that Speaker Mahinda Yapa Abeywardena has cleared the air on the limits of MPs' privileges declaring that MPs are not above the Criminal Procedure Code and the Penal Code for acts committed inside Parliament, why not get the Police to act? After all, the Police too were targets on that occasion. Or are we expected to wait for a similar predicament that befell Mervyn Silva 15 years after he was let off lamely by the law?

ri Lanka Tourism has declared 2022 as the 'Visit Sri Lanka Year' following the integrated five year Global Communication Campaign targeting to attract six million tourists and USD 10 billion output by 2025 in spite of the challenges posed by recent COVID spread and economic crisis facing Sri Lanka affecting the tourism industry. Travel advisories have been issued by Canada and the United Kingdom advising their citizens to restrict visiting Sri Lanka due to the country's frequent power cuts, gas and food shortages escalating food prices. In addition to the fear of the pandemic, the present spread of dengue in the country has placed Sri Lanka in a desolate position.

The UK is Sri Lanka's third biggest source of inbound tourists behind Russia and India. Tourism accounts for about five per cent of Sri Lanka's Gross Domestic Product (GDP), with Britain, India and China being the main markets. Canada has also advised its citizens to keep supplies of food, water and fuel in hand in case of lengthy disruptions and to make sure to have sufficient supply of medicines in hand as they may not be available and monitor nation's earnings from tourism and remittances.

#### **Action plan**

As a measure to overcome the worst aspect of the pandemic and the economic crisis, the World Economic Situation and Prospects 2022 (WESP) Report, produced by the United Nations Department of Economic and Social Affairs (UN DESA), in partnership with several other UN institutions, calls for better targeted and coordinated policy and financial measures at national and international levels. As discussed in the above mentioned report, national fiscal and monetary authorities need to carefully analyse and coordinate their policies to avoid sudden disruptions. This requires the complete mobilisation of the rele-

India also focused on purposeful research to rebuild tourism and also focused on virtual reality trips, sustainable travel certifications and eco-labelling.

It says in Guyana, the Government, private sector and tourism communities worked together on four priorities as in, re-tooling the country's tourism product, re-gaining the confidence of the tourism market, preparing for the new breed of traveller while also focusing on domestic tourism.

On the face of COVID-19, North America Tourism focused on the safety of travellers by reducing customer touch points by using robotics, automation and self-service kiosks and embraced Artificial Intelligence (AI) for tourism operations.

At the third stage, following global sustainable goals with local community participation in the industry is an effective strategy. Thus, offering job opportunities; making them participate in tourism programmes etc. would create a source of income for the local communities. Hence, educating the general public on why tourism is important for the country's economic recovery should be one of the key strategies in the process of the resumption of Sri Lanka Tourism; thus the attitude of the locals will be aligned for support in tourism

#### **Foreign Exchange Reserves**

Sri Lanka will target high-spending tourists to revive the tourism sector which has been shattered by the Coronavirus pandemic Sri Lanka plans to tap Indian tourists to revive the battered tourism sector and shore up its depleted Foreign Exchange Reserves. Authorities will hold roadshows starting next month in five Indian cities to attract travellers seeking "wellness, leisure, and Ramayana-trail," tours, corporate functions and destination weddings, said Tourism Minister Harin Fernando. Ramayana is the mythological life story of the Hindu God Ram.

The worst economic meltdown since Independence, coupled with political turmoil, has hurt the nation's tourism sector, that's been a key driver of foreign currency inflows. Sri Lanka's forex pile has dwindled to a meagre USD 1.89 billion in May this year as it needs nearly US\$ 6 billion in the next few months to tackle shortages and support its currency.

Sri Lanka is banking heavily on multilateral institutions, including the International Monetary Fund, and friendly countries, for aid to tide over the crisis. Neighbouring India, so far, has extended US\$ 3.5 billion of support in the last few months. Chennai, Bangalore, Hyderabad, Mumbai, and New Delhi have been picked for the roadshows, and hope to attract about 1 million tourists in 2022. Sri Lanka welcomed a peak of around 2.5 million tourists in 2018 before the Easter Sunday terror attacks dried up arrivals.

In conclusion, Sri Lanka must improve its tourist arrivals with promotion measures supported by its diplomatic missions abroad with its patriotic diplomats striving for the economic revival of our Motherland.

# **Constitutional Amendment Procedures**

ernment is to re-implement the 19th Amendment to the 1978 Constitution as the 22nd Amendment, with an essential and timely amendment to establish socio-economic and political stability to address the issues of the people. The Constitution is the supreme law of the country. Here the word Constitution is used to refer to a special document having special legal sanctity in which some of the more important constitutional rules, values and goals are set out. A Constitution, it must be remembered, is a totally different kind of enactment from an ordinary statute. It is an organic instrument defining and regulating the power structure and power relationship of the State. It embodies the hopes and aspirations of the people. It projects a system of values and it sets certain objectives and goals. It cannot therefore be interpreted or amended like an ordinary statute. A constitution must not be to ridged or to flexible in regard to amendment.

This Article reviews the Amendment Procedures under the Post-Independent Constitutions - the 1947, the 1972 and the 1978 Constitutions of Sri Lanka.

### Amendments to the Soulbury Constitution

This Constitution was granted by the British following the recommendations of the Commission on Constitutional Reform established in 1945 under the Chairmanship of Lord Soulbury for the purpose of the country to become an independent 'dominion' within the British Commonwealth. It was given effect to, by the Ceylon Order in Council of 1946 read together with the Ceylon Independence Act of 1947 and came into force on February

By Amendment No.36 of 1971 to the Soulbury Constitution of 1946, the Senate was abolished on October 2, 1971, prior to the adoption of the new republican Constitution of Sri Lanka on May 22, 1972. The United Front, an alliance consisting of the Sri Lanka Freedom Party and the leftist parties that came to power at the May 1970 election introduced a Parliamentary Bill to abolish the Senate. The Bill's second reading was passed by the House of Representatives on May 2, 1971. The Senate met for the last time on September 28, 1971. The Ceylon (Constitution and Independence) Amendment Act No.36 of 1971 received Royal Assent on October 2, 1971, becoming an Amendment to the Soulbury Constitution. The Senate was abolished after nearly 24 years of existence. This Constitution (save for Section 29) was to a large extent a codified model of Britain's 'unwritten' Constitution. However, being codified, it could not be altered or amended without a two-thirds majority of the total membership of the House voting in favour (Section 29(4)).

However, judicial interpretation of Section 29 had unexpected consequences. Section 29(1) empowered Parliament to make laws for the 'peace, order and good Government' of the island. Section 29 (2) rendered void any law or any part of a law that sought to restrict the free exercise of any religion or subject persons of any community or religion to disabilities or restrictions not imposed on other communities or religions. Section 29(3) declared that any law made in contravention of sub section (2) would be void to the extent of such contravention. Section 29(4) declared that no Bill for the amendment or repeal of the Constitution shall be presented for Royal Assent (the Sovereign being represented by the Governor General) unless it bore the Speaker's certificate to the effect that it had been passed by Parliament by a two-thirds majority vote.

Certain doubts and ambiguities persisted with regard to the issue of the competence of the Sri Lankan Parliament to amend Section 29(2) of the Soulbury Constitution, which the Privy Council interpreted in Ranasinghe's case as containing an absolute limitation rendering it completely unalterable. In this case of Bribery Commissioner v Ranasinghe, the actual dispute was whether an amendment to the Bribery Act creating a special Bribery Tribunal had been passed with the required two-thirds majority in terms of Section 29(4) in view of the fact that it was in conflict with the provisions of Section 55 of the Constitution dealing with judicial power. However, in the course of reviewing the provisions of Section 29, the Judicial Committee of Privy Council hearing the case stated that Section 29(2) set out 'entrenched religious and racial matters which shall not be the subject of legislation'. These matters in the view of the Judicial Committee represented 'the solemn balance of rights between the citizens of Ceylon, the fundamental conditions

s media reported, the Government is to re-implement the 19th Amendon which *inter se,* they accepted the Constitution and these are therefore unalterable under the Constitution'.

Deriving its authority directly from the sovereign will of the people of Sri Lanka, the Constituent Assembly process was invoked in 1970 to frame a new Constitution by the new Government. The elected members of the House of Representatives who were the 'founding fathers' met as duly authorized representatives of the people at a Constituent Assembly to establish a new Constitution. This procedure was adopted in order to establish the autochthony of the Constitution or to cause a break in legal continuity with the previous legal order rooted in Britain. Two fundamental features underscore the transition from a Dominion to a Republican Constitution, namely, the principle of autochthony and the doctrine of the supremacy of Parliament. Ironically, after Sri Lanka enacted the 1972 Constitution to become a Republic, the UK Parliament enacted the Sri Lanka Republic Act 1972 to make provision for Ceylon to become a Republic within the Commonwealth under the name of Sri

#### 1972 Constitution


The 1972 Constitution proclaimed Sri Lanka to be a 'Free, Sovereign and Independent Republic', and also to be a unitary State. In place of Article 29(2) of the Soulbury Constitution, the 1972 Constitution guaranteed equality to all citizens and dealt with religion in Article 6 of the 1972 Constitution.

Although the 1972 Constitution expressly acknowledged the concept of sovereign power of the people, it did not contain provisions which made that concept justiciable. Apart from this, while the Constitution provided for a separate chapter enshrining fundamental rights and freedoms, there was no specific machinery to challenge any executive or administrative action which might have been volatile of those rights and freedoms. Furthermore, the Constitution expressly precluded judicial review of enacted legislation, but permitted preenactment judicial review of legislation. This stood in contrast to the position under the Soulbury Constitution under which as interpreted by the Courts it was possible to challenge any legislation enacted by Parliament after its enactment.

Under the 1972 Constitution, the power to repeal or amend the Constitution was vested exclusively in the National State Assembly. The special majority required for Constitutional Amendment was two-thirds at least of the whole House (including those absent) voting affirmatively in favour of passing the provisions. (Article 51(5)). No referendum was required but in the event of repeal of the Constitution a new Constitution had to be enacted to replace the one that was being repealed. Suspension of the Constitution was prohibited but the National State Assembly could by a two-thirds majority pass a law that was inconsistent with the Constitution. Compared to the 1972 Constitution, the provisions of the 1978 Constitution relating to Constitutional Amendments are different due to certain provisions being entrenched.

A procedure was also introduced under the 1972 Constitution for challenging Parliamentary Bill before a special Constitutional Court set up under Article 54 (1) of that Constitution whose jurisdiction could be invoked by any citizen. However, this right could be suspended in the case of a Bill certified as 'urgent'. The provisions of these last two paragraphs were reproduced with some variations in the 1978 Constitution. Under the 1978 Constitution the Supreme Court was substituted as the highest Court of the land for the Constitutional Court under the 1972 Constitution. The Constitutional Court set up under the 1972 Constitution in its ruling on the Local Authorities (Imposition of Civic Disabilities) No.2 Bill rejected the argument that there were certain provisions in the Constitution which were fundamental to it which could not be changed or amended or repealed even with a two-thirds major-

One of the significant orders of the Constitutional Court was in relation to the Excise Amendment Bill which it held conflicted with the Constitution – one of the few Bills which the Constitutional Court had held to be contrary to the 1972 Constitution. The Court noted that the Bill on the face of it sought to vest an unfettered discretionary power in the Minister without assigning any reason to direct any authority granting licence to grant a licence, to renew or cancel a licence and to compel such authority to give effect to discretion. Accordingly the Constitutional Court held that the Bill



was inconsistent with Section 18(1) (a) of the 1972 Constitution. Once the Court has held that a Bill conflicts with a provision of the Constitution it could be enacted, if a two-thirds majority of the entire membership of the National State Assembly vote in favour of it.

Following the General Election in 1977 the United Front Government that had introduced the 1972 Constitution was defeated and the United National Party came to power with a 5/6th majority of the seats in Parliament. Initially the new Government sought to amend the 1972 Constitution in a sweeping manner so as to convert what was still essentially a Westminster model of Government into an Executive Presidential system. The change was effected under the terms of the 1972 Constitution. The two factors that influenced the former President Jayewardene's long standing advocacy of a Presidential system for Sri Lanka as stated by him were a search for executive stability and an anxiety to create and maintain consensus of politics.

### Second Amendment to the 1972 Constitution

The Second Amendment Bill was rushed to the Constitutional Court seeking an opinion and by the debate

in the National State Assembly was taken up only two weeks later. The Bill was certified on October 20, 1977, but was brought into operation only on February 4, 1978 for the new President to take office on Independence

J. R. Jayewardene had been appointed as the Prime Minister on 23rd July 1977 and would have been entitled to continue in that office for six years from that date. The Second Amendment provided for the incumbent Prime Minister to become Executive President and to be in office for six years from the date on which he assumed the Presidency, which would be until February 4, 1984

be until February 4, 1984.

The 2nd Amendment, albeit brief in its content, sliced through the Constitution of 1972 and, by virtue of Section 19 and the Amendments to Section 20, the President became the Head of State, the Head of the Executive, the Head of Government and Commander-in-Chief of the Armed Forces and was empowered to declare war and peace.

Significantly, Section 27(1) which required the President to act on the advice of the Prime Minister or a Minister assigned by the Prime Minister for this purpose, was explicitly repealed, elevating the President to the status of sole and untrammeled repository of Executive Power. Sec-

tion 5, the key provision of the Constitution of 1972 which relates to the exercise of sovereignty, was repealed and replaced by the following sections:

"The National State Assembly and the President are the supreme instruments of State power of the Republic, and accordingly, the Sovereignty of the People shall be exercised in the following manner:

(a). the legislative power of the People shall be exercised by the National State Assembly;

(b). the judicial power of the People shall be exercised by the National State Assembly through courts and other institutions created by law except in regard to matters relating to the powers, immunities and privileges of the National State Assembly; and of its Members, wherein the judicial power of the People may be exercised directly by the National State Assembly according to law; and

(c). the executive power of the People, including the defence of Sri Lanka, shall be exercised by the President.'

By virtue of Section 28B of the Second Amendment to the Constitution of 1972 the then Prime Minister J. R. Jayewardene was deemed for all purposes to have been elected President of Sri Lanka.

The Second Amendment to the 1972 Constitution was passed on October 4 within two months of the General Election of 1977 establishing the office of the Executive Presidency. The Second Amendment amended Section 94 of the 1972 Constitution to remove the Prime Minister's power to determine the number of Ministers and assignment of their subjects and functions to vest these powers in the President who could in addition take charge of any subjects not assigned and any ministry to which a minister is not appointed. This vital amendment was debated in the Assembly for a short time with the Opposition boycotting the deliberations. At the time of introducing the 2nd Amendment, Prime Minister Jayewardene clarified other changes to be considered by a

Select Committee which would also seek the views of political parties not represented in the Assembly. Accordingly, a Select Committee was convened in November in 1977 to consider and draft further revisions to the Constitution. The new document was adopted by the National State Assembly in August in 1978 and inaugurated on September 7, 1978. In 1978 the Second Republic Constitution was enacted under Section 51 of the 1972 Constitution. Therefore the present Constitution draws its validity from the 1972 Constitution, which in turn was brought into operation by the Constituent Assembly established through a people's mandate.


The Constitution of 1978 has taken over the wording of the Second Amendment to the Constitution of 1972 with regard to the exercise of sovereignty with the significant inclusion of fundamental rights the franchise as forming part of the sovereignty of the people. As regards Executive Power, Article 4(b) reads as follows:

'The executive power of the People, including the defence of Sri Lanka shall be exercised by the President of the Republic elected by the People'.

The words 'elected by the People' are the only words added to the original formulation in Section 5(c) of the Second Amendment to the Constitution of 1972. These words are significant and add an extra dimension to the executive power including the defence of Sri Lanka which is reposed in and exercised by the President, through the mandate directly received from the People in the exercise of their franchise at the election of the President. This is distinct from the mandate received by Members of Parliament who exercised the legislative power of the People in terms of Article 4(a).

### World Bank funded Landscape Design Methodology launched

The World Bank is assisting Sri Lanka with the implementation of a Landscape-based Design Planning Methodology that focuses on natural resources and human activities. The Ecosystem Conservation and Management Project in collaboration with the Government's Wildlife and Forest Conservation sectors will implement two pilot programmes in the Dry Zone and Wet Zone. In the pilot projects, planning process villages with human activities, home gardens, cities, agricultural lands, including other Government lands are identified for using areas sustainably.

The two pilot project areas in the Dry Zone Aare the Hurulu - Kaudulla - Kantale landscape and the Sinharaja Landscape. The Hurulu - Kaudulla - Kantale landscape is about 528,826.85 hectares of this around 272,557.03 hectares are protected land while the blance 256,269.82 hectares consisting of habitations agriculture lands and private Land

The other landscape area for which landscape management plans are being executed is the Sinharaja Forest Reserve Zone extending in 242695.17 hectares. Out of this 150,473.07 hectares are forest cover which include protected areas while the balance 99222.10 hectares used for many other purposes. The Sinharaja World Heritage Site as well as forest reserves such as Handawal Kanda Mudali Kanda, Yakkanda, Nawkanda,

Walankanda, Sooriyakanda etc. come under this particular landscape.

A spokesman (ESCAMP), the pilot project implementation body told the Daily News that this process involved identifying areas that are suitable for the different need such as areas to be conserved, restored, ecologically sensitive areas etc. Also the work programme includes development of forests, Soil erosion control, flood control and watershed

"The total forest cover at the beginning of 20th century was 80% of the land. At present, the forest cover has declined to a mere 29.2% which counts for about two million hectares. Of this area, nearly 1,335,400 hectares that include 65 Protected forests, as well as one national heritage site comes under the forest department.

The various protected areas under the wildlife conservation include approximately 13,136,440 hectares of thick forests bushland, grasslands and wetland areas. Therefore, it is imperative that those land areas are released for other purposes only after a thorough investigation has been carried out according to the specified criteria," the ESCAMP Spokesman further said. It is learnt that the Dry Zone Landscape Designing Pilot Project includes 14 DS Divisions in the Anuradhapura, Polonnaruwa and Trincomalee Districts. The Sinharaja Landscape Plan comprises 16 DS Divisions in the Ratnapura, Galle, Matara and Kaluthara Districts.

Their last League Tournament match was played on July 23 on their home grounds in Pallekele where they outplayed Kingswood College by a massive margin of 53-6.


