GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE PUBLIC SERVICE ADVERTISED IN THE "CEYLON GOVERNMENT GAZETTE"

- 1. Allowance.—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.
- 2. Conditions of Service.—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.
- 3. Terms of Engagement.—(i) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay) appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute at their option a further 5 per cent. The Government contribution in either case will be equal to 7½ per cent. of the salary paid in at the close of each financial year.
- (ii) Appointees may be required to furnish security in terms of the Public Officers (Security) Ordinance, if so required by the Head of their Department.
- (iii) Appointees other than those already in the Public Service will be required to pass a medical examination by a Government Medical Officer as to their physical fitness to serve in any part of the Island.
- 4. New Entrants to the Public Service.—(i) The period of probation/trial of New Entrants appointed to pensionable posts/non-pensionable posts, as the case may be, shall be 3 years unless a longer period is prescribed in respect of any posts.
- (ii) New Entrants will be required to comply with any rules already made or that may hereafter be made for giving effect to the Language Policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

- (iii) (a) They will be required to acquire proficiency in Sinhala during their period of probation/trial.
- (b) The confirmation, at the expiry of the period of probation/trial, will depend inter alia, on their passing within specified periods of time graded proficiency tests in Sinhala, leading up to the level of the J. S. C. Standard. Failure to pass these proficiency tests within the prescribed periods will result in the non-payment of the increments falling due, until the passing of same. Any officer who does not pass the proficiency tests of the Junior School Certificate standards by the end of his period of probation/trial will be liable to have his services terminated.

Note.—Those who qualify for entry into the Public Service through the Sinhala medium will be exempt from passing the proficiency tests in Sinhala as a prerequisite for confirmation.

- (iv) They will also be required to pass an Efficiency Bar test in the Sinhala language of the Senior School Certificate standard within two years from the date of confirmation in appointment.
- 5. Qualifications required.—(i) Every applicant must furnish satisfactory proof that he is a Ceylonese. A "Ceylonese" is a citizen of Ceylon by descent or by registration.
- (ii) A candidate for any post for which the minimum educational qualification prescribed is a pass in the Senior School Certificate examination or equivalent or higher examination shall have a pass in the Sinhala language or its equivalent obtained at the Senior School Certificate examination or its equivalent if he is a Sinhalese, educated in the Sinhala medium. (This requirement will not apply to those officers who are in Public Service from a date prior to January 1, 1961, and who seek appointments to other posts in the Public Service.)

- b. War Service Concession.—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty's Fighting Forces and full-time members of the Auxiliary Fire. Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service commencing from September 3, 1939, at the earliest, and up to December 31, 1949, at the latest from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous. and continuous.
- 7. Other Requirements.—(i) Applications from officers of the Public Service who are qualified must be forwarded through the Heads of their respective Departments. Such officers should in addition send a duplicate thereof direct to the Secretary, Public Service Commission, to reach him on or before the closing date. Commonwealth Scholarships in the United Kingdom, 1966

APPLICATIONS are invited for the award of scholarships offered under the Commonwealth Scholarship and Fellowship Plan and tenable at institutions of higher learning in the United Kingdom from the beginning of the academic year in October, 1966.

The scholarships aim at providing opportunities for Ceylonese students to pursue advanced courses or undertake research in the United Kingdom. They are available for post-graduate study or research at Universities and at colleges of technology. Applications for first degree courses will not be entertained.

The scholarships are meant for persons of good intellectual promise who may be expected to make a significant contribution to the life of the country on their return after completion of the scholarship.

Note: 1. No application from a Government servant will be entertained unless the Head of his/her Department certifies in terms of Treasury Circular No. 514 of 16.5.60 that the training provided by the scholarship is essential in connection with a project and the particulars of such project are indicated as required in that circular.

Note: 2. Applications from employees of Boards, corporations, Universities and similar Government-aided or sponsored Institutions should be sent through the Heads of respective

institutions, who should be requested to complete the certificate in cage 27 of the application appropriately, when forwarding the application.

Note: 3. Each applicant should send only one application and should apply only for one course of study.

- 2. Tenure.—A scholarship is tenable for a programme of study or research normally extending over a period of two academic years and leading to a University degree or similar qualification. An award may however be made tenable for one academic year only. The letter of award will specify the period, as well as the course, for which the scholarship will be available.
- S holarships are, however, liable to be terminated at any time during the currency of the course at the discretion of the United Kingdom authorities for misconduct, irregularity in attendance, absence without permission of the authorities concerned from College or Hoste!, or unsatisfactory progress in studies, or failure to pass examinations. In such an eventuality, the scholar might be required to return to Ceylon at his/her own expense.
 - 3. Eligibility.—Candidates should-
 - (i) be Citizens of Ceylon;
 - (ii) he not more than 35 years of age on 1.10.1966. (Preference will be given to those between 22 and 28 years of age);
 - (iii) if Government servants, be able to produce evidence that they have a knowledge of Sinhala of 8th standard level; and

- (iv) possess at least a Second Class degree of a recognised University, appropriate to the desired course of study; (applications will not be accepted pending results):
- (v) possess a high proficiency in English.
- NOTE: 1. A candidate who has entered into a Bond or Agreement to serve the Government or in a Board, Corporation, University or other Government-aided or sponsored institution for a specific period shall not be eligible to apply unless, by 1.10.1966, he/she has served the period specified in the Bond or Agreement and discharged fully the obligations entered into in the Bond or Agreement.
- NOTE: 2. Government servants holding temporary appointments and those holding permanent appointments but not confirmed in their appointments, will similarly not be eligible to apply unless they are prepared to resign their posts in the event of their being selected for awards.  - (f) an initial clothing grant of £40 for such scholars coming from tropical countries as are recommended to receive it;
- (g) for male scholars accompanied by their wives, a marriage allowance at the rate of £22.10s. per month, and allowances at the rate of £5, £3.6s.8d. and £2.18s.4d. per month respectively for the first, second and third of his children under the age of 16 who are with him in Britain. (These allowances will not be payable during the first year of the tenure of a scholarship unless the scholar was married at the time of the award (as fixed by the date of the formal letter of notification); marriage allowance will not be payable in respect of a wife who allowance will not be payable in respect of a wife who holds a scholarship herself or is in paid employment.)

(These emoluments are not subject to United Kingdom income tax.)

NOTE: The grant of leave to Government servants selected for these scholarships will be governed by the Treasury and Departmental rules and regulations in force at the time.

5. Interview.—Eligible candidates will be required to present themselves for an interview to be held in Colombo at an appointed time and place. No travelling of other expenses connected with this interview will be paid. They should also be prepared to produce at this interview, the originals of their certificates, birth certificate and any other documentary evidence in support of their candidature. of their candidature.

 - (b) undertaking to repay to the Government of Ceylon the full cost of the scholarship (i.e. all expenses incurred by the Government of Ceylon and the Awarding Agency in connection with the entire scholarship, including in the case of Government servants, salary, allowances fees &c.) in the event of their failure to comply with the terms and conditions of their Agreement.
- 7. Medical Examination.—Selected candidates will be required to pass a medical examination, by a Special Medical Board appointed by the Government, as to their physical and mental fitness to undertake a course of studies in the United Kingdom.
- 8. The study proposed will not, in the case of Government servants, entitled them to enhanced emoluments or enhance their promotion prospects. In the case of others, the Government will not undertake to provide employment on their return after completion of the scholarship.
- 9. Any statement in the application which is found to be incorrect will render the applicant liable to disqualification, if the inaccuracy is discovered before selection, and to withdrawal of the award if discovered after selection.
- 10. A successful candidate who declines to accept an award, will be debarred from any other scholarship award for a period of two years.

ROYAL CEYLON AIR FORCE TECHNICAL CADETSHIPS

APPLÍCATIONS are invited for two Technical Cadetships in the Royal Ceylon Air Force.

2. The selected candidates will be required to undergo training in Britain or elsewhere as required by the Commander of the Air Force. On successful completion of training they will be granted Regular Commissions in the Technical (Engineering) Branch of the Royal Ceylon Air Force in the rank of Pilot Officer. Officers will be expected to serve in the Royal Ceylon Air Force for a minimum period of ten years after commissioning.

Basic Qualifications:

Candidates should possess the following qualifications:-

- (a) Nationality—Candidates must be Ceylonese, i.e.
 - (i) a citizen of Ceylon by descent, or (ii) Registration.
- (b) Age—Candidates must not be less than 18 years and more than 20 years on 1st September, 1965.

- (c) Educational Qualifications—Candidates must possess at least one of the following qualifications—
 - (i) The 1st Examination in Science or Engineering of University of Ceylon, or
 - (ii) Intermediate in Science or Engineering of the University of London or an exemption threfrom, or
 - (iii) Higher School Certificate with passes in Pure Mathematics, Applied Mathematics, Physics and Chemistry, or
 - (iv) Passes in four subjects in the London/Ceylon G. C. E. at (Advanced Level) with credit passes in at least three of the following subjects: Pure Mathematics, Applied Mathematics, Physics and Chemistry, or
 - (v) The Ceylon Senior School Certificate with six credit passes four of which should be from the group Pure Mathematics, Applied Mathematics, Advanced Mathematics, Physics and Chemistry,

- (vi) The Ceylon G. C. E. (Ordinary Level) Examination with six credit passes obtained at not more than two sittings, four of which should be from the group Pure Mathematics, Applied Mathematics, Advanced Mathematics, Physics and Chemistry, or
- (vii) A pass in the Common Preliminary Examination of the Institute of Engineers, or
- (viii) Any other qualifications that the Commander of the Air Force may consider equivalent to any of the above clauses.
- (d) Civil Status—Candidates must be unmarried. (No Cadet will be permitted to marry whilst under training) and for two years after commissioning).

Note.—Officers will not be permitted to marry non-Ceylonese, and marriage to non-Ceylonese may result in stoppage of promotions or withdrawal of commission.

- (e) Medical Standards—Candidates must conform to the Air Force Medical Standards (minimum height 5 ft. 4 ins.)
- (f) Examinations—Candidates may be required to sit for an examination in Mathematics and Physics and pass General Intelligence tests before final selection.
- 3. On being accepted for Cadetship:
- (a) Candidates must enlist in the Royal Ceylon Air Force as Technical Cadets on a normal regular engagement for a period of five years with the Regular and seven years with the Reserve.
- (b) During period of Cadet training they will be subject to Air Force Law.
- (c) During the period of training Cadets will be accommodated in an Air Force Mess and provided with food, uniforms and medical treatment at Government expense.
- (d) (i) The pay of a Cadet while under training will be Rs. 2,700 per annum. He will not be eatitled to any increments of pay during the period of service as a Cadet. A Cadet will also be entitled to the following overseas allowance whilst under training abroad.
 - (a) while attached to a Mess .. Rs. 100 per month
 - (b) while not attached to Mess .. £1.10.0 per day
- (ii) Cost of living and special living allowance shall not be payable concurrently with an overseas allowance.
- (iii) An outfit allowance shall not be payable to a Cadet. He shall be provided at Air Force expense with all items of service clothing and equipment during his period of service as a Cadet.
- (e) (i) Cadets and their parents/guardians are required to enter into an agreement to cover the period of training and subsequent service in the Air Force.
- (ii) In the event of a Cadet voluntarily terminating his candidature for a commission during his period of training abread the parent or guardian will be required to refund to the Ceylon Government all expenses incurred up to that time by the Ceylon Government on the Cadet's account. The Cadet will also be required to return to Ceylon at his own expense.
- (iii) If at any time during his course of training abroad a Cadet is reported on by the authorities to be unsuitable for the grant of a commission for reasons of misconduct or for causes within his own control, his parent or guardian will be required to refund to the Ceylon Government all expenses incurred on his account by the Ceylon Government.
- (f) Parents or guardians will sign declarations as given in cage 21 of the form of application given in paragraph 20 below, in respect of sub-paragraph (e) (ii) and (iii) above and forward them together with the application. Parents or guardians of selected candidates will be required to enter into a Bond substantially in the form of the declaration with the Ceylon Government prior to the appointment of these candidates.
- (g) Upon successful completion of the period of training abroad, Cadets will return to Ceylon at the expense of the Ceylon Government. On their appointment to commissions, Cadets will be discharged from the Regular Air Force engagement they entered into as Cadets.

Conditions of Service when Commissioned:

4. The prospects and conditions or service of an officer in the Royal Ceylon Air Force are in terms of the Royal Ceylon Air Force (Regular and Regular Reserve) Regulations published in the Government Gazette No. 10,240 of April 27, 1951, as amended
