ORDER

Vesting Order No. 760 of January 23, 1962, relating to Ch/Bolawatta (Roman Catholic) Boys' Sinhala School, Waikkal, published in *Ceylon Government*

Gazette (Extraordinary) No. 12,887 of January 27, 1962, is hereby amended in the schedule thereto, by the substitution for paragraph 1 thereof, of the following paragraph:—

"1. The premises in which Ch/Bolawatta (Roman Catholic) Sinhala Boys' School, Waikkal, was conducted and maintained on July 21, 1960, viz., all that land situated in Bolawatta of Pitigal Korale South of the District of Puttalam, North-Western Province; and bounded on the—

North by the land claimed by M. Francis, boundary being the wire fence which extends for a distance of about 132 feet from the Bolawatta-Lunuwila Road;

East by the said Bolawatta-Lunuwila Road;

South by a portion of the Church property the boundary being a line 45 feet South of Southern wall of the Southernmost school building and parallel to the said wall;

West by a portion of the Church property the boundary being a line parallel to the Western wall of the aforesaid Southern school building and starting at the Western end of the aforesaid Northern boundary".
