THE CONTROL OF PRICES ACT

Order

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act (Chapter 173), I, Victor Chandratillake Bandara Unantenne, Deputy Controller of Prices (Food), for the Administrative District of Matale, do by this Order—

- (i) revoke with immediate effect Food Price Order No. ML. 1964/4 dated 28th September, 1964, published in the *Ceylon Government Gazette Extraordinary* No. 14,190 of 2nd October, 1964;
- (ii) fix with immediate effect the prices which for the time being have been fixed under the Control of Prices Act (Chapter 173), as the wholesale dealer's maximum wholesale price for Colombo Municipality increased by the amounts specified in column 3 in Schedule II hereto, to be a wholesale dealer's maximum wholesale price per hundredweight gross and the retail dealer's maximum retail price for the Colombo Municipality fixed under the Control of Prices Act (Chapter 173), increased by the amounts specified in column 4 in Schedule II hereto, to be a retail dealer's maximum retail price per pound nett to a consumer respectively, above which the article specified in the corresponding entry in column 1 in Schedule II shall not be sold within the Administrative District of Matale, appearing under column 2 of Schedule II, full particulars of which appear in Schedule I;
- (iii) direct that for the purpose of this Order—
 - (a) any sale of any quantity of an article specified in column 1 of Schedule II for the purpose of re-sale or any sale of an article specified in column 1 of Schedule II in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by whole sale;
 - (b) any sale of any quantity of an article specified in column 1 of Schedule II less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
- (iv) direct that in every area where maximum prices are fixed by this Order, no person shall sell any article specified in column 1 of Schedule II which is adulterated with any other article;

- (v) direct that in every area where maximum prices are fixed by this Order, every trader, who has any article specified in column 1 of Schedule II in his possession or under his control at any place or in any vehicle shall exhibit conspicuously at that place or on that vehicle a quantity of such article in a suitable container, with the maximum prices for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container, in such a manner that the article and the maximum prices could be clearly seen by any customer;
 - (vi) direct that for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight;
 - (vii) direct that in every area where maximum prices are fixed by this Order, every person who sells any article specified in column 1 of Schedule II by wholesale shall, and every person who sells any article specified in column 1 of Schedule II by retail shall, on demand, give the purchaser thereof, a receipt in which there shall be set out—
 - (a) the date of the sale;
 - (b) the quantity of such article sold by weight;
 - (c) the price paid for the quantity sold; and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
 - (viii) direct that when any article specified in column 1 of Schedule II is sold, the maximum prices referred to in columns 3 and 4 of Schedule II shall include the prices of wrapper or container, if any, in which such article is sold.

THE CONTROL OF PRICES ACT

Order

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act (Chapter 173), I, Amarawansa Bandara Elkaduwe, Deputy Controller of Prices (Food), for the Nuwara Eliya District, do by this Order —

- (1) revoke with effect from this date my Food Price Order No. NE 81 dated September 17, 1962, published in the *Ceylon Government Gazette Extraordinary* No. 13,308 of September 19, 1962 ;
- (2) fix with immediate effect the prices which for the time being have been fixed under the Control of Prices Act (Chapter 173), as the wholesale dealer's maximum wholesale price for Colombo Municipality, increased by the amounts specified in column 2 of the Second Schedule hereto to be the wholesale dealer's maximum wholesale price per hundredweight gross, above which the articles specified in column 1 of that Schedule shall not be sold within the Area Nos. 1, 2, 3, 4, 5 and 6 as described in the First Schedule hereto respectively ;
- (3) fix with immediate effect the prices which for the time being have been fixed under the Control of Prices Act (Chapter 173), as the retail dealer's maximum retail price per pound nett for Colombo Municipality, increased by the amounts specified in column 2 of the Third Schedule hereto to be the retail dealer's maximum retail price per pound nett above which the articles specified in column 1 of that Schedule shall not be sold within the Area Nos. 1, 2, 3, 4, 5 and 6 as described in the First Schedule hereto respectively ;
- (4) direct that for the purpose of this Order —
 - (a) any sale of any quantity of an article specified in column 1 of the Second Schedule for the purpose of re-sale or any quantity of an article specified in column 1 of the Second Schedule in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale ;
 - (b) any sale of any quantity of an article specified in column 1 of the Third Schedule in a quantity less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail ;
- (5) direct that in every area where maximum prices are fixed by this Order no person shall sell any article specified in column 1 of the Second and Third Schedules respectively which is adulterated with any other article ;
- (6) direct that where maximum prices are fixed by this Order every trader who has any article specified in column 1 of the Second and Third Schedules in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a quantity of such article in a suitable container, with the maximum price for such article fixed by this Order, displayed in figures not less than one inch in height on price tags or boards attached to each container in such a manner that the articles and the maximum prices could be clearly seen by any customer ;
- (7) direct that for the purpose of this Order " pound " or " lb. " shall be deemed to be the standard pound avoirdupois weight ;
- (8) direct that in every area where maximum prices are fixed by this Order, every person who sells any article specified in column 1 of the Second Schedule by wholesale shall, on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale ;
 - (b) the quantity of such article sold (by weight) ;
 - (c) the price paid for the quantity sold ; and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail ;
- (9) direct that in every area when any article specified in column 1 of the Second and Third Schedules is sold the maximum prices referred to in column 2 of the Second and Third Schedules shall include the price of wrapper or container, if any, in which such article is sold ;
- (10) this Order shall not apply to the Divisional Revenue Officer's Division of Uda Hewaheta.

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act (Chapter 173), I, Sandrasekaram Sivasubramaniam, Assistant Controller of Prices (Food), Mannar District, do by this Order—

- (i) revoke with immediate effect the Food Price Order No. MN/10/1963 of 22nd August, 1963, published in *Government Gazette Extraordinary* No. 13,744 of 30th August, 1963;
- (ii) fix with immediate effect the price which for the time being has been fixed under the Control of Prices Act, as the wholesale dealer's maximum price for Colombo Municipality, increased by the amounts specified in columns 2, 4 and 6 of the Second Schedule hereto, to be maximum wholesale price per hundredweight (cwt.) gross above which the article specified in the corresponding entry in column 1 of the same Schedule, shall not be sold within areas No. 1, No. 2 and No. 3 (as described in the First Schedule hereto) respectively;
- (iii) fix with immediate effect the price which for the time being has been fixed under the Control of Prices Act, as retail dealer's maximum retail price for the Colombo Municipality, increased by the amounts specified in columns No. 3, No. 5 and No. 7 of the Second Schedule hereto, to be the maximum retail price per pound (lb.) nett above which the article specified in the corresponding entry in column 1 of the same Schedule, shall not be sold within the areas No. 1, No. 2 and No. 3 (as described in the First Schedule hereto) respectively;
- (iv) direct that for the purpose of this Order—
 - (a) any sale of any quantity of an article specified in column 1 of the Second Schedule in a quantity for the purpose of re-sale, or any sale of an article specified in column 1 of the Second Schedule in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale;
