(1) Ward No. 1 of the following new description :—

"No. 1 Mandawala—Mahawela North—comprising that portion of the village of Mandawala Village which lies to the north of Mandawala Mahawela Ela." ; and

(2) Ward No. 2 of the following new description :—

"No. 2 Mandawala Mahawela South—comprising that portion of the Village of Mandawala Village which lies to the South of Mandawala Mahawela Ela."
