ORDER

The Order relating to the constitution of the Mulleriyawa Town Council, published in Gazette No. 14,166 of September 11, 1964, is hereby amended as follows:—

- (1) in the First Schedule thereto, under the heading "LIMITS OF THE TOWN OF MULLERIYAWA", by the substitution, for the words "Belagama and Kelanimulla in the Gramasevaka's Division No. 504" of the words "Belagama (part) and Kelanimulla (part) in Gramasevaka's Division No. 504, Angoda (part) in Gramasevaka's Division No. 504, Angoda (part) in Gramasevaka's Division No. 505"; and
- (2) in the Second Schedule thereto, under the heading "LIMITS OF THE WARDS OF THE TOWN OF MULLERIYAWA"—
 - (a) under the heading "Ward No. 3—Ambatale" in the description of the eastern limit thereof, by the substitution for the words "the centre line of Kudaluwagara Village Council road", of the words "the prolongation south-eastwards of the centre line of Maligagodella Road";
 - (b) under the heading "Ward No. 3—Ambatale" in the description of the southern limit thereof, by the substitution for the words "the centre line of Kudaluwagara Village Council road", of the words "the prolongation of the centre line of Maligagodella Road; thence northwestwards along the centre line of the said road";
 - (c) under the heading "Ward No. 4—Mulleriyawa South" by the substitution for all the words from "East: By a line drawn from" to

- "starting point of the northern limit of the ward", of the following:—
- "East: By a line drawn from the last-mentioned point south-eastwards and south-westwards along the centre line of Mulleriya-Talangama Public Works Department Road to the centre of its junction with Angoda-Mulleriyawa Hospital Road.
- South: By a line drawn from the last-mentioned point westwards along the centre line of Angoda-Mulleriyawa Hospital Road to the Centre of its junction with Kelanimulla-Koswatta Road.
- West: By a line drawn from the last mentioned point northwards along the centre line of Kelanimulla-Koswatta Road to the starting point of the northern limit of the Ward."
- (d) under the heading "Ward No. 5—Angoda" in the description of the eastern limit thereof, by the substitution for the words "thence southwards and south-eastwards along the eastern village limit of Angoda" of the words "thence southwards along the centre line of Kelanimulla-Koswatta Road";
- (e) under the heading "Ward No. 6—Himbutana" in the description of the northern limit thereof, by the substitution for the words "centre line of Himbutana Village Council road to the centre of its junction with Mulleriyawa-Talangama P. W. D. road", of the words "said limit to its eastern extremity.".
- (f) under the heading "Ward No. 6—Himbutana" in the description of the southern and western limit thereof, by the substitution for the words "thence north-westwards and northwards" of the words "thence northwards"; and
- (g) under the heading "Ward No. 7—Udumulla", in the description of the northern limit thereof, for the words "southern limit of Ward No. 4", by the substitution of the words "eastern limit of Ward No. 4.".

ORDER

The Order relating to the constitution of the Kotikawatta Town Council, published in Gazette No. 14,166 of September 11, 1964, is hereby amended as follows:—

(1) in the First Schedule thereto, under the heading "LIMITS OF THE TOWN OF KOTIKAWATTA", by the substitution for all the words from "All that area of land" to "Gramasevaka's Division No. 507", of the following:—

"All that area of land situated in the villages of Belagama (part) and Kelanimulla (part) in Gramasevaka's Division No. 504, Kotikawatta and Angoda (part in Gramasevaka's Division No. 505, Kohilawatta, Kudabuthgomuwa and Mahabuthgomuwa in Gramasevaka's Division No. 506, Brendiyawatta and Wennawatta in Gramasevaka's Division No. 507, Kittanpahuwa in Gramasevaka's Division No. 508, "; and

- (2) in the Second Schedule thereto, under the heading "LIMITS OF THE WARDS OF THE TOWN OF KOTIKAWATTA"—
 - (a) under the heading "Ward No. 1—Kotuwila", in the descriptions of the eastern and southern limits thereof, by the substitution for the expression "Wennawatta-Kotuwila Village Council road" of the expression "Gothami Road";
 - (b) under the heading "Ward No. 2—Wennawatta", in the description of the southern limit thereof by the substitution for the expression "Brendiyawatta V. C. Road," of the expression "Wennawatta Village Council Road"; and
 - (c) under the heading "Ward No. 2—Wennawatta", by the substitution for the description of the western limit thereof, of the following description:—
 - West: By a line drawn from the last-mentioned point northwards along the centre line of Wennawatta Village Council Road to the centre of its junction with the "devata" path leading to Wellampitiya-Kotuwila Public Works Department Road, thence westwards along the centre line of the said "devata" path to the centre of its junction with Wellampitiya-Kotuwila Public Works Department Road, thence northwards along the centre line of that road till it meets the southern extremity of the eastern limit of Ward No. 1, thence northwards, eastwards, and north westwards along the said eastern limit to the starting point of the northern limit of the ward".
